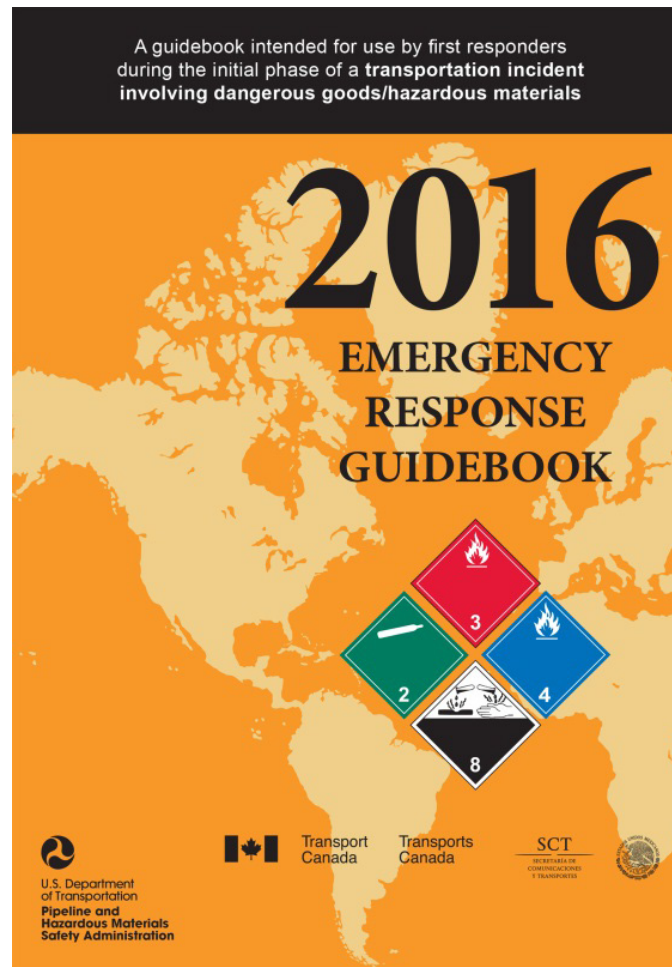

The 2016 Emergency Response Guidebook provides first responders with a go-to manual to help deal with hazmat transportation accidents during the critical first 30 minutes.

US DOT's goal is to place an ERG in every public emergency service vehicle nationwide. To date, nearly 14.5 million free copies have been distributed to the emergency response community through state emergency management coordinators. Members of the public may purchase a copy of the ERG through the GPO Bookstore and other commercial suppliers.

Information concerning ERG requests

The Regional and Local Coordinators have been instructed to distribute ERG's to State/Local governmental agencies and Indian Tribes for their first responder vehicles. **These guides do not go to individuals, private businesses or the Federal Government.** A listing of commercial suppliers that sell ERG's can be found at the following website:

Why can't Federal agencies receive ERG's from the State?

Below is the response from U.S DOT when asked this question:

The federal agencies are responsible for purchasing their own books. The money that has been designated for printing and distribution of the ERG's is for the State or local government employed first responder community and are **NOT** to be distributed to federal agencies. DoD employees please refer to their ERG point of contact (POC).

How do individuals request ERG's?

The requirements for submitting a request can vary by region, but the requesting individual will need to contact their respective Regional Coordinator or Local Coordinators and at a minimum provide their name, agency name, shipping address, and the number of ERG's that are being requested. For any questions concerning requests, please contact your Regional Coordinator and or a Local Coordinator.

Distribution:

Cal OES Regional Coordinators are responsible for distribution of ERGs to the Local ERG Coordinators. These Local ERG Coordinators are then responsible for arranging all logistics for ERGs including additional cost for storage and or further disseminating of ERGs to first responders vehicles. In addition, all coordinators have the opportunity to go directly to the drop off points.
