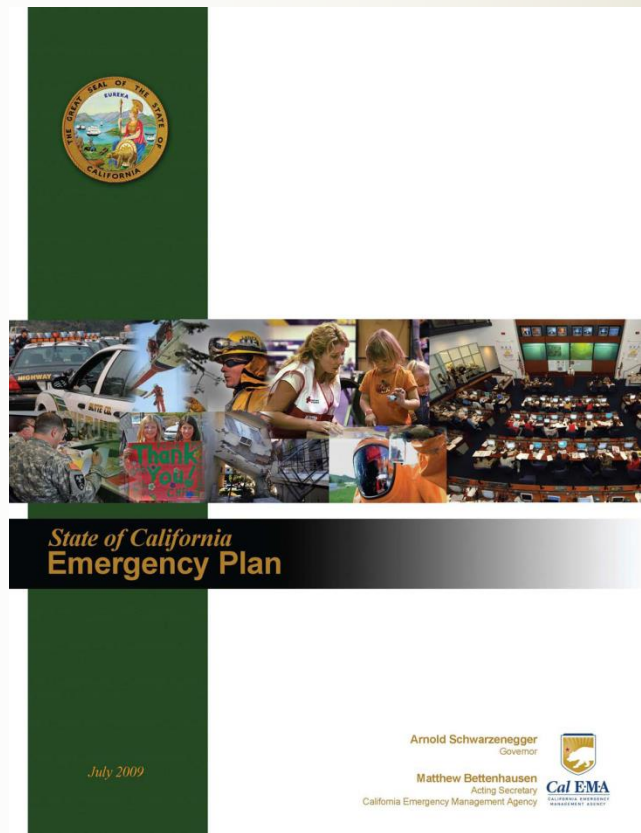

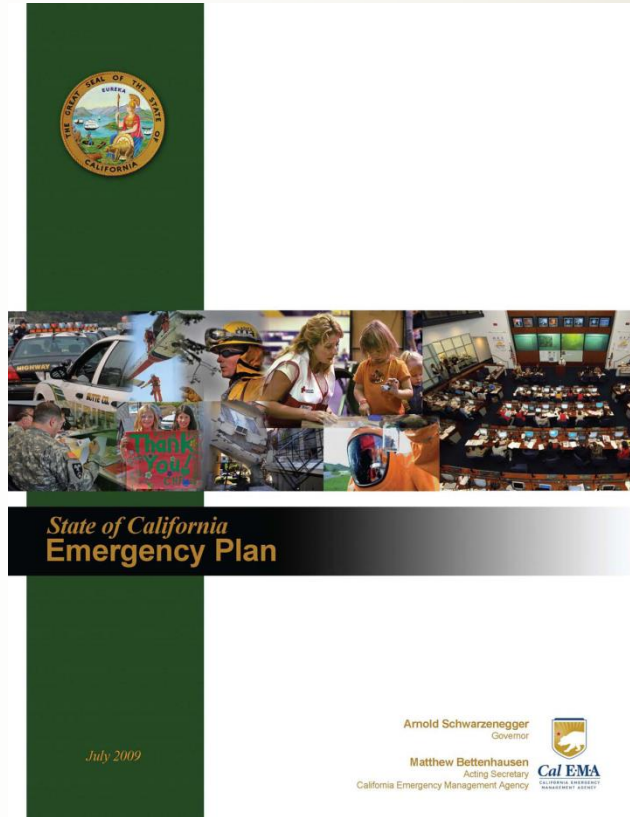
The State Emergency Plan

The SEP describes the state's response to extraordinary emergency situations.



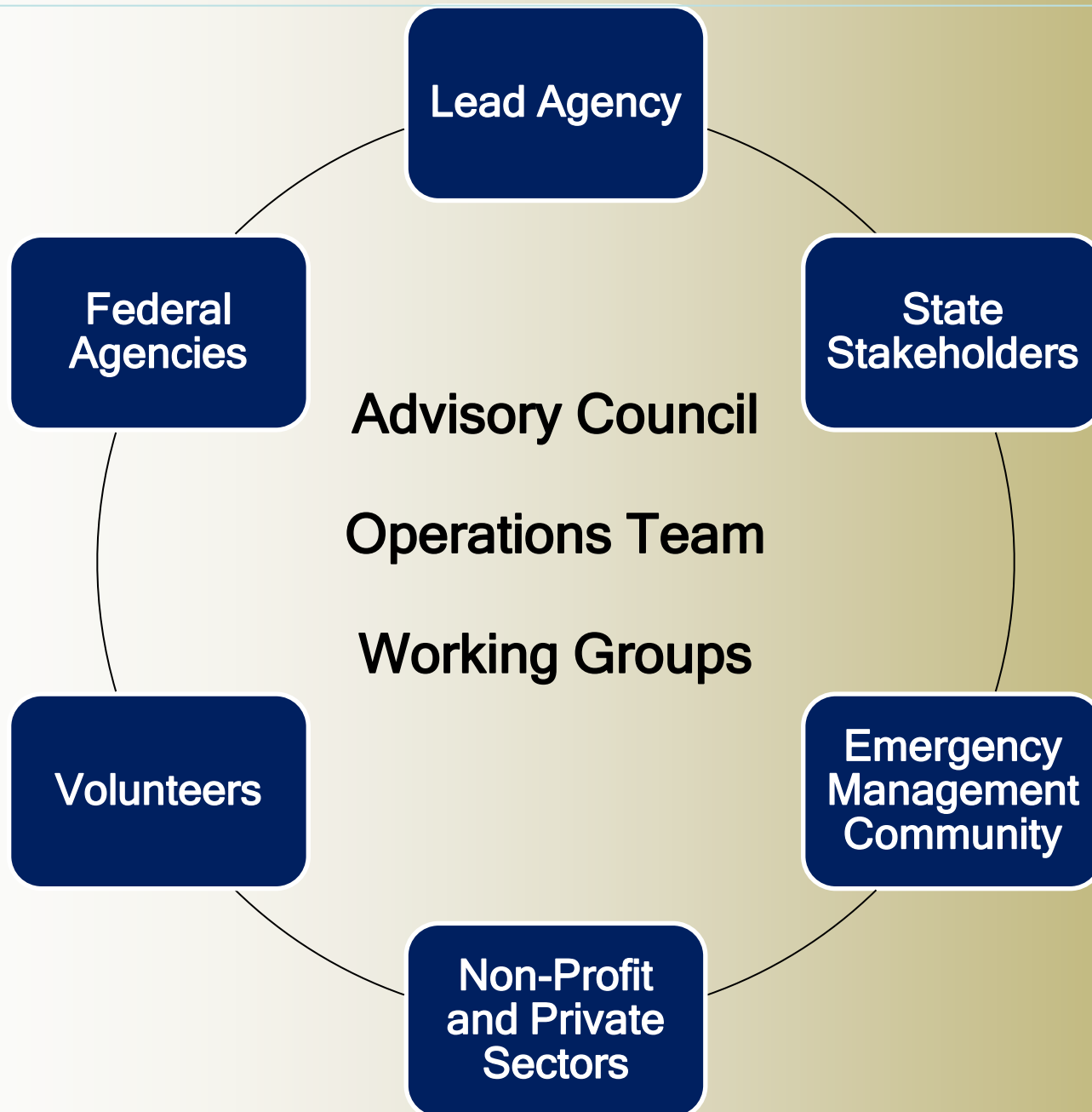

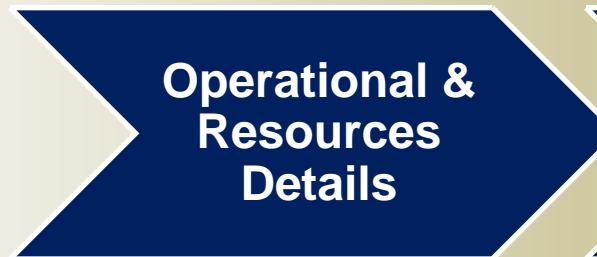

EF 3 Working Groups

- *EF 3 Capability Working Group*
 - Develop EF 3 specific capability directory, which captures the personnel and equipment that support the emergency event
 - Coordinate capture of existing data
- *Facilities Working Group*
 - Develop process for hazard identification and rating of state facilities to support emergency response and recovery, which includes determining structural integrity of the buildings, hazards associated with the location of the facilities and any other major infrastructure components

EF 7 Working Groups

- *Critical Assets/Core Commodities Working Group*
 - Develop initial critical assets list, which includes food, water, fuel, generators, and other core commodities
 - Evaluate existing inventory systems & coordinate capture of existing resource data
- *Facilities Working Group*
 - Identify state owned/controlled facilities
 - Develop characteristics and uses for identified facilities during emergencies, which can be utilized for shelters, feeding, medical support, and other required needs
- *Emergency Acquisition Working Group*
 - Update the DGS Emergency Acquisition Guide
 - Revise and develop Emergency Contracting Procedures, which will streamline the processes for acquisitions made during an event and to ensure proper reconciliation with the State Controller's Office to prevent or reduce the number of items disallowed as improper emergency purchases
