## FEMA-4683-DR-CA: California Severe Winter Storms, Flooding, Landslides, and Mudslides

On January 14, 2023, President Joseph R. Biden, Jr. declared a major disaster making federal disaster aid available to Merced, Sacramento, and Santa Cruz counties for the California Severe Winter Storms, Flooding, Landslides, and Mudslides; additional amendments starting January 17, 2023, to include Alameda, Butte, Calaveras, Colusa, Fresno, Glenn, Humboldt, Los Angeles, Marin, Mendocino, Monterey, Placer, San Benito, San Joaquin, San Luis Obispo, Santa Barbara, Santa Clara, Siskiyou, Sonoma, Trinity, Tulare, Ventura, and Yolo counties. This Fact Sheet contains information regarding the affected counties, available assistance, and Request for Public Assistance (RPA) application information.

### Available Assistance – Public Assistance (PA) Program

Under the PA program, FEMA to cost share eligible Emergency work costs at 100 percent for the first 60 days of the incident period, and 75 percent from day 61 and forward; and FEMA to cost share 75 percent of the eligible Permanent Work costs. See illustration below. The State cost shares at 75 percent of the Non-Federal share.

#### EMERGENCY WORK

- Debris Removal (**Category A**)
- Emergency Response and Protective Measures (**Category B**)

**Note:**

1. Category A "Only" - Force Account Labor overtime eligible and regular time may be eligible.
2. Category B Force Account Labor for Emergency Work - Only overtime eligible.

#### PERMANENT WORK

- Roads and Bridges (**Category C**)
- Water Control Facilities (**Category D**)
- Buildings and Equipment (**Category E**)
- Utilities (**Category F**)
- Parks, Recreational Facilities, Other Items (**Category G**)

**Note:**

Force Account Labor Permanent Work - Regular and overtime eligible.

### Important Work Eligibility Information

FEMA-4683-DR makes available federal funding for **Categories A - G** as listed below:

Alameda, Butte, Calaveras, Colusa, Fresno, Glenn, Humboldt, Los Angeles, Marin, Mendocino, Merced, Monterey, Placer, Sacramento, San Benito, San Joaquin, San Luis Obispo, Santa Barbara, Santa Cruz, Santa Clara, Siskiyou, Sonoma, Trinity, Tulare, Ventura, and Yolo counties

**RPAs must be received by the Public Assistance Division via Grants Portal no later than:**

**February 13, 2023** - Merced, Sacramento, and Santa Cruz counties

**February 16, 2023** - Monterey, San Luis Obispo, and Santa Barbara counties

**February 25, 2023** - San Benito, Tulare, and Ventura

**March 3, 2023** - Alameda, Butte, Calaveras, Colusa, Fresno, Glenn, Humboldt, Los Angeles, Marin, Mendocino, Placer, San Joaquin, Santa Clara, Siskiyou, Sonoma, Trinity, and Yolo counties
