Broadband Overview

Broadband refers to a high-speed internet connection that allows for the transmission of large amounts of data at a faster rate than traditional, dial-up internet connections. It enables users to access the internet, download and upload files, stream videos, participate in online telehealth, and engage in various other online activities with greater efficiency and speed.

The term "broadband" is used to describe a wide range of technologies and transmission mediums that provide these high-speed connections. Common broadband technologies include Digital Subscriber Line (DSL), cable, fiber optic, satellite, and wireless connections.

The key characteristics of broadband are its ability to offer fast data transfer rates, low latency, and the capability to handle multiple data streams simultaneously. This high capacity and speed allow users to have a more efficient and seamless online experience accessible across various devices, such as computers, smartphones, tablets, and smart TVs. Broadband has become a fundamental infrastructure for modern communication and has greatly transformed the way people access and interact with information on the internet.

The California Governor's Office of Emergency Service's Infrastructure RSF has developed the Broadband Resource Guide to provide funding and technical assistance to the communities that need broadband. This guide's grant funding, technical assistance, and support resources are intended to assist with current recovery activities and build broadband resiliency for the future.

Program Description	The purpose of the Small, Rural School Achievement (SRSA) program is to provide small, rural local educational agencies (LEAs) with financial assistance to address the unique needs of rural school districts that frequently lack the personnel and resources needed to compete effectively for Federal competitive grants and receive formula grant allocations in amounts too small to be effective in meeting their intended purposes. LEAs are entitled to funds if they meet eligibility and application requirements. Awards are issued annually, and award amounts are determined using a formula.

	purposes. The grant is non-competitive, and eligibility is determined by statute. <p>Program Description</p>	<p>The Section 108 Loan Guarantee Program (Section 108) provides communities with a source of low-cost, long-term financing for economic and community development projects. Section 108 financing provides an avenue for communities to undertake larger, more costly projects, where they may have limited resources to invest in upfront.</p> <p>Section 108 can fund economic development, housing, public facilities, infrastructure, and other physical development projects, including improvements to increase their resilience against natural disasters. This flexibility of uses makes it one of the most potent and important public investment tools that HUD offers to states and local governments.</p> <p>Section 108 assistance can be deployed in two ways:</p> <ul style="list-style-type: none"> • Directly by the community or its governmental or non-profit partner to carry out an eligible project • Indirectly with a community or its partner re-lending (or, in limited circumstances, granting) the funds to a developer or business to undertake an eligible project <p>The program is authorized under Section 108 of the Housing and Community Development Act of 1974 as the loan guarantee component of the Community Development Block Grant (CDBG) Program. The specific regulations governing the Section 108 Program may be found at 24 CFR 570, Subpart M, Loan Guarantees.</p>

Department of Transportation (DOT) Utilities Program: Accelerating Broadband Infrastructure Deployment

Program Description	<p>It has been recognized that it is in the public interest for utility facilities to jointly use the right-of-way of public roads and streets when such use and occupancy does not adversely affect highway or traffic safety, or otherwise impair the highway or its aesthetic quality, and does not conflict with the provisions of Federal, State, or local laws and regulations. The opportunity for such joint use avoids the additional cost of acquiring separate right-of-way for the exclusive accommodation of utilities. As a result, the right-of-way of highways, particularly local roads and streets, is often used to provide public services to abutting residents as well as to serve conventional highway needs.</p> <p>There is no direct funding specifically for broadband. However, broadband may be eligible for reimbursement with federal-aid highway funds if it supports a transportation use.</p>
