Microgrid Overview

Microgrids are self-powered electrical grid systems that can be used to power a small community, a school, a hospital campus, or even a single-family dwelling, independently of the larger electrical grid. The microgrid technology is an alternative energy generation and distribution system that can provide backup power during emergencies to increase resilience while reducing total energy costs. In addition, microgrids provide cost savings and also allow for energy independence, and they have proven to be more reliable and environmentally friendly than fossil-fuel alternatives.

The following features demonstrate the benefit of microgrids:

- **Standalone capability** If the main power grid resource goes offline, a microgrid can provide an autonomous source of energy that continues providing power.
- **Resiliency** Because microgrids are localized, and not distributed over hundreds of miles like traditional electrical power lines, they can be built to withstand common effects of disaster.
- **Green** Microgrids are generally powered by solar photovoltaic panels, but can also derive power from wind, hydroelectric, geothermal, or a combination of these sources.
- **Profitability** Excess power produced by microgrids can be directed back into the main grid, for a profit to the microgrid owner.
- Reliability Microgrid reliability can be increased through the establishment
 of maintenance contracts with third-party vendors. A microgrid is
 composed of a power source, a power controller that routes electricity,
 storage batteries, and often a fossil fuel electric generator, which serves as
 a backup power source if the microgrid goes offline. When a generator runs
 on a microgrid, it operates at full efficiency until the batteries are
 recharged, then shuts off (unlike usual generator operation that runs less
 efficiently to simply meet a load demand.)

Program Description	The National Science Foundation, EPCN Program supports innovative research in modeling, optimization, learning, adaptation, and control of networked multi-agent systems, higher-level decision making, and dynamic resource allocation, as well as risk management in the presence of uncertainty, sub-system failures, and stochastic disturbances. EPCN's goal is to encourage research on emerging technologies and applications including energy, transportation, robotics, and biomedical devices & systems. EPCN invests in novel machine learning algorithms and analysis,
	adaptive dynamic programming, brain-like networked architectures performing real-time learning, and neuromorphic engineering. EPCN additionally emphasizes electric power systems, including generation, transmission, storage, and integration of renewable energy sources into the grid; power electronics and drives; battery management systems; hybrid and electric vehicles; and understanding of the interplay of power systems with associated regulatory & economic structures and with consumer behavior.

California Public Utilities Commission (CPUC) Microgrid Incentive Program (MIP)	
Application Deadline	 Early October 2023 - Within 180 days upon issuance of the decision, the utilities shall make available the MIP Handbook. Early July 2024 - The first MIP application window opens no later than nine (9) months after the publication of the MIP Handbook.
Program Description	 The California Public Utilities Commission (CPUC) has established a Microgrid Incentive Program (MIP) under a January directive tied to Senate Bill 1339 (2018) to help fund clean energy microgrids and increase resilience of communities vulnerable to power loss. MIP objectives include the following: Increase electrical reliability and resiliency in communities at higher risk of electrical outage. Increase electrical power reliability for critical infrastructure such as fire stations, schools, and nursing homes that keep communities safe. Reduce impacts of power outages and minimize disruptions for low-income households, persons requiring uninterrupted power, needing assistive or medical equipment, or having other access and functional needs. Reduce Greenhouse Gas emissions by deploying clean power generation technologies and expanding the market for resiliency solutions that do not rely on diesel power generation.

Program Description	California Infrastructure and Economic Development (IBank) IBank's ISRF Loan Program provides low-cost, direct loans to local governments and nonprofits sponsored by public agencies for a wide variety of public infrastructure and economic expansion projects (excluding housing) that improve and sustain communities, helping individuals and families thrive. We focus on small and midto moderate-sized local governments and special districts – including those in underserved regions and communities. Eligible infrastructure projects include, but are not limited to, educational, cultural, and social facilities, power and communications facilities, and city streets, among many others (see web page).

Projects must be stand-alone activities that will reduce risk as their primary benefit, but Cal OES strongly encourages the submission of projects that achieve multiple benefits. Self-Generation Incentive Program (SGIP)	
Application Deadline	Ongoing
Program Description	The California Public Utilities Commission (CPUC) SGIP provides incentives to support existing, new, and emerging distributed energy resources. SGIP provides rebates for qualifying distributed energy systems installed on the customer's side of the utility meter. Qualifying technologies include battery systems, wind turbines, pressure-reduction turbines, and projects involving onsite, directed, or vented biogas. The following projects are eligible if powered by 100% biogas: fuel cells, internal combustion engines (generators), microturbines, and gas turbines. The following projects are ineligible: solar, and projects involving the flaring of biogas.
