New Courses on Inclusive Emergency Management

To empower jurisdictions to further their inclusive disaster preparedness and emergency response measures, Cal OES, through the Office of Access and Functional Needs (OAFN) and the California Specialized Training Institute, is developing three new online training courses.



Designed to help emergency managers take their integrated emergency planning and operations to the next level, the courses will focus on:

- 1. Inclusive Communication
- 2. Inclusive Evacuation/Transportation
- 3. Inclusive Mass Care & Sheltering

Grounded in concentrated, proven, actionable principles and practices, the courses aim to present inclusive, life-saving information in a straightforward, approachable format that can be accessed and utilized by emergency managers and whole community stakeholders anytime, anywhere via the agency's web-based learning management system.

The courses will be available for delivery by May 2023.

Cal OES Expands Digital Document Accessibility Courses



Cal OES is committed to furthering equity and inclusion by ensuring the plans, best practices, and information the agency develops to enhance preparedness and resilience meet 508 accessibility compliance standards. To support this mission, the Office of Access

and Functional Needs (OAFN) provides monthly training courses on creating accessible documents and forms. In an effort to improve digital accessibility throughout the field of emergency management, Cal OES is expanding its training offerings, for free, to emergency managers throughout the state.

California's Continued Efforts to Fight COVID-19

Cal OES continues to make progress to ensure Californians at highest risk for negative impacts associated with COVID-19 receive the resources they need to stay healthy, safe, and secure.

Throughout the pandemic, Cal OES has collaborated with whole community partners to distribute hundreds of millions of surgical, N95, and cloth masks; bottles of hand sanitizer; face shields; gowns;



sanitization wipes; at-home COVID-19 tests; and other vital Personal Protective Equipment across the State.

Cal OES has also supported the development of mechanisms to provide free, accessible transportation for individuals with access and functional needs to/from vaccination sites. The agency also promoted the launch of a peer-support friendship line for older adults. To utilize the service, call Friendship Line California at (888) 670-1360.
