The Power of Partnerships




Due to California's diverse risk landscape, OAFN often supports multiple incidents, events, and declared disasters at the same time. For example, while activated in response to last month's extreme heat event, OAFN was also supporting activities associated with wildfires, grid reliability concerns, air quality issues, and a tropical storm impacting Southern California.

Throughout these complex events, OAFN maintains ongoing communications with whole community partners and stakeholders serving older adults, individuals with disabilities, and people with access or functional needs throughout the state. This partnership enables the identification of unmet needs and empowers the facilitation of efforts necessary to address those needs in timely and meaningful ways.

OAFN also utilizes partnerships to support disaster-related initiatives before disasters occur. For example, following the announcement by investor-owned utilities that they would be proactively de-energizing lines to avoid potential wildfire starts caused by damaged infrastructure, OAFN outlined the need for power providers to partner with community-based organizations to better serve electricity-dependent Californians. Among the partnerships that formed was a relationship between Pacific Gas & Electric (PG&E) and the California Foundation of Independent Living Centers (CFILC) that led to the development of the Disability Disaster Access & Resources (DDAR) program. Funded by PG&E and administered by CFILC, the DDAR program provides charging capabilities, accessible transportation services, and lodging at no-cost for many Californians with access and functional needs.

Whether before, during, or after disasters – the power of partnership is real.

The National Access and Functional Needs Symposium

The National Access and Functional Needs Symposium was held virtually on July 19 & 20, 2022. Over 2,300 people registered for the first-of-its-kind event.

The National AFN Symposium brought the disability community together with emergency managers, disaster planners, and first responders from across the country in an online forum that fostered an environment of trust and understanding vital to advancing the mission of access and functional needs

throughout the nation.

Led by the Cal OES and organized in partnership with the International Association of Emergency Managers (IAEM), the Colorado Division of Homeland Security and Emergency Management (CDHSEM), and New York University (NYU), the Symposium highlighted forward-leaning, inclusive, innovative practices in emergency management from across the nation. The event was sponsored by Big City Emergency Managers and the American Red Cross.
