- Federal Legislation Update
  - i. Disaster Mitigation and Tax Parity Act 2025\_
    - Text S.336 119th Congress (2025-2026): A bill to amend the Internal Revenue Code of 1986 to exclude from gross income amounts received from State-based catastrophe loss mitigation programs. | Congress.gov | Library of Congress
  - ii. H.R.7849 Disaster Resiliency and Coverage Act of 2024
    - 1. Text H.R.7849 118th Congress (2023-2024): Disaster Resiliency and Coverage Act of 2024 | Congress.gov | Library of Congress
    - 2. The legislation includes four main provisions.
      - a. 1<sup>st</sup> creates a grant program, administered through State governments, through which individual households in designated disaster-prone regions (with certain limitations) are eligible for up to \$10,000 for specified disaster resiliency work on their homes.
      - b. 2<sup>nd</sup> and 3<sup>rd</sup> provisions (Sections 3 and 4 of the legislation) mirror existing legislation (H.R. 4070) stipulating that payments from State-run disaster resiliency programs and payments from various federal emergency agricultural programs are not considered income for federal tax purposes.
      - c. 4<sup>th</sup> section provides a 30% tax credit for qualified disaster risk mitigation activities conducted by individuals or businesses. The credit is meant to complement the grant program by providing meaningful assistance to larger property owners for whom mitigation activity costs would far exceed \$10,000
- State Legislation Update
  - i. SB616 Community Hardening Commission: wildfire mitigation program
    - Require the joint powers authority to revise the wildfire mitigation program in accordance with prescribed community hardening standards and guidelines developed pursuant to the bill's provisions, as specified.
    - 2. Establish the Community Hardening Commission as an independent unit within the Department of Insurance, to be composed of specified members, including, among others, the

Insurance Commissioner and the State Fire Marshal or Secretary of the Natural Resources Agency, or their designee.

- ii. AB1 Residential property insurance: wildfire risk
  - Require the Department of Insurance, on or before January 1, 2030, and every 5 years thereafter, to consider whether or not to update its regulations to include additional building hardening measures for property-level mitigation efforts and communitywide wildfire mitigation programs. As part of this consideration, the bill would require the department to consult with specified agencies to identify additional building hardening measures to consider, as well as to develop and implement a public participation process during the evaluation
- iii. AB1143 State Fire Marshal: home hardening certification program
  - This bill would require, on or before January 1, 2027, the Office of the State Fire Marshal to develop a home hardening certification program that identifies the best appropriate combination of those listed products and construction assemblies, and other home hardening techniques, including defensible space, to substantially reduce the risk of loss during a fire. The bill would require the Office of the State Fire Marshal, for the purpose of developing the home hardening certification program, to convene and facilitate a workgroup, as specified. The bill would authorize the Office of the State Fire Marshal to expend funds from the Building Standards Administration Special Revolving Fund, upon an appropriation by the Legislature, for the purposes of developing the home hardening certification program and convening and facilitating the workgroup.
- iv. SB662 Wildfires: defensible space: education efforts
  - 1. Existing law requires the Director of Forestry and Fire Protection, until January 1, 2026, to establish a statewide program to allow qualifying entities to support and augment the Department of Forestry and Fire Protection in its defensible space and home hardening assessment and education efforts and requires the director to establish a common reporting platform that allows defensible space and home hardening assessment data, collected by qualifying entities, to be reported to the department, among other things.
  - 2. Existing law requires the department, until January 1, 2026, to develop and implement a training program to train individuals to support and augment the department in its defensible and home hardening assessment and public education efforts.
  - 3. This bill would extend those programs to January 1, 2031.
- v. AB1457 Wildfires: training programs: defensible space: inspections
  - 1. Existing law requires the department, until January 1, 2026, to develop and implement a training program for individuals to support and augment the department in its defensible and

home hardening assessment and public education efforts. Existing law requires the training program to do specified things.

- 2. This bill would require the training program to include training consistent with the "Home Ignition Zone/Defensible Space Inspector" course plan, established by the State Fire Marshal, to ensure that individuals are trained to conduct home ignition zone inspections. The bill would also extend the operative date of both programs described above indefinitely.
- vi. SB499 Fire prevention: home hardening: defensible space: data usage
  - 1. Existing law requires the Director of Forestry and Fire Protection, until January 1, 2026, to establish a statewide program to allow qualified entities to support and augment the Department of Forestry and Fire Protection in its defensible space and home hardening assessment and education efforts. Existing law requires the director to establish a common reporting platform that allows defensible space and home hardening assessment data, collected by the qualified entities, to be reported to the department and requires the director to establish any necessary quality control measure to ensure that the assessment data is accurate and reliable. Existing law authorizes the director to use the assessment data, as specified.
  - 2. This bill would instead require the director to use that assessment data, as specified.
- vii. SB269 Personal income taxes: Fire Safe Home Tax Credits Act
  - 1. This bill would require the department to create a standardized accreditation framework for counties to accredit local governments, fire safe councils, and homeowners for following wildfire prevention practices, as provided. The bill would require the department to maintain a publicly available database with specified information, including the counties that have opted into the accreditation framework
- viii. AB888 California Safe Homes grant program
  - 1. This bill would establish the California Safe Homes grant program to be developed by the department to reduce local and statewide wildfire losses, among other things. The bill would require the department to prioritize specified needs when awarding grant funds, and would require eligible program applicants, which would include individuals, cities, counties, and special districts, to meet specified criteria. The bill would establish the Sustainable Insurance Account within the Insurance Fund, which would be continuously appropriated to fund the program. The bill would require 40% of the amount of the gross premiums tax collected from property and casualty insurance above the amount collected from those insurers in 2023 to be deposited into the account. By depositing general fund moneys into a continuously appropriated account, the bill

would make an appropriation. The bill would require the department to collect specified information about the performance of the program and, on or before January 1, 2027, and every 2 years thereafter, to publish a performance report that would be posted to its internet website and submitted to the Legislature

- ix. SB514 Wildfire prevention: accreditation
  - This bill would require a qualified taxpayer to reserve a credit for qualified costs relating to qualified home hardening or qualified vegetation management to be eligible for the abovedescribed credits and provide all necessary information for this purpose, as specified.
    - a. This bill also would include additional information required for any bill authorizing a new income tax credit and would require the Legislative Analyst's Office to prepare a written report regarding the credits, as provided.
    - b. This bill would take effect immediately as a tax levy.
- x. SB90 Safe Drinking Water, Wildfire Prevention, Drought Preparedness, and Clean Air Bond Act of 2024: grants: improvements to public evacuation routes: mobile rigid water storage: electrical generators.
  - 1. This bill would include in the list of eligible projects grants to the above-mentioned entities for improvements to public evacuation routes in very high and high fire hazard severity zones, mobile rigid dip tanks, as defined, to support firefighting efforts, prepositioned mobile rigid water storage, as defined, and improvements to the response and effectiveness of fire engines and helicopters. The bill would also include grants, in coordination with the Public Utilities Commission, to local agencies, state agencies, special districts, joint powers authorities, tribes, and nonprofit organizations for backup electrical generators for water reservoirs.
- xi. AB441 Wildfire prevention: Office of Wildfire Technology Research and Development: wildfire mitigation program.
  - 1. (2) Existing law, upon appropriation of the Legislature, requires the Office of Emergency Services to enter into a joint powers agreement with the Department of Forestry and Fire Protection to develop and administer a comprehensive wildfire mitigation program. Existing law requires the department to delegate its duties and responsibilities for this program to the Office of the State Fire Marshal. Existing law requires the State Fire Marshal, in consultation with other officials, to identify measures eligible for financial assistance under the wildfire mitigation program that are both cost effective and provide for appropriate site or structure fire risk reduction, as specified. Existing law requires the joint powers authority to develop eligibility criteria for property owners, community organizations, and local governments who may receive financial assistance under the wildfire mitigation

program. Existing law requires the joint powers authority to submit a report to the Legislature regarding the implementation of the wildfire mitigation financial assistance program that includes, among other things, an evaluation of the costeffectiveness of the wildfire mitigation program compared to other structure hardening, defensible space, vegetation management, and fuel reduction incentive programs and an evaluation of the overall wildfire risk reduction achieved statewide through awards of financial assistance under the wildfire mitigation program. Existing law repeals these provisions on July 1, 2029.

- 2. This bill would delete the July 1, 2029, repeal date described above, thereby extending these provisions indefinitely.
- 3. The bill was previously suspended, there is a hearing this week and we should know something soon
- xii. CWMP Pilot Program Next Steps
  - 1. CWMP Funding Budget Act 2022 (AB-179) Funding \$13 Million
    - a. ~\$6 Million Committed to Siskiyou County for HMGP Grant ~\$24 million
    - b. ~\$7 Million Committed to Riverside County for HMGP Grant ~\$26 million
    - c. Both Projects submitted to FEMA on 11/21/2024 utilizing funding opportunity DR-4699-CA (California Severe Winter Storms, Straight-line Winds, Flooding, Landslides, and Mudslides) FEMA Review will take ~7-12 months.
    - 2. SB946, Personal Income Tax Law: Corporation Tax Law: exclusions: wildfire mitigation payments (2023-2024)
    - 3. Proposition 4
      - a. Grants under the Home Hardening Program to retrofit, harden, or create defensible space for homes at high risk of wildfire in order to protect California communities
    - 4. SECTION 1. Section 91510 of the Public Resources Code is amended to read
      - a. 91510. (a) Of the funds made available by Section 91500, \$135,000,000 shall be available, upon appropriation by the Legislature, to the Office of Emergency Services for a wildfire mitigation grant program. The Office of Emergency Services shall coordinate with the Department of Forestry and Fire Protection in administering these moneys. The grant program shall assist local and state agencies to leverage additional funds, including matching grants from federal agencies. Funds may be used to provide loans, rebates, direct assistance, and matching funds for projects that prevent wildfires, increase resilience, maintain existing wildfire risk reduction projects, reduce the risk of wildfires to communities, or increase home or community hardening.

Projects shall benefit disadvantaged communities, severely disadvantaged communities, or vulnerable populations.

i. The amended JPA agreement and resolution have been sent to CAL FIRE and Cal OES legal teams for review. The recommendation was for them to accept the amended dates and sign as is to extend dates, then provide additional feedback for any subsequent changes.

- 1. CAL FIRE has agreed to sign the Agreement and is going through their processes and will be sent to Cal OES.
- 2. Cal OES council has stated they will be reaching out soon to set a meeting.

# V. BOARD MEMBER COMMENTS

- a. A. Browning, Budget Hearings are ongoing, Board Member Berlant and the State Hazard Mitigation Officer are attending the meetings and testifying on programs, including the CWMP. It is fire season, already receiving notifications regarding fires, as well as still working on recovery in Los Angeles, moving ahead at amazing speed. Also, wants to acknowledge the Law Enforcement responding to the terrorist attack over the weekend.
- b. F. Bigelow provided year to date numbers regarding fires for 2025, 1,525 fires so far, increase of 233 since last Monday. Compared to same time 2024, 1,130 fires. For five-year average we are a little under. Acres burned so far in 2025 is 66,618. All the more importance why we are here, hopefully a better chance for survivability of homes and property.
