- CWMP Pilot Program Next Steps
 - i. CWMP Funding Budget Act 2022 (AB-179) Funding \$13 Million
 - 1. ~\$6 Million Committed to Siskiyou County for HMGP Grant ~\$24 million
 - 2. ~\$7 Million Committed to Riverside County for HMGP Grant ~\$26 million
 - 3. The \$13 Million from AB-179, will now come from Prop 4 funds
 - 4. Both Projects submitted to FEMA on 11/21/2024 utilizing funding opportunity DR-4699-CA (California Severe Winter Storms, Straight-line Winds, Flooding, Landslides, and Mudslides) FEMA Review will take ~7-12 months.
 - ii. SB-946, Personal Income Tax Law: Corporation Tax Law: exclusions: wildfire mitigation payments (2023-2024)
 - iii. Proposition 4
 - 1. Grants under the Home Hardening Program to retrofit, harden, or create defensible space for homes at high risk of wildfire in order to protect California communities
 - 2. SECTION 1. Section 91510 of the Public Resources Code is amended to read
 - a. 91510. (a) Of the funds made available by Section 91500, \$135,000,000 shall be available, upon appropriation by the Legislature, to the Office of Emergency Services for a wildfire mitigation grant program. The Office of Emergency Services shall coordinate with the

Department of Forestry and Fire Protection in administering these moneys. The grant program shall assist local and state agencies to leverage additional funds, including matching grants from federal agencies. Funds may be used to provide loans, rebates, direct assistance, and matching funds for projects that prevent wildfires, increase resilience, maintain existing wildfire risk reduction projects, reduce the risk of wildfires to communities, or increase home or community hardening. Projects shall benefit disadvantaged communities, severely disadvantaged communities, or vulnerable populations.

- AB 38, July 1, 2025, disclosure requirements.
 - i. This bill, on or after January 1, 2021, would require the seller of any real property located in a high or very high fire hazard severity zone to provide a prescribed disclosure notice to the buyer, if the home was constructed before January 1, 2020, of information relating to fire hardening improvements on the property and a list of specified features that may make the home vulnerable to wildfire and flying embers and which features, if any, that exist on the home of which the seller is aware. *The bill, on or after July 1, 2025, would require the disclosure notice to also include the State Fire Marshal's list of low-cost retrofits.* The bill would also require a seller who has obtained a specified final inspection report to provide to the buyer a copy of that report or information on where a copy may be obtained.
- c. Shasta County Fire Safe Council Update, Pam Bates, Project Manager
 - Roles and Responsibilities – SCFSC and Partners
 - i. SCFSC: Project Management, Construction Management (Scope of Work (SOW), bids, contractor oversight, inspection), contracting, grant and finance management.
 - ii. Three SCFSC staff dedicated to the project; Project Manager (PM) Construction Manager (CM), Project Assistant).
 - iii. Western Shasta Resource Conservation District (WSRCD) responsibilities: Outreach, education, application processing, assessments, SOWs and Site-specific checklist.
 - iv. Three to four RCD staff
 - v. Our model - a small core team, with tightknit relationships with local agencies and contractors. Very efficient, scalable, and can adapt when needed
 - Successes:
 - i. Homeowners extremely happy with results, appreciative of personal attention and education.

- Have helped them with Wildfire Prepared Home certification, sale of homes.
- ii. Strong team of contractors have become very specialized, experts in implementing Minimum Quality Standards (MQS).
- iii. 17 homes completed to date, 14 more will be completed or in contract by November 15 (for a total of 31)
- iv. Time from Assessment to Home Hardening completed: Eight weeks
- v. Can work on multiple homes simultaneously
- vi. Average total cost per home: \$45,300
 - 1. Average cost for Defensible Space: \$4,700
 - 2. Average cost for Home Hardening Construction: \$40,600
- vii. Cost share cap has been effective in retaining program participants, homeowners know what to expect (e.g., reduced from \$6337 to \$3000).
- Challenges
 - i. Homeowners in our area are hesitant to participate in “government” programs.
 - ii. Homeowner confusion between our program and other CAL FIRE and FEMA projects in the area, bad experiences with PG&E.
 - iii. Remoteness of homes and limited access (slows implementation, increase costs)
 - iv. Number of parcels limited to No-Issue Parcels currently. This causes distrust of the process (not first in, first served; upset that there are “flags” on their property, no timeline as to when we can work on their home)
 - v. Dispersed No-Issue Parcels reduces the development and effectiveness of Fire Resilient Communities.
 - vi. Implementation blocked due to FEMA review delays

V. BOARD MEMBER COMMENTS

- a. F. Bigelow, Currently we have seasonable weather with moisture, helping to temper the risk of fire. Looking to tour areas near Sonora for the CA Wildfire and Resilience Task Force Regional Meeting in March 2026, may want to consider touring our project area in Tuolumne County if any work going on.
- b. R. Troy, Thank you to our hosts, the SCFSC, and the town of Whitmore. We have teams in Tuolumne County doing damage assessments, not enough for a major disaster recovery declaration from FEMA, but Small Business Administration (SBA) is available, offering low interest loans. Loans available up to \$500,000 plus 20% for

mitigation.

- c. A. Browning, Thank you to the community for hosting us this month. She is cautiously optimistic about the fire season, some of the most devastating fires have occurred this time of year, cautions everybody to stay vigilant.

VI. PUBLIC COMMENT

- a. T. Asef asked when and how will AB 3074 and SB 504 be enforced? She was referred to the Board of Forestry.
- b. L. James expressed the need for the CWMP in Sacramento County, specifically the City of Herald.
