

**A RESOLUTION OF THE CALIFORNIA WILDFIRE)
 MITIGATION PROGRAM AUTHORITY)
 ESTABLISHING HOMEOWNER COST SHARE)
 REQUIREMENTS)**

WHEREAS the California Wildfire Mitigation Program Authority (the “CWMP”) is a California joint powers authority organized under California Government Code Section 6500 et seq. and operating by and through its Board of Directors (“Board”); and

WHEREAS Government Code Section 8654.8(b) authorizes CWMP to establish financial assistance limits and matching funding or other recipient contribution requirements to ensure the viability and efficient operation of the wildfire mitigation program and to maximize the impact on reducing wildfire risk in California; and

WHEREAS in furtherance of the objectives of the program, the CWMP Board of Directors desires to establish homeowner cost share limits exclusively for the benefit for CWMP Board approved projects, with not to exceed amounts for each income bracket, based on Area Median Income (AMI) as determined by the California Department of Housing and Community Development (HCD).

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Directors of CWMP hereby establishes the cost share limits set forth in Table 1, exclusively for CWMP Board approved projects, set forth in Table 2, effective October 1, 2025 (the “Effective Date”).

BE IT FURTHER RESOLVED THAT no refunds, reimbursements, or other remedies shall be offered to program participants for any cost share contributions made prior to the Effective Date.

HCD Income Bracket	Cost Share Tier	Cost Share Details
Up to 120% AMI	N/A	No Cost Share (NCS)
Above 120% to 200% AMI	Tier 1 (T1)	10% of total project cost, not to exceed \$3,000
Greater than 200% AMI	Tier 2 (T2)	25% of total project cost, not to exceed \$6,000
