# I. Call to Order / Introductions

- The meeting was called to order by Advisory Board Executive Officer Derek Lambeth.
- Roll call was taken, and a quorum was achieved.
- Cal OES Director Nancy Ward opened the meeting with remarks that expressed gratitude towards all stakeholders and partners for their role in advancing operational strategies and the implementation of the Early Earthquake Warning (EEW) system and provided an overview of the meeting's agenda. She also extended a warm welcome to Jeremy Lancaster, introducing him as the new State Geologist with CGS.
- Jeremy Lancaster provided brief remarks reiterating CGS' support for the Cal OES mission and discussed the development of a strategic plan emphasizing CGS' role in supporting emergency services, including geological events that pose hazards to public safety and infrastructure.

# II. Review and Approve Meeting Minutes from May 10, 2023.

• The motion to approve was led by Board Member Sanchez-Cornejo. The motion was seconded by Board Member Cash. Motion passed unanimously.

# III. Recent Events

- Executive Officer Derek Lambeth provided an update on earthquakes occurring since the last board meeting in May 2023, along with the subsequent number of MyShake downloads and notable aftershocks.
- Doug Given, Geophysicist and USGS EEW Coordinator discussed the magnitude overestimation for the Isleton Earthquake.
- Robert de Groot, USGS ShakeAlert Coordinator, discussed high latencies and other issues around ShakeAlert-powered WEA deliveries for the Ojai Earthquake.
- Board Member Assefa asked whether the 5-second Alert Pause that is in place to account for potential overestimations would limit who is informed if the initial estimation is accurate. Given noted that it depends on the size of the actual earthquake; however, the reasons for including the pause outweigh not having it in place.
- Board Member Toney asked whether the ShakeOut test location being San Francisco was deliberate and cautioned that the test location could cause public confusion. De Groot suggested this would be better answered by UC Berkeley colleagues as the test was not a system





occurrence, it was specific to MyShake.

#### IV. Sector-Based Implementation

- Robert Sides, HOA General Manager of the Regatta Seaside Condominiums discussed steps taken to implement EEW in the condominium building, including determining risk management, the benefits, and the challenges encountered in implementation.
- Sides provided insight into how Cal OES can help similar HOAs implement EEW, including:
  - Adopting a formal set of policies to get high-rises started with EEW and ShakeAlert
  - Legislative options
  - Outreach to over 50,000 HOAs throughout California
  - Financial incentives
- Director Ward requested further clarification on the specific reasons behind the initial hesitation of the HOA board to approve the implementation of the EEW system. Sides clarified that it was a financial challenge rather than understanding the benefit of the technology.
- Board Member Pepper inquired about the integration of elevator recall systems, referencing an ongoing study on similar technology in airports. She sought to understand the specific challenges the HOA encountered in implementing such a system. Sides replied that elevator recall is considered a major benefit; however, the elevator contractor who owns the operating system was told by the city/county officials this could not be done. Director Ward asked if a reason was given for denying permission and Sides responded the contractor did not provide specifics but suspects a code issue is causing hesitancy and fear of changing the system. Board Member Pepper wondered if testing with other systems currently in place, such as a fire system, needs to be done to show EEW would not infringe on other systems and Sides agreed, saying there is a need for multiple systems to act as a backup during an emergency.
- Deputy Director Nezhura inquired if the implementation of the EEW system has yielded any advantages, specifically regarding the enhancement of home values and the reduction in insurance premiums for individual homeowners within the HOA. Sides responded the Regatta focuses on risk management and that insurance brokers feel that EEW gives them a lot of assurance, having a positive impact on insurance rates and coverage. However, it can depend on a broker's understanding of the technology





and willingness to negotiate.

• Executive Officer Lambeth stated Cal OES continues to explore the topics and issues Sides raised in the presentation and that having a diverse Advisory Board allows for greater possibility in addressing issues and policies.

# V. Research and Development

- The Operations Manager with Berkeley Seismology Lab, Julien Marty, provided a review of the test alert that was sent out on October 19, 2023, and discussed the MyShake Desktop/Chromebook app that is currently under development, emphasizing its suitability for professional settings where desktop computers are predominantly used for work. Marty then described the benefit of implementation on Google Chromebook and targeting schools for deployment of the MyShake app.
- Board Member Assefa inquired about the data and cybersecurity measures embedded in both the software and hardware components discussed. In response, Marty stated the commitment to security includes thorough and systematic reviews of the software, specifically targeting potential vulnerabilities, conducted prior to the software's official release. Deputy Director Nezhura reiterated that Cal OES coordinated with the State Threat Assessment Center and the California Cybersecurity Integration Center to ensure compliance with state security protocols.

# VI. System Operations

- Executive Officer Lambeth provided updates on the system build-out.
- Hamid Haddadi of the California Geological Survey provided an update on the California Integrated Seismic Network Display Standalone Application functions and new developments, including the ability to serve as a real-time earthquake display, provide customized features and views for emergency responders, and act as a redundancy for access to earthquake information. Haddadi also introduced the newly developed QuakeWatch Web Application, which was developed to provide more advanced functions and a more user-friendly interface. In conclusion, Haddadi discussed the Community Seismic Network (CSN) pilot project, which will collocate CSN packages with high-resolution California Strong Motion Instrumentation Program instruments at ten (10) ground response stations and one (1) building, to record earthquakes by both instrument types, and to evaluate the usability of CSN records.





- Deputy Director Nezhura requested information regarding the origins of the traffic data on QuakeWatch. Haddadi noted that there are public access web sources that provide traffic information but would need to follow up to provide specifics. Deputy Director Nezhura restated the benefits this will have to first responders.
- Board Member Pepper reiterated the importance of the availability of this information for first responders and those who assist first responders, such as transit operators.

### VII. Education and Outreach

- Jon Gudel, Senior Emergency Services Coordinator with the EEW program, provided an update on the pilot partnership with the San Jose Earthquakes Major League Soccer team, including a review of assets, metrics, and outcomes.
- Director Ward noted that the Earthquakes announced the building of additional training fields and facilities in Santa Clara, so there may be additional opportunities for partnerships moving forward.
- Deputy Director Nezhura noted that she had the opportunity to meet with the Earthquakes' president who expressed the desire to educate fans and encouraged continued relationship building with community partners. Board members should work with Cal OES on any ideas for other partnerships that can further EEW.
- Board Member Toney noted the work San Diego OES had done with the San Diego Padres that had a similar impact.
- Board Member Assefa suggested the provision of giveaways at events in addition to providing information, particularly earthquake putty because it is a good tool people are not likely to purchase. Executive Officer Lambeth stated some items are currently used as giveaways, but Cal OES can consider other items and tools like the earthquake putty.
- Yvette LaDuke, Program Manager, Earthquake, Tsunami, Volcano briefed on the recently completed Great California ShakeOut Tour, including locations, a focus on equity, outcomes, and media coverage.
- Director Ward noted the greater impact of a tour rather than a singular event because it reaches a wider, more diverse audience.
- Board Member Grant applauded the outcomes of the tour.





#### VIII.Finance

• Deputy Director Nezhura provided an overview of the financial budget and spending plan. She informed the board a report was submitted to the state legislature regarding funding opportunities. This report will be sent to board members and made available on the Cal OES EEW website.

### IX. Closing Comments

- Director Ward thanked the partners at USGS, UC Berkeley, CGS, and Special Speaker Robert Sides. She iterated that the input from board members is critical to the EEW program and encouraged them to remain engaged, bring ideas, and continue to represent their constituencies.
- Board Member Pepper suggested including the Gov Ops agency in future board meetings, and to look for opportunities to streamline procurement.
