Review of Training Records Inspection: All required *training certificates* to verify Hazardous Materials Specialist were presented and were in order. We can verify that you have a minimum of seven (7) personnel trained to CSTI Hazardous Materials Specialist (HMS) 240 hour. We can certify that one of those five also has attained the Assistant Safety Officer training, by proof of certificate, effective this date. Furthermore, we can certify by proof of certificate that these seven personnel also have received the 24 hours of WMD/Terrorism CSTI training, or equivalent.

**Review of Equipment Inspection – Type 1:** According to our records, documentation submitted to show receipt of all *equipment items* required for a Type 1 Hazardous Materials Company in accordance with the FIRESCOPE *Standardized Equipment List* have been found to be present and available. Therefore, we can certify that your hazardous materials response unit, "HM-2599", has met all requirements for standardized equipment for a California Office of Emergency Services, Fire & Rescue Division Type 1 Hazardous Materials Team. We would like to remind you that effective immediately and here-after, all equipment and gear as presented and documented in the *Inspection Record* must be available and respond with your company whenever activated and mobilized for a mutual aid response through the Cal OES Fire & Rescue Mutual Aid system. Similarly, your agency

must also insure that when activated and mobilized the staffing of your company shall always comply with the minimum as required (seven for a Type 1) and trained to the minimum State requirement level (Hazardous Materials Specialist). Please review Bulletin #20 for a more in depth description and explanation of procedures to follow when a mutual aid activation is through the Cal/EMA process.
