We would like to remind you that effective immediately and here-after, all equipment and gear as presented and documented in the *Inspection Record* must be available and respond with your company whenever activated and mobilized for a mutual aid response through the Cal OES Fire & Rescue Mutual Aid system. Similarly, your agency must also insure that when activated and mobilized the staffing of your company shall always comply with the minimum as required (five for a Type 3 and Type 2, seven for a Type 1) and trained to the minimum State requirement level. Please review Bulletin #20 for a more in depth description and explanation of procedures to follow when a mutual aid activation is through the Cal OES process.
