

CICCS 2014 Qualifications Guide Errata Sheet #1

Equivalency Matrix:

Adds S-200 back to the Equivalency Matrix with the language from the 2010 Equivalency Matrix

Adds Command 2E back to the Equivalency Matrix as equivalent to S-300

Positions:

Adds I-300 to the CRWB/FIRB/HEQM positions to maintain consistency with the other single resource boss positions

Adds S-215 to STEN. S-215 was added to ENGB but was left out from the requirements for STEN. This has the potential of having ENGB's who were qualified prior to 1/1/2014 not to have taken S-215 when applying for STEN.

Revises the note at the bottom of each Strike Team Leader Position in the 2014 CICCS Qualifications Guide. The note has been amended to read:

Upon qualification in the prerequisite Single Resource Boss position, the specific Strike team Leader PTB may be initiated. Once qualified as a Strike Team leader, any additional Single resource Boss qualifications will also qualify the individual in the corresponding Strike Team Leader position once agency certification is documented on the PTB Verification/Certification page and permission of the Operational Area Peer Review Committee is granted.

REQUIRED EXPERIENCE

Qualified as an Aircraft Base Radio Operator (**ABRO**)

Incident Dispatcher (**INDI**)

Radio Operator (**RADO**)

HERO should read:

Qualified as HECM

Successful performance as a HERO

HLCO should read:

REQUIRED EXPERIENCE

Qualified as a Task Force Leader (TFLD)

+

Successful position performance as Helicopter Coordinator (HLCO)

OR

Qualified as one Strike Team Leader position (STCR, STEN, STEQ, STCR)

+

Successful position performance as Helicopter Coordinator (HLCO)

LSC2 adds an additional option:

OR

Qualified as a Facilities Unit Leader

+

Qualified as a Ground Support Unit Leader

+

Successful Performance as a Logistics Section Chief Type 2 (LSC2)

LSC2 additionally should read:

Qualified as a Supply Unit Leader (SPUL)

+

Qualified as a Facilities Unit Leader (FACL)

+

Successful position performance as a Logistics Section Chief Type 2 (LSC2)

OR

Qualified as a Type 3 Logistics Section Chief 3 (LSC3)

+

Successful position performance as a Logistics Section Chief Type 2 (LSC2)

OPBD should read:

REQUIRED EXPERIENCE

Qualified as a Division/Group Supervisor (**DIVS**)

+

Successful performance as a Branch Director

RXM1 should read:

REQUIRED EXPERIENCE

Qualified as a Prescribed Fire Burn Boss Type 1 (**RXB1**)

+

Successful position performance as a Prescribed Fire Manager Type 1 (**RXM1**) on a Prescribed Fire Incident

RXM2 should read:

REQUIRED EXPERIENCE

Qualified as a Prescribed Fire Burn Boss Type 2(**RXB2**)

+

Successful position performance as a Prescribed Fire Manager Type 2 (**RXM2**) on a Prescribed Fire Incident

RXB1 should read:

REQUIRED EXPERIENCE

Qualified as a Prescribed Fire Burn Boss Type 2 (**RXB2**)

+

Successful position performance as a Prescribed Fire Burn Boss Type 1 (**RXB1**) on a prescribed fire incident

RXB2 should read:

Qualified as a Firing Boss, Single Resource (**FIRB**)

+

Qualified as an Incident Commander Type 4 (**ICT4**)

+

Successful position performance as a Prescribed Fire Burn Boss Type 2 (**RXB2**) on a prescribed fire incident

TOLC should read:

REQUIRED EXPERIENCE

Qualified as a Helicopter Crewmember (**HECM**)

+

Successful position performance as a Takeoff and Landing Coordinator (**TOLC**)
