# Update to FIRESCOPE ICS-SF-SAR 020-1: SWIFTWATER/FLOOD SEARCH AND RESCUE RECOMMENDED TRAINING, SKILLS, AND EQUIPMENT LIST

The FIRESCOPE Board of Directors (through the FIRESCOPE Operations Team/Task Force/Technical Rescue Specialist Group) has approved recommendations from the Cal OES-coordinated Swiftwater/Flood Search and Rescue Work Group, which worked for more than two years in collaboration with subject matter experts, California Fire Service stakeholders and leadership, State Fire Training, and other stakeholders to update the following document: FIRESCOPE ICS-SF-SAR 020-1 (Swiftwater/Flood Search and Rescue Recommended Training, Skills, and Equipment List).

## **Background:**

The original FIRESCOPE ICS-SF-SAR 020-01 (Swiftwater/Flood Search and Rescue) guidelines were published in 2001, prior to establishment of the following currently recognized standards: The National Incident Management System (NIMS), National Fire Protection Association's (NFPA) Standard 1670: Standard on Operations and Training for Technical Search and Rescue and NFPA 1006: Standard for Technical Rescue Personnel Professional Qualifications.

### **Action:**

The FIRESCOPE Board of Directors has approved the following updates to FIRESCOPE ICS-SF-SAR 020-01, Swiftwater/Flood Search and Rescue Recommended Training, Skills, and Equipment List:

#### Increased Staffing for Type I Swiftwater Rescue Teams:

Increase in Type I Swiftwater/Flood Search & Rescue Team staffing from 14 to 16 members, consistent with NIMS typing).

## Swiftwater/Flood Search and Rescue Team Vessel Staffing:

Required: 2 qualified Swiftwater/Flood Search and Rescue Boat Operators per Vessel.

Complete the following training and certifications:

- California State Fire Training, Firefighter I or equivalent
- California State Fire Training, Rope Rescue Operations
- California State Fire Training, Rope Rescue Technician
- California State Fire Training, Confined Space Rescue Technician
- California State Fire Training, Structural Collapse Specialist 1\*
- California State Fire Training, Structural Collapse Specialist 2\*
- California State Fire Training, Trench Rescue Technician
- California State Fire Training, Auto extrication
- California State Fire Training, River Flood Rescue Technician
- Helicopter Awareness Training
- GPS, Data collection awareness and training
- Current Certification Emergency Technician or equivalent

Required: Satisfactory performance as a SFT Firefighter I or equivalent.

Complete the following training and certifications:

- Helicopter Awareness Trainina

#### **Refresher Training:**

- Required Annual Swim Evaluation: 500yd in 19 minutes per or International Association Dive and Rescue Specialist (IADRS) Watermanship evaluation per NFPA 1006.
- Required Annual Refresher, of related rescue skills and abilities in water per NFPA 1006.
- Required every three years, refresher of rescue skills in moving water per NFPA 1006.

### Swiftwater/Flood Search & Rescue Team/Program Evaluation:

- Every 5 years, Evaluation
- Evaluation of staffing and requirements for staffing
- Evaluation of Training records
- Evaluation of required equipment

### **Equivalencies:**

NFPA 1670 (standards on operations and training for technical search and rescue incidents). NFPA 1006 (standard for technical rescue personnel professional qualifications, from which the JPR's originate).

#### **Qualifications Equivalencies:**

To assist personnel and agencies to develop and maintain compliance with the updated Swiftwater/Flood S&R Team qualifications, following is a list of equivalencies that consider the pertinent California State Fire Training Job Performance Requirements (JPR's) and equivalent training options.

1. The California State Fire Training Rescue Systems 1, Rescue Systems 2, and Rescue Systems 3 courses, combined, meet equivalency for the requirements of FEMA US&R Structural Collapse Technician or California US&R Structure Collapse Specialist 1 and 2 courses. Rescue Systems 1 has been sunset, with Rescue Systems 2, and Rescue Systems 3 courses sunsetting in 2023.
