PROGRAM SYNOPSIS

Program Description:

The purpose of the BW Program is to be a resource to the domestic violence victim service field by providing technical assistance, informational resources, and networking opportunities to domestic violence service providers in California.

The California Partnership to End Domestic Violence (the Partnership) is the only eligible Applicant.

D. ELIGIBILITY

The California Partnership to End Domestic Violence (the Partnership) is the only eligible Applicant.

Applicants applying for federal funds must be registered in the federal System for Award Management (SAM) and have an expiration date that is at least eight weeks after the Application due date. [Check SAM status.](#)

Applicants that are community-based organizations must be registered with the California Department of Justice's Registry of Charitable Trusts with a "current" or "pending" status. [Check nonprofit status.](#)

E. GRANT SUBAWARD PERFORMANCE PERIOD

The Grant Subaward performance period is July 1, 2020 – June 30, 2021.

F. FUNDS

Approximately \$650,000 is available for the Program for the Grant Subaward performance period. **Funding is contingent upon availability of funds and passage of the 2020-21 State Budget Act.**

1. Source of Funds

Detailed information on all VS Branch federal fund sources can be found in the [VS Branch Federal Fund Information Guide](#). Applicants are **strongly encouraged** to review this document to familiarize themselves with the requirements for all fund sources that support this Program.

The Program is supported through the following funds:

- a. Victims of Crime Act (VOCA) Victim Assistance Formula Grant Program (Formula Grant Program)
 - Supports eligible crime victim assistance programs.
 - Requires a cash and/or in-kind match equal to 20 percent of the total project cost. Applicants may request a match waiver of the required match amount. **To request a match waiver, Applicants must submit the VOCA Victim Assistance Formula Grant Program Match Waiver Request form (Attachment A) to the applicable Program Specialist, by**

email, by May, 29, 2020. The VOCA Victim Assistance Formula Grant Program Award Number can be obtained from your Program Specialist or left blank. All other sections of the form must be complete. Answers to questions 9-11 must be specific and unique to the Applicant.

- Cal OES's four-character code for this federal fund is VOCA. This code will be in the drop-down on the Grant Subaward Face Sheet (Cal OES 2-101).
- The federal award number is unknown at the time of release of this RFA. Contact your Program Specialist if you need this information.

b. Family Violence Prevention and Services/Domestic Violence Shelter and Services Grant Program

G. PROGRAM INFORMATION

1. Program Description

The purpose of the BW Program is to be a resource to the domestic violence victim service field by providing technical assistance, informational resources, and networking opportunities to domestic violence service providers in California. This includes an annual conference for the domestic violence field.

2. Program Components

a. Statewide Technical Assistance

- The Subrecipient must provide statewide technical assistance to Domestic Violence Assistance (DV) Program Subrecipients, service providers, and clients through Technical Assistance Training (TAT) requests, including e-mail and telephone requests. Technical assistance will be provided to assist agencies with issues concerning cultural diversity, client confidentiality requirements, systems advocacy, program and policy development, shelter service standards, trauma-informed services, immigration, legal information, outreach to underserved communities, employment for survivors/domestic violence victims, and/or economic development.
- As requested by Cal OES, the Subrecipient must provide technical assistance to specific Cal OES Subrecipients. These Subrecipients will be selected by Cal OES based upon the level of difficulty they are experiencing in meeting their programmatic goals and objectives, developing the 40-hour domestic violence training, improving fund development, or who are otherwise identified as failing to meet Cal OES grant requirements.
- The Subrecipient must develop and document a manageable action plan with each agency that requires on-site technical assistance. A copy of each action plan must be kept on file at the Partnership and reviewed with the agency to ensure resolution to the issue. The results of action plans will be reported to Cal OES in the quarterly Progress Reports. Data reported to Cal OES does not need to include

information identifying the specific agency receiving technical assistance.

- b. Statewide Domestic Violence Conference and Travel Stipends
 - The Subrecipient may support costs associated with a statewide domestic violence conference.
 - If the Subrecipient supports costs of the conference, advertisement for the conference must acknowledge the support from, and collaboration with, Cal OES.
 - The Subrecipient may also use the grant funds to provide travel stipends for domestic violence service providers to attend the conference.
- c. Meet with Cal OES and the Domestic Violence Advisory Council (DVAC)
 - The Subrecipient must attend meetings with Cal OES as needed in order to discuss progress made in meeting grant-related requirements and critical issues related to the domestic violence field.
 - A representative for the Subrecipient will attend all DVAC meetings to serve as a resource.
- d. Model Web-Based Training Curriculum
 - The Subrecipient will be responsible for maintaining, updating and/or expanding upon the Model Web-Based Training Curriculum related to the Domestic Violence Counselor 40-Hour Training, developed during the 2011-12 Grant Subaward performance period. Updates to this curriculum should be made as necessary in order to keep the curriculum information current and relevant.
 - Expansion of the curriculum should focus on the development of additional specialized components to supplement and/or complement the existing components. Priority in the development of expanded components should focus on

areas where need has been identified within the domestic violence field.

e. Resources for Voluntary Participation in Services (VPS)

- The Subrecipient will be responsible for maintaining resources and educational materials for distribution related to VPS. The Subrecipient must promote the availability of materials to agencies needing VPS assistance.
- As requested by Cal OES, the Subrecipient will provide technical assistance to specific Cal OES-selected Subrecipients. These Subrecipients will be selected by Cal OES based upon the level of difficulty they are experiencing in meeting the VPS policy.

3. Regional Training

The VS Branch will be holding regional grants management trainings during the Grant Subaward performance period. Anticipated locations include: Sacramento, Redding, San Jose, Los Angeles, and San Diego. Although attendance is not mandatory, it is strongly encouraged. Interested Subrecipients should budget for two staff members to attend the two-day training.

4. Reporting Requirements

Progress Reports serve as a record for the implementation of the project. Statistics for Progress Reports must be collected on a quarterly basis, even when reporting occurs less frequently. The following reports are required:

a. Cal OES Progress Reports

There are two Cal OES Progress Reports required for the Program. See the chart for report periods and due dates.

b. Office for Victims of Crime (OVC) Reports

There are two, on-line OVC reports Subrecipients will also need to complete:

1) Subgrant Award Report (SAR)

This on-line report is due **within 90 days of the beginning of the performance period**. Cal OES will initiate access and the Subrecipient must complete the remainder of the report in the OVC Performance Measurement Tool.

2) Subgrantee Report

The Subrecipient must complete this report no later than two weeks following the end of each federal fiscal year quarter. Subrecipients will report data directly into the OVC PMT database no later than the due dates listed, unless otherwise instructed by your Program Specialist.

A. SUBRECIPIENT HANDBOOK

Applicants are strongly encouraged to review the [Subrecipient Handbook \(SRH\)](#). The SRH outlines the terms and conditions that apply to the Cal OES, VS Branch grants and provides helpful information for developing an application, including a Glossary of Terms.

B. FORMS

The Applicant must use the forms provided on our website. The forms must be printed on plain white 8½" x 11" paper and single sided. **Applicants may not alter the formatting of any forms, including the Project and Budget Narratives. No tables, charts, or changes to the margins are allowed.**

C. APPLICATION COMPONENTS

Applicants must complete and submit all required components. Specific information for each component is included next. The Checklist in Part III is included to ensure Applicants submit all required components.

1. Grant Subaward Face Sheet (Cal OES 2-101)

The Grant Subaward Face Sheet is the title page of the Grant Subaward that is signed by the Subrecipient and the Cal OES Director (or designee). Instructions are included on the form.

2. Project Contact Information (Cal OES 2-102)

The Project Contact Information form provides Cal OES with all relevant Subrecipient personnel. Information for each individual should be direct contact information. Instructions are included on the form.

3. Signature Authorization (Cal OES 2-103)

The Signature Authorization form provides Cal OES with signatures of authorized signers and who they authorize to sign on their behalf for all grant-related matters. Instructions are included on the form.

4. Certification of Assurance of Compliance (Cal OES 2-104m)

Cal OES is required by law to obtain written certifications of compliance. The Certification of Assurance of Compliance form is a binding affirmation that the Subrecipient will comply with the following regulations and restrictions:

- State and federal civil rights laws
- Drug Free Workplace
- California Environmental Quality Act
- Federal grant fund requirements
- Lobbying restrictions
- Debarment and Suspension requirements
- Proof of Authority documentation from the city council/governing board

Subrecipients may be asked to sign and submit an updated Certification of Assurance of Compliance once in Grant Subaward. Each year, Cal OES updates each Certification of Assurance of Compliance to ensure that any new conditions placed upon the federal award are passed down to Subrecipients. Subrecipients will be notified if this change is needed.

5. Budget Pages (Cal OES 2-106a)

The Budget demonstrates how the Applicant will implement the proposed plan with the funds available through this Program. The budget is the basis for management, fiscal review, and audit. **Budgets are subject to Cal OES modifications and approval.** Failure of the Applicant to include required budget items does not eliminate responsibility to comply with those requirements during the implementation of the project.

The Budget Pages automatically calculate the subtotal at the end of each budget category and provide the total of the three

spreadsheets at the bottom of the Equipment page. Applicants may add additional columns to the Budget Pages when necessary.

Cal OES requires the Applicant to develop a line-item budget that includes a **calculation and justification in the left column for all expenses.**

The Budget Pages should:

- Cover the entire Grant Subaward performance period
- Include costs related to the objectives and activities of the project
- Strictly adhere to required and prohibited expenses
- Include expenses in the correct category (i.e., Personal Services, Operating Expenses, and Equipment – see below)

Include **only** those items covered by grant funds, including match funds, when applicable. Applicants may supplement grant funds with funds from other sources. However, since approved line items are subject to audit, Applicants should not include in the Project Budget matching funds (if applicable) in excess of the required match.

a. Personal Services – Salaries/Employee Benefits

1) Salaries

Personal services include services performed by project staff **directly employed by the Applicant** (not a contract or participating agency) and must be identified by position, cost and time spent on allowable activities for the Program (e.g., Clerical Staff @ \$20/hour x 980 hours; or Victim Advocate @ \$3,500/month x 12 months x .50 FTE). They may be salaried or hourly, full-time or part-time positions. Sick leave, vacation, holidays, overtime, and shift differentials must also be budgeted as a part of salaries. If the Applicant's personnel have accrued sick leave or vacation time prior to the approval of grant funding, they may not take time off using project funds.

2) Benefits

Employee benefits must be identified by type and percentage of salaries. The Applicant may use fixed percentages of salaries to calculate benefits. Budgeted

benefits cannot exceed those already established by the Applicant.

Employer contributions or expenses for social security, employee life and health insurance plans, unemployment insurance, and/or pension plans are allowable budget items. Benefits, such as uniforms or California Bar Association dues are allowable budget items if negotiated as a part of an employee benefit package.

A line item is required for each different position/classification, but not for each individual employee. If several people will be employed full-time or part-time in the same position/classification, provide the number of full-time equivalents (e.g., three half-time clerical personnel should be itemized as 1.5 clerical positions).

b. Operating Expenses

Operating Expenses are defined as necessary expenditures other than personal salaries, benefits, and equipment. The expenses must be grant-related (i.e., to further the Program objectives as defined in the Grant Subaward) and be encumbered during the Grant Subaward performance period.

Examples of an Operating Expense line item include, but are not limited to:

- Consultant services such as subcontractors
- Indirect cost allowance
- Salaries of participating staff who are not employed by the Applicant
- Travel
- Office supplies
- Training materials
- Equipment maintenance
- Software equipment rental/lease
- Telephone, postage
- Printing
- Facility rental
- Vehicle maintenance

- Furniture and office equipment with a cost of less than \$5,000 (excluding tax) and/or with a useful life of less than one year.

Salaries for staff not directly employed by the Applicant must be shown as consultant and/or participating staff costs and must be supported with a Second Tier Subaward, which must be kept on file and made available for review during audits or at the request of Cal OES (SRH 3710 and 4300).

c. Equipment

Equipment is defined as nonexpendable tangible personal property having a useful life of more than one year and a cost of \$5,000 or more per unit (excluding tax).

A line item is required for different types of equipment, but not for each specific piece of equipment (e.g., three laser jet printers must be one line item, not three).

6. Budget Narrative (Cal OES 2-107)

The Budget Narrative should describe the following:

- a. How the Applicant's proposed budget supports the objectives and activities.
- b. How funds are allocated to minimize administrative costs and support direct services.
- c. How shared costs are allocated.
- d. How project-funded staff duties and time commitments support the proposed objectives and activities.
- e. The necessity for subcontracts and unusual expenditures.
- f. Need for mid-year salary range adjustments.

7. Project Narrative (Cal OES 2-108)

The Project Narrative is the main body of information describing the problem to be addressed, the plan to address the identified problem

through appropriate and achievable objectives and activities, and the ability of the Applicant to implement the proposed plan.

a. Problem Statement

In narrative form, address the following:

- The areas of need for training for domestic violence service providers
- The areas of need for technical assistance for domestic violence service

b. Plan

Provide a description of the Applicant's plan to accomplish the Program Components identified in Part I, Section G, of this RFA. Provide a timeline for meeting each component.

8. Subrecipient Grants Management Assessment

Per title 2 CFR § 200.331, Cal OES is required to evaluate the risk of noncompliance with federal statutes, regulations, and grant terms and conditions posed by each Subrecipient of pass-through funding. The assessment is made in order to determine and provide an appropriate level of technical assistance, training, and grant oversight to Subrecipients. Instructions are included on the form.

9. Project Service Area Information (Cal OES 2-154)

The Project Service Area Information form identifies the counties, cities, and congressional districts served by the project. Instructions are included on the form.

10. Organizational Chart

The Organizational Chart should clearly depict the structure of the Applicant organization and the specific unit within the organization responsible for the implementation of the project. This chart should also depict supporting units within the organization (e.g., the Accounting Unit) and the lines of authority within the organization. Job titles on the Organizational Chart must match those in the Budget Pages and Budget Narrative.

11. Additional Forms/Documents

The following are required only if applicable:

- VOCA Victim Assistance Formula Grant Program Match Waiver Request

This form is required only if the Applicant is requesting to waive a portion or all of the VOCA Formula Grant Program required Match.

- Non-Competitive Bid Request Checklist (Cal OES 2-156)

This form is required only if the Applicant proposes a line item in their Budget that meets the criteria for a Non-Competitive Bid Request per *SRH 3511*. Instructions are included on the form.

- Contractor/Consultant Rate Exemption Request (Cal OES 2-164)

This form is required only if the Applicant is requesting an exemption to the maximum rate for an independent contractor/consultant of \$650 per eight-hour day or \$81.25 per hour per *SRH 3710.1*. Instructions are included on the form.

- Out-of-State Travel Request (Cal OES 2-158)

This form is required only if the Applicant proposes a line item for out-of-state travel per *SRH 2236.11*. Instructions are included on the form.
