**Subject:** Fiscal Year (FY) 2017 California State Nonprofit Security Grant Program (CSNSGP) Application Workshops

---

Cal OES Grants Management is soliciting proposals for the California State Nonprofit Security Grant Program (CSNSGP) for FY 2017.

The purpose of the CSNSGP is to provide funding support for target hardening and other physical security enhancements to nonprofit organizations that are at high risk of a terrorist attack. It closely models the federal DHS/FEMA Nonprofit Security Grant Program (NSGP) and complements the NSGP's efforts to build and sustain the National Preparedness Goals and Capabilities across prevention, protection, response and recovery mission areas.

Organizations eligible to submit CSNSGP Investment Justification (IJ) applications are described under Section 501(c)(3) of the Internal Revenue Code of 1986 (IRC) and exempt from tax under Section 501(a) of such code. They must be located within the State of California, and considered to be at high risk of terrorist attack due to their ideology, beliefs, or mission.

Approximately \$2 million in CSNSGP funds were allocated by the California State Legislature and approved by the Governor in 2017. Applicants may apply for up to \$75,000 in funding. Cal OES rates and ranks the proposals competitively. The highest ranking Applicants will receive funding until all the allocated funding is awarded.

Applicants should attend a CSNSGP application workshop or webinar to learn how to successfully complete and submit the IJ application. The due date for submission is: 05:00 p.m., Monday, January 8, 2018. All applications must be emailed to [Nonprofit.SecurityGrant@caloes.ca.gov](mailto:Nonprofit.SecurityGrant@caloes.ca.gov). No late submissions will be considered.
