Subject:	CSNSGP Award Announcement and Required Documents Workshops

Cal OES is pleased to announce that California has awarded \$2,000,000 in FY 2017 CSNSGP funding which will go to the 28 California nonprofit organizations.

It is mandatory and a requirement of accepting the award funds that a representative from each organization that will be working with Cal OES to complete these documents must attend one of the required documents workshops. Additional staff and grant administrators may also attend.

Workshop Agenda

Cal OES is conducting Required Documents Workshops throughout the State to assist awardees through the application process. To obtain funding, Subrecipients must submit the required application documents listed below by COB **April 30, 2018.**

The workshops, lasting approximately two to three hours, will feature a presentation explaining the Subrecipient's grant management responsibilities and will conclude with a question and answer period. Attendees will learn how to complete and submit the following documents:

- <u>The FY 2017 Financial Management Forms Workbook (FMFW)</u>: An Excel workbook which includes the initial application documents and subsequent transaction worksheets.
- <u>Governing Body Resolution</u>: A document from the nonprofit's governing board (Board of Trustees/Directors) indicating acceptance of the award and agreement to abide by the terms of the grant. The board resolution will also name the individual(s), called Authorized Agent(s), who will be authorized to sign the grant documents.
- <u>Grant Assurances</u>: This is the basic grant agreement that contains the terms and conditions for use of the funds as specified in federal and state rules and regulations. These are the terms and conditions agreed to in the Resolution.

- <u>Internal Revenue Service (IRS) 501(c)(3)</u> Determination Letter or Self-Declaration <u>Letter on Letterhead</u>: This letter is proof that the organization meets the federal taxexempt status that was a prerequisite to apply for, and to receive this award.
- <u>Payee Data Record Form STD 204</u>: This document is used to apply for the unique organization number needed to receive grant funds.
- <u>Subrecipient Grants Management Assessment Form</u>: Per Title 2 CFR § 200.331, Cal OES is required to evaluate the risk of noncompliance with federal statutes, regulations and grant terms, and conditions posed by each Subrecipient of pass-through funding. This assessment is made to determine and provide an appropriate level of technical assistance, training, and grant oversight to Subrecipients for the award referenced above.
- <u>California Environmental Quality Act (CEQA) Negative Declaration</u>: According to CEQA Statutes Section 21064, a Negative Declaration is a "written statement briefly describing the reasons that a project will not have a significant effect on the environment and does not require the preparation of an environmental impact report."
