

# Fiscal Year (FY) 2017 Nonprofit Security Grant Program (NSGP) Frequently Asked Questions (FAQs)

#### 1. What is the purpose of the FY 2017 NSGP?

The FY 2017 NSGP provides funding support for target hardening and other physical security enhancements to nonprofit organizations that are at high risk of terrorist attack and located within one of the specific FY 2017 Urban Area Security Initiative (UASI)-designated urban areas. The NSGP also promotes emergency preparedness coordination and collaboration activities between public and private community representatives as well as state and local government agencies.

The FY 2017 NSGP plays an important role in the implementation of the National Preparedness System by supporting the development and sustainment of core capabilities. The core capabilities, outlined in the National Preparedness Goal (the Goal) are essential for the execution of the five mission areas—Prevention, Protection, Mitigation, Response, and Recovery mission areas and the realization of a secure and resilient Nation.

### 2. What legislation authorized funding for the FY 2017 NSGP?

The FY 2017 NSGP is authorized by Section 2003 of the *Homeland Security Act of 2002*, as amended (Pub. L. No. 107-296) (6 U.S.C. § 604); and by the *Department of Homeland Security Appropriations Act, 2017* (Pub. L. No. 115-31).

#### 3. How much funding is available under the FY 2017 NSGP?

The total amount of funds distributed under the FY 2017 NSGP will be \$25,000,000. Each nonprofit organization must apply through its State Administrative Agency (SAA) for up to a \$75,000 grant award. The FY 2017 NSGP funds will be allocated to high-risk nonprofit organizations, as described under section 501(c)(3) of the Internal Revenue Code of 1986, Title 26 of the U.S.C., and exempt from tax under section 501(a) of such Code.

#### 4. What are the changes in funding levels between FY 2016 and FY 2017?

The FY 2017 NSGP funding level is twenty-five percent (25%) higher than the FY 2016 NSGP level. In FY 2016 \$20,000,000 of NSGP funding was distributed and \$25,000,000 will be distributed in FY 2017.

## 6. Who is eligible to apply for FY 2017 NSGP funds?

The SAA is the only entity eligible to apply for FY 2017 NSGP funds on behalf of eligible nonprofit organizations which have been determined to be at high risk of terrorist attack. Eligible nonprofit organizations are those organizations described under section 501(c)(3) of the Internal Revenue Code of 1986, Title 26 of the U.S.C., and exempt from tax under section 501(a) of such Code. Eligible nonprofits must be located within one of the FY 2017 UASI-designated Urban Areas, listed in Appendix A of the FY 2017 NSGP Notice of Funding Opportunity (NOFO).

Nonprofit organizations must apply to their SAA; non-profit organizations **may not** apply directly to the Federal Emergency Management Agency (FEMA) for FY 2017 NSGP funds.

#### 7. How will the FY 2017 NSGP applications be submitted?

Applying for an award under the NSGP is a multi-step process:

Eligible applicants must submit their initial application through the grants.gov portal at <a href="http://www.grants.gov">http://www.grants.gov</a>. Applicants in need of grants.gov support should contact the grants.gov customer support hotline at (800) 518-4726.

Eligible applicants will be notified by FEMA and asked to proceed with submitting their complete application package in the Non Disaster (ND) Grants System. Applicants in need of technical support with the ND Grants System should contact ndgrants@fema.gov or (800) 865-4076.

Completed applications must be submitted no later than 5:00 p.m. EDT, June 22, 2017.

#### 8. What are the key dates associated with the FY 2017 NSGP?

- June 2, 2017: Release date for FY 2017 NSGP NOFO
- June 22, 2017, 5:00pm EDT: Applications for FY 2017 NSGP are due to FEMA

#### 9. How will the FY 2017 NSGP Program funds be allocated?

FY 2017 NSGP applications will be reviewed through a two-phased process that includes a state and federal review for completeness, adherence to programmatic guidelines, feasibility, and how well the Investment Justification (IJ) (project description and justification) addresses the identified risk. # 10. What is the FY 2017 NSGP period of performance?

The period of performance is thirty-six (36) months.
