The California Governor's Office of Emergency Services (Cal OES), Grants Management, is pleased to announce the FY 2019 NSGP Required Documents Workshops.

Cal OES received the FY 2019 NSGP award from the U.S. Department of Homeland Security in the amount of \$12,217,530. Of the \$12,217,530, \$11,842,530 is awarded to the NSGP-Urban Area, and \$375,000 is awarded to the NSGP-State. The <u>FY 2019 NSGP Award Allocations</u> are available on the Cal OES website.

To ensure funds are spent pursuant to the intent of the grant, Cal OES will conduct workshops to relay programmatic requirements for the FY 2019 NSGP. The workshops will cover topics such as new requirements for FY 2019, how to avoid common mistakes, instruction on the required documents submission process, and procurement technical assistance. A representative from each nonprofit organization <u>must</u> attend this workshop. A lack of attendance may lead to an increased risk of noncompliance with grant requirements.
