

## GRANT MANAGEMENT MEMORANDUM GMM 2025-08

**Subject:** Fiscal Year (FY) 2025 HSGP Application Updates, Guidance, and

Allocations

On August 8, 2025, Cal OES released <u>GMM 2025-06</u> with FY 2025 HSGP allocations and program updates. This memo provides additional guidance to help facilitate the submission of required project-level details for DHS/FEMA review as part of our FY 2025 HSGP application process.

The FY 2025 HSGP National Priority Areas (NPAs) and required minimum spends are as follows:

NPA	Minimum Spend Requirement
*NEW – Supporting Border Crisis Response and Enforcement	10% minimum spend
*NEW – Supporting Homeland Security Task Forces and Fusion Centers	No minimum spend
Enhancing the Protection of Soft Targets/Crowded Places	No minimum spend (no change)
Enhancing Cybersecurity	No minimum spend (no change)
Enhancing Election Security	3% minimum spend (no change)
<b>Removed</b> – Enhancing Information and Intelligence Sharing	-
Removed – Enhancing Community Preparedness and Resilience	-
<b>Removed</b> – Combating Domestic Violence Extremism	-

Subrecipients must allocate a minimum of 30% of funding across the five NPAs.

Enhancing Election Security and Supporting Border Crisis Response and Enforcement are the only national priorities with minimum spends totaling 13%. Subrecipients will have the flexibility to allocate the remaining 17% across the remaining priorities.

The updated Investment Justifications (IJ)s and numbering are as follows:

- IJ (1) Supporting Homeland Security Task Forces and Fusion Centers
- IJ (2) Enhance the Protection of Soft Targets/Crowded Places
- IJ (3) Enhance Cybersecurity
- IJ (4) Supporting Border Crisis Response and Enforcement
- IJ (5) Strengthen Emergency Communications Capabilities Through Planning, Governance, Technology, And Equipment
- IJ (6) Enhance Medical and Public Health Preparedness
- IJ (7) Strengthen Information Sharing and Collaboration
- IJ (8) Enhance Multi-Jurisdictional/Inter-Jurisdictional All- Hazards/Whole Community Incident Planning, Response & Recovery Capabilities
- IJ (9) Protect Critical Infrastructure and Key Resources (including Food & Agriculture)
- IJ (10) Enhance Election Security

The minimum spend requirement for Law Enforcement Terrorism Prevention Activities (LETPA) will remain at 35% of the award. For an activity to be classified as LETPA, it must have both a law enforcement and terrorism prevention nexus. Information Bulletin (IB) 485 includes the most up-to-date information on project selection considerations and allowable activities for LETPA investments.

Management and administration costs for FY 2025 should be captured under Investment Justification #6. All emergency communications projects must comply with the SAFECOM Guidance and must be captured under Investment Justification #5. The project description should contain the SCIP goal and "emergency communications" in the project description.

As you develop your projects you may reference the example project types listed in the latest copy of the <u>FY 2025 HSGP NOFO</u> released on August 1, 2025. You may also reach out to your assigned Grants Analyst for any questions related to project development.

The deadline to submit revised FY 2025 projects with final allocations to your HSGP Grants Analyst is **Tuesday, September 16, 2025**. This timeline allows Cal OES sufficient time for our internal review and project entry into FEMA's new grants management system, FEMA GO. To meet the grant requirements for an award under HSGP, the State must pass at least 80% of funding to local or tribal governments. By submitting our required project-level details in advance, we

can submit our projects to DHS/FEMA for review before receiving our award, thus avoiding unnecessary delays in receiving HSGP funding.

California and 19 other states filed a lawsuit challenging the lawfulness of the civil immigration terms and conditions set forth in DHS Standard Terms and Conditions and seeking to prohibit their enforcement (See State of Illinois et al. v. Federal Emergency Management Agency, et al. (D. R.I., No. 1:25-cv-206-WES-PAS). The parties are currently awaiting a decision from the court as to the lawfulness of these provisions. Once the court issues its decision, Cal OES will update its FAQs.

In submitting the FY 25 HSGP application, Cal OES also submitted a reservation of rights (RoR) letter which provided that submission of the FY 25 HSGP application should not be construed as agreement to the disputed conditions, certification of compliance with the disputed conditions or as a waiver of any rights by Cal OES or the State of California, including the civil immigration terms and conditions.

The RoR letter also addressed the Election Security NPA portion of the FY 25 HSGP NOFO, which "integrat[es] the directives of Executive Order 14248", which is the subject of ongoing litigation, including in *State of California*, et al. v. Donald J. Trump, et al. (D. Mass., No. 1:25-cv-10810-DJC). The RoR rights letter stated that the application should not be construed as an agreement to the Election Security NPA conditions or as a waiver of any rights or arguments by Cal OES or the State of California concerning the election-related conditions In light of the above-referenced reservation of rights, subrecipients are encouraged to submit their applications.

There have been no changes to the allocations provided in the chart from the GMM sent out on August 8, 2025. The allocations are provided in this document as well for reference.
