Subject: Fiscal Year (FY) 2026 Counter-Unmanned Aircraft Systems (C-UAS)

Grant Program Application Webinar

The Department of Homeland Security (DHS)/Federal Emergency Management Agency (FEMA) announced the FY 2026 C-UAS Grant Program under the authority of the One Big Beautiful Bill Act of 2025. This program provides a total of \$500 million in funding over two Fiscal Years to support state, local, tribal and territorial governments combatting the unlawful use of unmanned aircraft systems that threaten the safety and security of the American people, communities, and institutions.

For FY 2026 - DHS/FEMA has prioritized \$250 million in funding to states that are directly or indirectly hosting FIFA World Cup 2026 events and the National Capital Region, which is hosting America 250 national events. California will receive a statutory minimum of \$3,325,000 in funding with an additional \$105,050,000 allocated competitively based on a Special Event Assessment Rating level of hosted events (representing risk), and the anticipated effectiveness of proposed projects.

The outstanding \$250 million will be distributed in FY 2027 to states and territories, with an expanded focus on building national detection and response capacity. Details regarding Fiscal Year 2027 will be determined and shared at a later date.

Eligibility for FY 2026 funding is limited to local, tribal, and territorial government entities located in California, including city and county agencies, law enforcement, fire services, emergency medical services, emergency management, and other qualifying public safety organizations.

All agencies and personnel operating counter-unmanned aircraft systems mitigation technologies purchased or supported with C-UAS Grant Program funds must:

 Have the Department of Justice acting through the Federal Bureau of Investigation (FBI), deputize state, local, tribal, and territorial law enforcement or correctional facility officers in the FBI Joint Terrorism Task Forces.  Have personnel trained at or scheduled to be trained at the FBI's National Counter-Unmanned Aircraft Systems Training Center.

In preparation for the FY 2026 C-UAS Grant Program application submission, Cal OES will be conducting webinars to explain the requirements and application process.
