AA	Sexual Assault American Rescue Plan Technical Assistance	Provides funding for training, information, and technical assistance to ensure the continuity of sexual assault service providers and rape crisis centers, including culturally specific organizations, during the COVID-19 public health emergency.
AC	Child Abduction Training Program	Provides funding for statewide training to multidisciplinary professionals. The training is facilitated by members of the Child Abduction Task Force and provides tools and resources for responding to a child abduction.
AP	California Advancing the Prison Rape Elimination Act Program	Provides funding to enhance and increase services for victims/survivors of sexual assault in state correctional facilities. The Program allows for the Subrecipients to work with the California Department of Corrections and Rehabilitation (CDCR) to renew/secure formal partnerships between all CDCR facilities and local rape crisis centers.
AR	Sexual Assault American Rescue Plan	Provides funding to help rape crisis centers and sexual assault programs continue adapting to meet the emergency needs of sexual assault survivors in response to the COVID-19 public health emergency.
AT	Child Abuse Treatment Program	Provides funding for comprehensive therapeutic treatment services for child victims of abuse and/or neglect.
BW	State Coalition Technical Assistance & Training Program	Provides funding to the statewide domestic violence coalition to be a resource to the domestic violence victim service field by providing technical assistance, informational resources, and networking opportunities to the domestic violence service providers in California.
CA	Child Abuse Training and Technical Assistance Program	Provides funding for technical assistance and training to professionals that provide direct services to child victims - Northern California.
CC	Statewide Child Abuse Training and Technical Assistance Program	Provides funding for training, leadership, and resources to child abuse service providers in California.
CK	Postconviction DNA Testing Assistance Program	Provides funding to conduct post-conviction DNA testing in cases of murder, non-negligent manslaughter, forcible sexual assault, and all other violent felony offenses in which actual innocence might be demonstrated. Funds are geared toward the review of such postconviction cases and to locate and analyze biological evidence associated with these cases.
CQ	Paul Coverdell Forensic Science Improvement Program	Provides funding to acquire and maintain accreditation for crime labs, reduce backlogs, and improve the quality and timeliness of forensic science and medical examiner/coroner services.

CR	Crisis Response Training Program	Provides funding for the implementation of comprehensive crisis response training and technical assistance to local Victim Witness Centers and multi-disciplinary teams to establish response readiness to mass victimization crimes.
CS	Child Sexual Abuse Treatment Program	Provides funding for comprehensive treatment services to children under the age of 18 who are victims of sexual abuse and/or sexual exploitation.
CT	Campus Sexual Assault Program	Provides funding to maintain a comprehensive, coordinated, community response that is victim/survivor-centered, enhance victim/survivor safety (whether or not they report the crime to law enforcement or other investigatory bodies and whether or not they choose to participate in an investigation), provide confidential services to sexual assault victims/survivors, hold offenders accountable, and include comprehensive outreach activities at institutions of higher education.
CW	Court Education and Training Program	Provides funding to develop and provide trainings, seminars, publications, symposiums, and other programs designed to increase the knowledge of court personnel in cases involving domestic violence, sexual assault, stalking, and teen dating violence. These trainings are offered to both state and tribal court judges and all judicial officers.
DS	Native American Domestic Violence and Sexual Assault Program	Provides funding to supportive services to Native American women and their children, who are victims/survivors of domestic violence and/or sexual assault. Supportive services may include shelter, counseling, court accompaniment, and advocacy.
DV	Domestic Violence Assistance Program	Provides funding for comprehensive support services to existing domestic violence providers throughout California, including emergency shelter to victims/survivors of domestic violence and their children.
EM	California Medical Training Center Program	Provides funding to ensure forensic examinations are conducted in a standard and consistent manner throughout California. This is accomplished through the development of standardized forms, protocols, and training for forensic medical examiners, law enforcement, prosecutors, and court personnel.
ES	Electronic Suspected Child Abuse Reporting System Program	Provides funding for an electronic Suspected Child Abuse Reporting System (SCAR) to improve the system of sharing information for suspected child abuse cases. The electronic SCAR (eSCAR) will be used by district attorney offices, local law enforcement, and county child welfare departments.

EX	Equality in Domestic Violence Prevention and Services Program	Provides funding to provide culturally appropriate domestic violence education, prevention, outreach, and services for the lesbian, gay, bisexual, transgender, intersex, queer, and asexual (LGBTIQA+) community that will improve access for this unserved/underserved community.
FA	Flexible Assistance for Survivors Pilot Program	Provides funding to improve safety, healing, and financial stability for victims/survivors of crime, and loved ones of those violently injured or killed, through the establishment of assistance funds to distribute in direct cash assistance.
FD	Intimate Partner Violence Prevention Program	Provides funding to prevent intimate partner violence, including teen dating violence, prioritize underserved populations within communities, and build the capacity of local organizations to do this work.
FE	Emerging Family Justice Center Program	Provides funding to support emerging Family Justice Centers (FJs) to meet the standards defined in California Penal Code § 13750.
FJ	Family Justice Center Program	Provides funding to established Family Justice Centers throughout the state to support and provide legal services to victims of domestic violence, intimate partner violence, sexual assault, child abuse, elder abuse, transnational abandonment, and human trafficking, and to help victims file petitions for protective orders, including domestic violence restraining orders and gun violence restraining orders.
FO	Domestic Violence Mobile Health Care Services	Provides funding to domestic violence victims/survivors and their children for access to COVID-19 testing, vaccines, and primary health care through weekly mobile health care visits. To ensure all areas of California are reached, Cal OES is utilizing a regional approach where one Subrecipient coordinates services for all domestic violence shelters and programs within the identified region.
FW	Farmworker Women's Sexual Assault and Domestic Violence Program	Provides funding for program activities aimed at addressing and combatting issues of sexual assault and domestic violence experienced by monolingual and bilingual Spanish-speaking and low-income farmworker women.
HA	Human Trafficking Advocate Program	Provides funding to Victim Witness Assistance Centers (Centers) so the Centers can hire or dedicate at least one half-time advocate who will provide comprehensive services to victims/survivors of human trafficking. Human Trafficking victims/survivors include sex and labor trafficking.

HV	Human Trafficking Victim Assistance Program	Provides funding to help human trafficking victims/survivors (sex trafficking and labor trafficking) recover from the trauma they experienced and assist them with reintegrating into society through comprehensive safety and supportive services using a trauma-informed, culturally sensitive, victim/survivor-centered approach.
HX	Homeless Youth and Exploitation Program	Provides funding to provide comprehensive services to help homeless youth exit street life, with a focus on providing specialized services for youth experiencing sexual exploitation.
HY	Homeless Youth Emergency Services Pilot Program	Provides funding to expand crisis intervention and stabilization services to homeless youth so that the immediate crisis these youth face can be resolved, and they can focus on their futures.
IC	Internet Crimes Against Children Program	Provides funding to better ensure local law enforcement agencies are adequately equipped to investigate computer crimes that target our youth; provide educational programs aimed at law enforcement officers, teachers, parents, and children; serve as a forensic resource to law enforcement agencies within each service area; pursue the prosecution of cases at the local, state, and federal level; and participate in nationally coordinated, investigative efforts.
KA	Victim Advocacy in Detention Facilities Program	Provides funding for rape crisis centers to increase access to appropriate services for victims/survivors of sexual assault in local detention facilities. Local detention facilities include adult detention facilities, juvenile detention facilities, and immigration detention facilities.
KC	Child Advocacy Center Program	Provides funding for Child Advocacy Centers to provide direct victim services to child abuse victims/survivors and their families through a multidisciplinary team approach. These services must include victim centered, trauma-informed forensic interviews, advocacy, direct or referral to therapy/counseling, and referrals for medical exams.
KE	Specialized Emergency Housing Program	Provides funding to emergency shelters for domestic violence victims, elderly victims, and homeless youth victims of crime in urban areas where statistics show high numbers of unmet requests for emergency shelter for these victim populations.
KI	Innovative Response to Marginalized Victims of Crime Program	Provides funding to implement new and unique methods to provide direct support services for victims/survivors of crime who are part of a marginalized population.

KR	California CASA Association Training and Recruitment Program	Provides funding to increase advocacy services to children in foster care by recruiting Court Appointed Special Advocate (CASA) volunteers statewide and by providing the required training to CASA volunteers.
KS	Court Appointed Special Advocates Program	Provides funding to Court Appointed Special Advocates (CASA) Programs in California to provide more children in foster care with a CASA volunteer who will advocate for the services and support needed by children who have experienced abuse and neglect.
KT	Native American Tribal Court Advocate Program	Provides funding to provide trauma-informed, culturally sensitive services to victims/survivors of crime and educate the greater tribal community on the process of the tribal court system.
LE	Law Enforcement Specialized Units Program	Provides funding to create or enhance specialized units to provide a coordinated first response to victims/survivors of domestic violence and their children. The specialized units will accomplish this through police or sheriff investigations, immediate victim advocacy, training for first responders, and the development of effective practices and protocols that will remain sustainable beyond the Grant Subaward performance cycle.
LT	Legal Training Program	Provides funding to provide consistent quality training, publications, and other materials to prosecutors and public defenders throughout California on the prosecution of crimes against women.
MC	Minor's Counsel Program	Provides funding to support the courts by appointing a minor's counsel in child custody cases involving child abuse, neglect, or exploitation, and to determine if the appointment of minor's counsel improves the criminal justice system's response to these cases.
NA	Native American Child Abuse Treatment Program	Provides funding for comprehensive psychotherapy and/or culturally centered therapy services to Native American children victimized by abuse and/or neglect.
PO	Law Enforcement Training Program	Provides funding to train law enforcement personnel in the areas of sexual assault, domestic violence, stalking, and culturally specific dynamics as it relates to these crimes.
PP	Statewide Prevention Coordination Program	Provides funding to facilitate statewide collaboration of Intimate Partner Violence (IPV) prevention, provide collaborative support to Cal OES on the development and implementation of IPV prevention programs, and provide training and technical assistance to Subrecipients of the Intimate Partner Violence Prevention (FD) Program. and technical assistance to Cal OES program subrecipients.

PT	Probation Officer Training Program	Provides funding to provide in-person or online specialized training to California's probation officers. The training must be victim-centered and focus on enhancing probation officers' knowledge and skills regarding violence against women. Training must concentrate specifically on the supervision of probationers convicted of domestic violence, sexual assault, dating violence, and/or stalking. If appropriate, integrate restorative justice training into the existing curriculum.
PU	Probation Specialized Units Program	Provides funding to support specialized units within probation departments in California for focused supervision, through a reduced caseload, to probationers of crime involving domestic violence, sexual assault, dating violence, and stalking.
PV	Statewide Domestic Violence Prevention and Resource Center Program	Provides funding to a) establish, expand, and maintain a resource center for the collection, retention, and distribution of educational materials related to domestic violence, family violence, and/or teen dating violence; (b) prevent domestic violence and intimate partner violence, including teen dating violence, prioritize underserved populations within communities, and build the capacity of local organizations to do this work; and (c) provide training and ongoing technical assistance for Cal OES Intimate Partner Violence Prevention (FD) Program subrecipients.
RC	Rape Crisis Program	Provides funding to proposed and existing sexual assault services programs (SASPs) operating local rape victim centers and prevention programs. Cal OES shall provide financial and technical assistance to SASPs (rape crisis centers) to implement the following services: crisis intervention, 24-hours per day, seven-days-per week, follow-up counseling, accompaniment services, advocacy services, information and referrals to victims and the general public, community education presentations, rape prevention presentations, and self-defense programs.
RJ	Restorative Justice Training	Provides funding to establish expertise in victim/survivor-centered restorative justice prosecutorial best practices in response to domestic violence and sexual assault cases.
SD	Sexual and Domestic Violence Prevention	Provides funding to prevent sexual and domestic violence through primary and secondary prevention efforts, prioritize marginalized/underserved populations within communities, and build the capacity of local organizations. This program will be ending December 31, 2024.

SP	Supervised Visitation Program	Provides funding to assure the safety and protection of children by supporting professional providers who supervise visitation of children with a noncustodial party where there is a history or allegations of domestic violence, child abuse or neglect, or sexual abuse.
TP	California Victim Witness Advocate Training Program	Provides funding, per California Penal Code § 13835.10, which statutorily mandates Cal OES to establish a statewide victim/survivor assistance training program to develop minimum training and selection standards, certify training courses, and provide funding to enable local victim/survivor service providers to have the required training.
US	Project Safe Neighborhoods Formula Grant Program	Provides funding to bring together federal, state, local, tribal, and territorial law enforcement officials, prosecutors, community-based partners, and other stakeholders to identify the most pressing violent crime problems in community and develop comprehensive solutions to address them. PSN is coordinated by the U.S. Attorneys' Office in 94 federal judicial districts throughout the 50 states and U.S. territories.
UV	Unserved/Underserved Victim Advocacy and Outreach Program	Provides funding to increase access to culturally appropriate victim services for unserved/underserved victims/survivors of crime.
VA	Domestic Violence Response Team Program	Provides funding to support communities in building and implementing protocols and practices for a collaborative and coordinated response to incidents of domestic violence. The Program builds the capacity of communities that demonstrate a need for greater collaboration and coordination between domestic violence service providers and law enforcement.
VE	Bulletproof Vest Partnership Program	Provides funding for reimbursement to local jurisdictions for the cost of body armor vests purchased for law enforcement.
VI	Victim Services Information Program	Provides funding to examine and respond to the various needs of crime victims/survivors and ensure that inmates, parolees, correctional staff, and the public recognize and understand the impact of crime on victims/survivors. Victim/survivor services provided by the Subrecipient include notifying victims of the whereabouts of offenders and circumstances of the case, counseling, education regarding victim's rights, and assistance in preparing victim impact statements.
VN	Victim Information and Notification Everyday Program	Provides funding to track the location of inmates while incarcerated and inform victims of changes to incarceration location and/or release.

VR	Victims Legal Resource Center Program	Provides funding for the California Victims' Legal Resource Center to provide victims, their families, and victim service providers with information about victims' legal rights in the criminal and civil justice systems and to provide tailored resource referrals, as described in California Penal Code, Section 13897.2.
VT	Victim Notification Program	Provides funding to provide appeal notifications to victims/survivors and their families, as well as assistance, support, resources, and outreach in capital and non-capital appeals.
VV	Violence Against Women Vertical Prosecution Program	Provides funding to improve the criminal justice system's processing of violent crimes against women through a coordinated, multi-disciplinary, prosecutorial response including specialized units with a highly qualified prosecutor and victim advocate.
VW	Victim/Witness Assistance Program	Provides funding to maintain Victim Witness Centers in each of California's 58 counties to provide comprehensive services to victims/survivors and witnesses of all types of violent crime, pursuant to California Penal Code §13835.
XB	Bullying & Violence in School Advocacy Program	Provides funding to provide counseling, advocacy, and other support services to children/teenagers who have been victimized by bullying and/or school violence.
XD	Domestic Violence Housing First Program	Provides funding to provide victims/survivors of domestic violence with safe, permanent housing and ongoing, trauma-informed services tailored to address the individual needs of each victim/survivor that allows them to choose how to best rebuild their lives.
XE	Elder Abuse Program	Provides funding to enhance the safety of elder and dependent adult abuse victims/survivors of crime by providing direct services to this vulnerable population, bridge the gap between elder justice service providers and improve the delivery of services by allied service providers including, but not limited to, Adult Protective Services, Long-Term Care Ombudsman Programs, and legal assistance providers. This Program will provide support for communities to improve their ability to identify the needs of victims/survivors of elder and dependent adult abuse, including those with disabilities.
XH	Transitional Housing Program	Provides funding to provide victims/survivors of crime with transitional/short-term housing assistance and a range of supportive services with the goal of moving victims/survivors into safe, permanent housing.

XL	Legal Assistance Program	Provides funding to establish or expand access to a range of housing options that meet the needs of youth experiencing homelessness, and to provide crisis intervention and stabilization services so that the immediate crises these youth face can be resolved, and they can focus on their futures.
XS	Sexual Assault Response Team Program	Provides funding for a full-time Sexual Assault Counselor, per Evidence Code § 1035.2, to act as a SART Advocate to take a lead role in the planning and coordinating of SART efforts in their local community with the goal of improving the quality of response to, and services for, sexual assault victims/survivors.
XY	Underserved Child & Youth Advocacy Program	Provides funding for advocacy and support services to unserved/underserved child and youth victims/survivors of crime.
YE	Homeless Youth Emergency Services and Housing Program	Provides funding for food, shelter, counseling, and outreach services to locate homeless youth and link them with services, screen for basic health needs, and provide long-term stabilization planning with an emphasis on housing. Four targeted counties include: San Francisco, Santa Clara, San Diego, and Los Angeles.
YT	Youth Emergency Telephone Referral Network Program	Provides funding for a non-threatening, toll-free hotline to connect youth in need of services to appropriate service agencies. The referral network can be accessed by youth and their families from anywhere in the State.
	Sexual Assault Reimbursement	Provides funding to establish an amount to reimburse local law enforcement to offset the cost of conducting the medical evidentiary examination of a sexual assault victim who has determined, at the time of the examination, to report the assault to law enforcement, using funds made available upon appropriation for this purpose.

HSGP-T	Homeland Security Grant Program Tribal Allocation	Provides funding to support building or sustaining security enhancement projects at federally-recognized tribes and Indian organizations that fall within one of the Cal OES HSGP Investment Justifications.
HSGP-SA	Homeland Security Grant Program for State Agencies	Provides funding to support state agency security Enhancement projects that fall within one of the Cal OES HSGP Investment Justifications.
*SHSP	State Homeland Security Program	Provides funding for the support of state, tribal, territorial, and local preparedness activities that address high priority preparedness gaps across all core capabilities that support terrorism preparedness.
*OPSG	Operation Stonegarden Program	Provides funding for the support of enhanced cooperation and coordination among Customs and Border Protection (CBP), United States Border Patrol (USBP), and local, tribal, territorial, state, and Federal law enforcement agencies.
*UASI	Urban Area Security Grants Program	Provides funding for the assistance of high-threat, high-density Urban Areas in efforts to build, sustain, and deliver the capabilities necessary to prevent, protect against, mitigate, respond to, and recover from acts of terrorism.
NSGP	Nonprofit Security Grant Program	Provides funding for the support for target hardening and other physical security enhancements to nonprofit organizations that are at high risk of a terrorist attack.
CSNSGP	California State Nonprofit Security Grant Program	Provides a State of California allocation for target hardening and other physical security enhancements to nonprofit organizations that are at high risk of violent attacks, and hate crimes due to ideology, beliefs, or mission.
EMPG	Emergency Management Performance Grant	Provides funding to states to assist state, local, territorial, and tribal governments in preparing for all hazards.

SLCGP – L&T	State and Local Cybersecurity Grant Program – Local and Tribal	Provides funding to address cybersecurity risks and cybersecurity threats to information systems owned or operated by, or on behalf of local, or tribal governments.
