FY 2021-22 LISTOS CALIFORNIA GRANT PROGRAM EXECUTIVE SUMMARY

BACKGROUND

The Listos California Emergency Preparedness Campaign was established in Spring 2019 as a two-year effort to educate the most vulnerable Californians – older adults, people with disabilities, those living in poverty, and people with language barriers. While the original goal was to reach one million Californians, the campaign reached over 3.8 million and successfully partnered with over 300 community-based organizations (CBOs) and volunteer and service teams. Listos California was successful in reaching vulnerable communities to provide emergency preparedness information and resources.

The campaign focused on 24 of the state's 58 counties and was driven by research, data and technology. Educational materials were developed to be culturally and linguistically accessible. Local CBOs utilized these materials to educate local community members that reflected the most vulnerable population of their county.

FY 2021-22 LISTOS CALIFORNIA GRANT PROGRAM

To build upon the achievements of the Campaign, Governor Newsom and the State Legislature included a \$25 million ongoing General Fund appropriation in the 2021-22 Budget Act to the California Governor's Office of Emergency Services (Cal OES.) The permanent funding supports a statewide grant program that utilizes the information and techniques developed through the Campaign. This funding, and combined data, allows Cal OES to continue partnering with CBOs and tribes and to support Community Emergency Response Team (CERT) efforts in providing not only preparedness, but response and recovery operations that support equity and outreach efforts for marginalized and underserved communities across the State.

Allocations were distributed as follows:

- \$6 million to Targeted CBOs CBO partners serving the most socially vulnerable Californians at risk for adverse impacts from natural disasters were permitted to apply for up to \$500,000 on a competitive basis.
- \$8 million to Statewide CBOs CBO partners working with socially vulnerable populations outside the target areas were permitted to apply for up to \$350,000 on a competitive basis.
- \$1 million to California Federally-Recognized Tribes Tribes could apply for up to \$100,000 on a completive basis.
- \$500,000 to CERT Programs CERT programs could apply for up to \$15,000 on a competitive basis.
- \$9.5 million Communications Management/Training and Technical Assistance (Allocated as follows):
 - \$7 million to develop a multilingual paid media campaign to amplify the work being done by CBOs through targeted paid

media outreach; to pursue partnerships with trusted media sources for communities most-impacted by disasters; to create and promote Listos California resources; to update and distribute campaign materials; to develop strategic partnerships to further reach into targeted communities and cross-promote messages targeting similar audiences; and to provide ongoing public access to the Listos California website.

- \$2 million to train CBOs and tribes and provide other technical assistance.
- o \$500,000 for a CERT Training Conference.

REPORTING REQUIREMENTS

Assembly Bill 170 in the State Budget Act of 2021-22 requires Cal OES to provide a report to the Legislature on the expenditure of Listos California Grant Program funds, no later than February 1, 2023. The report must identify:

- How funds were allocated;
- What methods of outreach the Office of Equity used to inform eligible entities of the funding;
- The entity or community that received the funding; and
- A description of projects funded.

The period of performance for the Listos California Grant Program is June 1, 2022, through December 31, 2023.

OUTREACH EFFORTS

Listos California is housed under the Office of Diversity, Equity, and Inclusion (DEI) within the Cal OES Executive Office. Leaning on the successful campaign results with a focus on equitable access to Listos California Grants, outreach efforts included: advertising on the Cal OES website Search for Grants page and the Department of Justice's Grants and Payment Management System. To expand our reach to Californians in marginalized and underserved communities, DEI worked in coordination with the Cal OES Office of Tribal Coordination. All federally-recognized tribes in California were sent email notifications highlighting the Listos California Grant opportunities. Similarly, CERT Programs, legislative officials, and CBO stakeholders were sent email notifications. Furthermore, a press release was placed on the Cal OES website and solicitation announcements were posted on all Cal OES social media outlets. A live webinar training was provided to potential applicants on how to understand the components of the grant Request for Proposal and how to complete application forms. A recording of the webinar was placed on the Cal OES website for those that were unable to attend.

PROJECTS FUNDED

The activities identified in this report provide a description of projects and engagements as of June 1, 2022, through December 1, 2022.

SUCCESSES

Since July 1, 2022, there have been organizations that have had some early achievements. These are just a few of the successful outcomes from the FY 2021-22 Listos California Grant Program.


The California Rural Legal Assistance foundation utilized the Listos California Statewide Grant Program to organize an outreach event with the Mexican Consulate at the Lodi Migrant Center located in San Joaquin County. The event delivered disaster preparedness, response, and recovery materials and supportive resources to the community, along with earthquake preparedness training and accompanying flyers. The materials and training provided were particularly useful, during and after the 5.1 magnitude San Jose earthquake.

The Center for Independent Living used Listos California Target Grant Program funding to provide one-on-one emergency preparedness planning sessions with community members where they are able to use the Listos California Disaster Ready guides to: create individual emergency plans; map out emergency resources in their communities; discuss how to build an emergency kit; and how to build an evacuation plan. Their one-on-one session also provided an overview of how people with disabilities can prepare for specific disasters, including earthquakes, wildfires, excessive smoke, heat warnings, floods, and power shutoff events.

The Scotts Valley Band of Pomo Indians used Listos California Tribal Grant Program funding to collaborate with the Kelseyville Fire Department in providing fire safety and fire extinguisher education to the community.
