Executive Summary

The Listos California Emergency Preparedness Campaign was established in Spring 2019 as a two-year effort to educate the most vulnerable Californians – older adults, people with disabilities, those living in poverty, and people with language barriers. Educational materials were developed to be culturally and linguistically accessible. Local community-based organizations (CBOs) utilized these materials to educate local community members who reflected the most vulnerable populations of their county. While the original goal was to reach one million Californians, the campaign reached over 3.8 million and successfully partnered with over 300 CBOs and volunteer and service teams. Listos California was successful in reaching vulnerable communities to provide emergency preparedness information and resources.

To build upon the achievements of the Campaign, Governor Newsom and the State Legislature included a \$25 million ongoing General Fund appropriation in the 2021-22 Budget Act to the California Governor's Office of Emergency Services (Cal OES). The funding supports a statewide grant program that utilizes the information and techniques developed through the Campaign. This funding allows Cal OES to continue partnering with CBOs and tribes and to support Community Emergency Response Team (CERT) efforts in providing not only preparedness but also response and recovery operations that support equity and outreach efforts for marginalized and underserved communities across the State.

Introduction

The activities identified in this report describe projects and engagements as of June 1, 2023, through December 1, 2023. These funds were used to the benefit of the people of California for a range of essential activities including more active engagement in multiple preparedness initiatives, such as the Great California Shake Out drill at multiple locations, as well as disaster preparedness messaging at annual charity concerts, monthly food distribution events, and other community events. Funding provided unhoused individuals and those within the Section 8 Housing Programs with curated kits with hygiene items and Listos California emergency resource materials. This innovative effort of combining resource materials with tangible items was found to provide more holistic support to both homeless and Section 8 residents reached by the CBO who received this funding, allowing the CBO to navigate its challenges more effectively. This funding also allowed a federally recognized tribe to design and publish a disaster preparedness webpage to better prepare their members for potential disasters. This is only a fraction of the successful outcomes from the Fiscal Year (FY) 2022-23 Listos California Grant Program.

Reporting Requirements

Pursuant to the California Budget Act of 2022 (Senate Bill 154), section 2.00, item 0690-101-0001 provision 5, Cal OES is required to provide a report to the Legislature on the expenditure of Listos California Grant Program funds, no later than February 1, 2024. The report must identify:

- 1. How funds were allocated;
- 2. What methods of outreach the Office of Equity used to inform eligible entities of the funding;
- 3. The entity or community that received the funding; and
- 4. A description of projects funded.

The period of performance for the FY 2022-23 Listos California Grant Program is June 1, 2023, through December 31, 2024.

Fund Allocation

Of the total \$25 million General Fund appropriation, Cal OES allocated \$7.5 million for continued communications management and training, \$2 million for philanthropy grant writing and technical assistance, and the remaining \$15.5 million to local CBOs, tribes, and CERT programs following the breakdown below:

- \$6 million to targeted CBOs CBO partners serving the most socially vulnerable Californians at risk for adverse impacts from natural disasters were permitted to apply for up to \$300,000 on a competitive basis. Award amounts were based on the number of engagements a CBO committed to accomplish during the Grant Subaward performance period.
- \$8 million to statewide CBOs CBO partners serving communities statewide to support the same general activities as the targeted were permitted to apply for up to \$500,000 on a competitive basis. Award amounts were based on the number of engagements a CBO committed to accomplish during the Grant Subaward performance period.
- \$1 million to California federally recognized tribes Tribes could apply for up to \$200,000 on a competitive basis. Award amounts were not based on engagements.

- \$500,000 to CERT programs CERT programs could apply for up to \$25,000 on a competitive basis. Award amounts were not based on engagements.
- \$7.5 million for continued communications management and training This funding was used to continue the development of a multilingual paid media campaign that amplifies the work being done by CBOs through targeted paid media outreach; to pursue partnerships with trusted media sources for communities most impacted by disasters; to develop strategic partnerships to further reach into targeted communities and cross-promote messages targeting similar audiences; to create and promote Listos California resources; to update and distribute campaign materials; to provide ongoing public access to the Listos California website; and to provide general project management support to ensure complementary activities and overall accountability.
- \$2 million for grant writing support This funding was used to support organizations seeking to apply for grants. Assistance consists of multilingual and multicultural workshops around the State, webinars, educational toolkits, and one-on-one support to potential grantees in California. Funding was also provided to host a website and provide organizational support for grants created for disaster preparedness, mitigation, response, and recovery, focusing on equity and communities.

Outreach Efforts

Listos California is housed under the Office of Diversity, Equity, and Inclusion (ODEI) within the Cal OES Executive Office. Cal OES launched a successful campaign focused on equitable access to Listos California Grants. Outreach efforts included advertising on the Cal OES website Search for Grants page and the California State Library's California Grants Portal. To expand our reach to Californians in marginalized and underserved communities, ODEI worked in coordination with the Cal OES Office of Tribal Coordination. All federally recognized tribes in California were sent email notifications highlighting Listos California Grant opportunities. Similarly, CERT programs, legislative officials, and CBO stakeholders were sent email notifications. Furthermore, a press release was placed on the Cal OES website and solicitation announcements were posted on all Cal OES social media outlets. A live webinar training was provided to potential applicants on how to understand the components of the grant Request for Proposal and how to complete application forms. A recording of the webinar was placed on the Cal OES website for those who were unable to attend.

Innovative approaches to expand and embed equity into the program are being implemented every year. The latest initiatives include supporting new and

small CBOs that may be unfamiliar with the grant process. The Listos California grant funded a philanthropic organization to provide an overview and training on grant writing. To support diversity in the emergency management workforce, Listos California developed a grant opportunity targeting youth in underrepresented communities. Lastly, but importantly, to strengthen communities' preparedness capacity, Listos California program staff stay connected to the grantees and the communities they serve through monthly virtual engagements, coordinating and supporting community events, and organizing listening sessions to provide CBOs the opportunity to speak openly about unmet needs and ways for Cal OES to provide additional support.

Entities/Communities Receiving Funding

The Listos California Grant Program is comprised of four (4) grant programs, each with a different focus. All programs are united in achieving the Listos California goal of reaching millions of Californians who otherwise would not have access to lifesaving emergency preparedness information and providing tools to help vulnerable Californians not only survive but also thrive post-disaster.

Listos California Target Grant Program (Target):

Supports organizations throughout California that serve smaller populations with key social vulnerability factors located in any given area at moderate to high risk from natural hazards. Community-based organizations throughout the State, referred to as CBOs, can work independently or subgrant with local CBOs to provide disaster training and resources to vulnerable and diverse populations. This work is intended to increase their communities' disaster preparedness, response, recovery, and mitigation capabilities.

Listos California Statewide Grant Program (Statewide):

Supports organizations throughout California that serve multiple counties and/or larger populations with key social vulnerability factors located in areas at moderate to high risk from natural hazards. Community-based organizations throughout the State, referred to as CBOs, can work independently or subgrant with local CBOs to provide disaster training and resources to vulnerable and diverse populations. This work is intended to increase their communities' disaster preparedness, response, recovery, and mitigation capabilities.

Listos California Tribal Grant Program (Tribal):

Supports federally recognized tribes located in California that serve populations in areas at moderate to high risk from natural hazards. Tribal governments can work independently, with other tribal governments, or with local CBOs to provide

disaster training and resources to vulnerable and diverse populations. This work is intended to increase their communities' disaster preparedness, response, recovery, and mitigation capabilities.

Listos California CERT Support Grant Program (CERT):

Provides funding to new and existing CERT programs to support projects that help prepare vulnerable and underserved populations.

Projects Funded

Below is a listing of each FY 2022-23 Listos California Grant Program Subrecipient and a description of the projects funded.

Access California Services

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Orange. Access California Services was granted Listos California Target Grant Program funding to:

- Implement a three-step program design and service delivery system which will include outreach, training, and community engagement to increase disaster preparedness, response, recovery, and mitigation with a focus on the Middle Eastern population.
- Provide workshops, training, and participation opportunities with written materials.
- Host virtual meetings to discuss key aspects of emergency preparedness.
- Provide in-person education to over 200 individuals on emergency preparedness.

- Provide education outreach via social media, e-blast newsletters, and mass texting.
- Host community meetings to raise awareness of Listos California and meet with local officials on suggested solutions.

Asian Business Institute and Resource Center

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Fresno. The Asian Business Institute and Resource Center was granted Listos California Target Grant Program funding to:

- Ensure that farmers are well prepared for future natural disasters by encouraging conversations with farmers/farmworkers to assess their needs and then utilize the collected data to design and conduct 13 engagement activities that will provide education and training.
- Provide outreach to populations using a culturally and linguistically competent approach that takes into account different language translation/interpreting needs and other group-specific accommodations.
- Invite local leaders and representatives to attend meetings with farmers/farmworkers.
- Provide workshops on topics such as floods, droughts, hail, wildfires, and earthquakes.

Asian Health Services

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Alameda. Asian Health Services was granted Listos California Target Grant Program funding to:

- Provide culturally and linguistically appropriate outreach, education, and workshops to targeted populations.
- Engage immigrants and refugees, seniors/older adults, individuals with low broadband and low digital literacy, and households with limited English proficiency.

- Provide the community with emergency preparedness training, materials, and information on how to prepare and respond to a disaster (e.g., evacuation plan, emergency contact list, emergency food supply and kit).
- Establish and maintain a unified and coordinated operational structure that appropriately integrates all critical stakeholders.
- Deliver information to the whole community through the use of clear, consistent, accessible, and culturally and linguistically appropriate methods to effectively relay information.
- Build and sustain resilient systems, communities, critical infrastructure, and key resource lifelines to reduce the vulnerability of service area inhabitants.

Asian Youth Center

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. Asian Youth Center was granted Listos California Target Grant Program funding to:

- Implement a comprehensive outreach, engagement, and education program to increase disaster preparedness, response, and recovery among diverse and vulnerable populations.
- Conduct various community engagement activities with a kick-off press conference, reaching individuals through in-person and online education workshops, community events, and social media outreach.
- Conduct outreach activities to deliver rapid disaster training and resources directly to targeted communities to include education on disasters like extreme weather events and wildfires.
- Partner with schools, libraries, and other nonprofit organizations on various outreach methods in social media and newsletters that offer and advertise videos, written materials, community events, festivals, and health fairs.
- Hold in-person workshops and webinars and promote peer-to-peer education to engage immigrants and limited English community members.

- Educate individuals to enable them to take on leadership roles in their neighborhoods and work on emergency preparedness long after the program ends with training on what to do before, during, and after an event.
- Partner with local fire departments to hold community days and town hall meetings to raise awareness and foster community involvement in disaster preparedness.

Athletes and Entertainers for Kids

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in all 58 counties. Athletes and Entertainers for Kids was granted Listos California Statewide Grant Program funding to:

- Provide disaster and emergency preparedness and response training educational materials to elementary schools and libraries throughout the state in English and Spanish.
- Produce and distribute classroom kits that include videos, presenter guides and lesson plans, bookmarks, coloring books, certification of completion, student activity sheets, posters, achievement certifications, pins, etc.
- Organize the 9-1-1 Heroes Ceremonies, Tim Brown Mentor Mini Camp, and the Holiday Children's Gala.

Big Valley Band of Pomo Indians

A federally recognized tribe located in Lakeport, California. The Listos California Tribal Grant Program will allow the tribe to provide emergency response, recovery, and mitigation resources/education to vulnerable tribal community members located in the County of Lake. The Big Valley Band of Pomo Indians was granted Listos California Tribal Grant Program funding to:

- Train tribal members on the NIXLE alert system, a communication tool, during CERT and town hall meetings.
- Conduct and provide materials for CERT training to tribal staff members and the community.

- Survey households at the Rancheria to gather community input on emergency preparedness needs.
- Host town hall meetings to discuss emergency preparedness gaps and solutions.
- Provide emergency preparedness, response and recovery, and mitigation education to people with disabilities, seniors/older adults, people experiencing homelessness, elders, areas with geographically isolated individuals or families, and households with low broadband subscriptions.
- Host a kick-off meeting with elected officials and key tribal departments, such as education, social services, and administration to establish communication methods, set common goals, and discuss opportunities for collaboration.
- Provide emergency preparedness outreach to youth at the Big Valley Boys and Girls Club.

Blue Lake Rancheria

A federally recognized tribe located in Blue Lake, California. The Listos California Tribal Grant Program will allow the tribe to provide emergency response, recovery, and mitigation resources/education to vulnerable tribal community members located in the County of Humboldt. The Blue Lake Rancheria was granted Listos California Tribal and CERT Support Grant Program funding to:

- Recruit, select, and contract qualified preparedness consultants to conduct workshops and assist with curriculum development of Train-the-Trainer courses.
- Conduct ten Preparedness Academies, nine in English and one in Spanish.
 Students will earn a certificate of completion and various preparedness kit items (backpack, water filter, emergency blanket, or weather radio).
 Suitable courses will be configured for online access in multiple languages and hearing-impaired audiences and will be published in the Blue Lake Rancheria library online channel for further education purposes.
- Conduct Train-the-Trainer courses that will be open to community participants. Graduates will receive a certificate of completion.

- Provide one Traumatology course and two Stop-the-Bleed trainings as a part of continuation training for CERT members.
- Provide Basic CERT trainings utilizing locally qualified TERT/CERT instructors and the 20-hour Basic CERT FEMA training curriculum. Graduates will receive a fully stocked CERT backpack from Blue Lake Rancheria Office of Emergency Services.
- Perform one tabletop exercise using the CERT approved Deluxe Disasterville toolkit.

Buddhist Tzu Chi Foundation

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Los Angeles, Orange, and San Mateo. The Buddhist Tzu Chi Foundation was granted Listos California Statewide Grant Program funding to:

- Create and distribute culturally sensitive emergency preparedness outreach materials in the following languages: Mandarin, Cantonese, Korean, Vietnamese, and Tagalog.
- Utilize interpreters to effectively communicate with Asian communities and help overcome language barriers.
- Organize public education events, such as seminars, workshops, and town hall meetings to educate Asian communities. The events will be advertised through social media, community newspapers, and Asian community organizations.
- Launch social media campaigns to spread awareness.
- Collaborate with Asian community organizations, such as local community centers, churches, and temples, to reach out to a larger audience and provide resources and support to the targeted communities.
- Establish feedback mechanisms, such as surveys, to measure the
 effectiveness of the outreach program and improve future outreach
 efforts.

California Fire Foundation

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Fresno, Imperial, Lake, Los Angeles, Mendocino, Monterey, and Siskiyou. The California Fire Foundation was granted Listos California Statewide Grant Program funding to:

- Produce a culturally competent Listos California/California Fire Foundation branded, 30-second disaster preparedness video and radio public service announcement (PSA) using firefighters as the messengers on how to create a disaster-ready evacuation plan, including how to interpret different warnings and what essentials to pre-pack before disaster strikes. The PSAs will be in English, Spanish, Mixteco (a Mexican Indigenous language), Vietnamese, Hmong, Mandarin, and Cantonese, and will include open captions and/or American Sign Language versions.
- Create and distribute culturally competent, multilingual disaster preparedness information via print and digital/web-based assets, including flyers, brochures, and related social media.
- Create a multilingual disaster preparedness information hotline with a direct phone number, which will be included in the PSAs and print, social media, and digital/web-based assets.
- Host a Listos California webpage that will publicly house the video, radio, print, and digital assets produced.

California State Alliance of YMCAs

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Los Angeles, Santa Barbara, Shasta, Siskiyou, Sonoma, and Ventura. The California State Alliance of YMCAs was granted Listos California Statewide Grant Program funding to:

 Partner with local agencies, such as food banks, safety councils, the Red Cross, and other trusted community organizations, to offer training and develop a targeted outreach plan specific to their regions and the natural disasters that affect them.

- Create and deliver disaster preparedness, response, and recovery outreach education and training in multiple languages to diverse and vulnerable populations.
- Provide staff and volunteers with resources to ensure they are equipped to deliver effective disaster preparedness, response, and recovery outreach and education.
- Host monthly discussions with six YMCAs to ensure that objectives are met in each other's areas and act as a partner to help with outreach plans.
- Host events such as community resource fairs, specialty events (trunk or treat, healthy kids' day, etc.), afterschool programs, youth sports, local food bank distributions, and tabling partner events.
- Provide tools to track data and manage reporting, and marketing materials.

Catholic Charities CYO of the Archdiocese of San Francisco

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Marin, San Francisco, and San Mateo. The Catholic Charities CYO of the Archdiocese of San Francisco was granted Listos California Statewide Grant Program funding to:

- Target areas high in poverty, immigrants, families experiencing homelessness, limited English speaking, older adults, and significant Black, Indigenous, and people of color populations for outreach and training.
- Provide training for staff and educational material in different languages, particularly in English, Spanish, Tagalog, Mandarin, and Cantonese.
- Implement a three-step program design and service delivery system driven by training, outreach, and community engagement to develop more awareness.
- Host two in-person trainings per week for sixty weeks, host sixty virtual webinars, and post content via social media twice a week for 120 media posts total.

- Post ads in primary newspapers for each county publicizing training and events.
- Have weekly and biweekly check-ins and Zoom meetings to share best practices and address questions and concerns.
- Subgrant to Catholic Charities of California to provide project management expertise to monitor progress and deliverables and expenditures.

Catholic Charities of Los Angeles, Inc.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Los Angeles, Santa Barbara, and Ventura. The Catholic Charities of Los Angeles, Inc. was granted Listos California Statewide Grant Program funding to:

- Target areas high in poverty, immigrants, families experiencing homelessness, limited English speaking, older adults, farmworkers, and isolated individuals and families that may have limited connectivity population for outreach and training.
- Host or attend events such as the Abilities Expo 2022, peer-to-peer outreach, and education/training delivered to culturally diverse communities.
- Subgrant to Catholic Charities of California to provide project management expertise to monitor progress and deliverables and expenditures.
- Conduct weekly and biweekly check-ins and Zoom meetings to share best practices and address questions and concerns.

The Catholic Charities of Santa Clara County

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Santa Clara. The Catholic Charities of Santa Clara County was granted Listos California Statewide Grant Program funding to:

- Continue to serve farmworkers, isolated populations, immigrants, refugees, limited English communities, and vulnerable populations through caravan events, incentive items, and education and hands-on training.
- Provide in-language materials for training, laminated checklists, and videos.
- Provide social media posts on safety tips and links to Listos resources.
- Distribute information materials to community centers, senior centers, expanded learning sites, and affordable housing developments with checklists and websites to download alert apps and invitations to workshops.
- Continue workshops that provide home fire safety and power outage, wildfire, flood, earthquake, and pandemic preparedness. Workshops will include instruction on the use of fire extinguishers, identifying home hazards, local emergency numbers and the circumstances in which to call each, accessing emergency information websites (Cal OES/Listos, County OES, CADRE), downloading emergency alert apps to smartphones (AlertSCC, MyShake, local emergency response agencies such as CalFire on Facebook), creating and practicing family emergency plans, basic first aid and emergency supplies "Stay Kits" for sheltering in place.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Fresno, Kern, Kings, Merced, and Tulare. The Catholic Charities of the Diocese of Fresno was granted Listos California Statewide Grant Program funding to:

- Serve all groups but primarily immigrants, refugees, farmworkers, geographically isolated, and limited English Proficient individuals.
- Partner with county fairs, county Offices of Education, food banks, the United Way, and the American Red Cross to attend events.
- Integrate Listos California services into food distribution events, delivering one-on-one and group education and information to food distribution recipient households.

- Recruit and train additional peer educators.
- Promote and partner with local organizations to host future listening sessions to identify gaps and share ways to best address those needs, as well as leverage the existing resources, resiliency, and support.
- Create videos and short impactful stories of people with disabilities about surviving disasters and preparing for them, as well as educational videos on what people with disabilities can do to prepare for a disaster.

Center for Volunteer and Nonprofit Leadership

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Napa and Solano. The Center for Volunteer and Nonprofit Leadership was granted Listos California CERT Support Grant Program funding to:

- Train CERT instructors during a 3-day Train-the-Trainer workshop.
- Provide two 20-hour CERT training courses.

- Provide Spanish-language instructors at CERT training courses.
- Provide CERT training to teens and Latinx/Hispanic community members.
 Attendees who become committed CERT members will receive basic gear including a CERT backpack, safety vest, hard hat, leather work gloves, wrench, flashlights, batteries, first aid kit, dust mask, emergency blankets, safety goggles, whistle, multi-function tool, hand sanitizer, and duct tape.

Central City Neighborhood Partners

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The Central City Neighborhood Partners was granted Listos California Target Grant Program funding to:

- Provide services to vulnerable community members residing within the City
 of Los Angeles with a primary focus on seniors, immigrants, refugees, and
 households with limited English proficiency.
- Engage the community on emergency preparedness with project training, flyers, social media, and regular meetings/conversations.
- Provide in-person engagements including door-to-door outreach, online
 live training, recorded training, and e-blast newsletters. Online live training
 will be in English and Spanish via Facebook Live, Zoom, or Google. Online
 training will be recorded in video posts on YouTube and will discuss key
 aspects of emergency preparedness.

City of Alhambra Fire Department

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The City of Alhambra Fire Department was granted Listos California CERT Support Grant Program funding to:

 Recruit and train CERT volunteers with a focus on vulnerable and underserved populations, such as individuals who primarily speak Spanish or Mandarin.

- Continue in-person CERT training to prepare community members for a disaster and educate them on how to help themselves and their neighbors in an emergency.
- Conduct community outreach and CERT recruitment at various events in the city and by engaging community-based organizations such as the Alhambra Latina Association and the Asian American and Pacific Islander Forward Movement.
- Provide CERT kits with helmet, backpack, vest, and gas shut-off wrenches.

- Purchase CERT backpacks with personal protection equipment and supplies.
- Purchase training kits and educate volunteers on fire extinguisher use, medical triage and emergency treatment, light search and rescue, cribbing, structural damage assessment, and two-way radio use.

- Equip CERT vehicles and provide CERT-trained drivers with training materials and equipment for first responder assistance.
- Participate in community-driven activities, sharing Disaster Preparedness materials to educate the local population.

 two core groups of ten vulnerable and underserved community members
 on basic fire suppression, first aid, hands-on cardiopulmonary resuscitation,
 search and rescue, and evacuation techniques. The volunteers will assist
 firefighters with local disasters and in providing manpower for communitywide public events.

City of National City Fire Department

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of San Diego. The City of National City Fire Department was granted Listos California Grant Program CERT Support funding to:

- Purchase training kits and educate members on basic cribbing, triage, cardiopulmonary resuscitation/automated external defibrillator, first aid, personal protection equipment, and natural gas meter training in both English and Spanish.
- Recruit and train Spanish-speaking CERT members to provide feeding and sheltering services to vulnerable populations during evacuations.
- Provide basic CERT training that includes first aid, Stop the Bleed, and You are the Help Until Help Arrives classes in Spanish.
- Recruit and train a minimum of 100 additional CERT members.

City of Norwalk

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The City of Norwalk was granted Listos California Target Grant Program funding to:

City of Poway Fire Department

- Provide field operation guides for new and existing members.
- Procure personal protection equipment CERT kits that include a backpack, helmet, vest, goggles, gloves, facemask, duct tape, first aid kit, emergency blanket, and a flashlight.
- Provide Federal Bureau of Investigation and Department of Justice background checks on new members.
- Provide CERT basic academy, cardiopulmonary resuscitation, and first aid medical operations training and materials to new and existing members.

City of San Diego Fire Rescue Department

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of San Diego. The City of San Diego Fire Rescue Department was granted Listos California CERT Support Grant Program funding to:

- Provide CERT Hybrid training academies delivered via Zoom, two hours a week for four weeks and, three in-person training, for 6-hour days.
- Register five volunteers to attend the National CERT Association
 Conference located in San Francisco, California, including travel expenses.
- Provide in-person training on how to build a family communication plan, how to call 9-1- 1, how to place a person in need in the recovery position, and how to provide support. Printed handouts will be in multiple languages.
- Deliver in-person training on Listos Aware and Prepare courses at the library utilizing Spanish-speaking instructors.

Add up to five new CERT volunteers to the CERT Instructor Cadre.

Coalition for Humane Immigrant Rights

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Imperial. The Coalition for Humane Immigrant Rights was granted Listos California CERT Support Grant Program funding to:

- Provide two CERT training courses throughout the performance period.
- Provide CERT backpacks that include calorie food bars, solar blankets, pouches of water, a 54-piece first aid kit, plastic whistles with lanyards, and a crank radio with flashlight to all committed and trained CERT members.
- Conduct local workshops partnering with local organizations to provide bilingual (English/Spanish) free training to the local public, participants will understand their unique role in immediate disaster response.

Comite Civico del Valle, Inc.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Imperial and San Diego. The Comite Civico del Valle, Inc. was granted Listos California Target Grant Program funding to:

- Reach, educate, motivate, and activate individuals who are traditionally excluded and underserved in disaster preparedness.
- Build on an existing communications infrastructure that is already used to deliver trusted, culturally informed, timely, and sensitive information to target communities.
- Build upon the participants' strengths consisting of the knowledge and skills they have honed through life experiences and situations.
- Mobilize expertise and uplifting evidence-based approaches that promote access to holistic support resources, strengthen cultural bonds, and respond to language needs.
- Motivate the community by instilling trust that preparedness benefits everyone, utilizing trusted messengers to encourage target populations to

participate in training, and establishing safe and comfortable environments and settings for people to participate.

- Educate the community with training strategies that will be tailored to teach the community about disaster preparedness.
- Engage trusted messengers in the activation of vulnerable populations to take actual steps in the disaster preparedness continuum.

Community Bridges

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Monterey and Santa Cruz. Community Bridges was granted Listos California Target Grant Program funding to:

- Increase the community's disaster preparedness, response, recovery, and mitigation capabilities.
- Provide outreach to the following groups: farmworkers, immigrants, people with disabilities, older adults, unhoused residents, and households with limited English proficiency.
- Provide CERT training to staff.
- Implement a three-step program design and service delivery system driven by three elements: outreach, training, and community engagement. The overall goal is to increase the disaster preparedness, response, recovery, and mitigation capabilities of socially vulnerable populations.
- Host a kick-off meeting with key county leaders, health centers, CBOs, and community leaders to raise awareness of Listos California and inform stakeholders of the proposed plan. The meeting will be used to establish communication methods, set common goals, and discuss opportunities for collaboration.

- Target captive audiences (e.g., people waiting in lines for food distribution), stationary audiences (e.g., crowds at churches, parks, community agencies), and unrushed moving crowds (e.g., people at community festivals, health fairs, community events). Community Bridges has a booth in the Capitola Mall and will have flyers and other relevant emergency preparedness materials available for shoppers.
- Knock on doors to provide quick information for about three to five minutes in each home to reach people directly in their homes.

Community Emergency Response Volunteers of the Monterey Peninsula

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Monterey. The Community Emergency Response Volunteers of the Monterey Peninsula were granted Listos California Target Grant Program funding to:

- Target multiple vulnerable groups, including immigrants, refugees, farmworker families, people with disabilities, seniors, low income, and households with limited English.
- Provide printed and video materials in multiple languages.
- Conduct Zoom training/education, in-person meetings, and workshops.
- Work with CBOs who deliver culturally and linguistically appropriate peerto-peer disaster preparedness training and education to the most vulnerable populations.
- Engage the community in webinars, tabling, public events, and regular gathering events.
- Conduct online courses and incentivize the use of the Artist Text-based disaster preparation course.
- Provide materials and Train-the-Trainer webinars and/or in-person workshops.
- Reach out to stakeholders across sectors to host conversations about preparedness, response, recovery, and mitigation gaps in exiting plans and work to develop specific actions to close those gaps.

Community Health Partnership of Santa Clara County, Inc.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Santa Clara. The Community Health Partnership of Santa Clara County, Inc. was granted Listos California Target Grant Program funding to:

- Implement a far-reaching approach with multiple elements and activities, the development of an Advisory Board, outreach and education, training, community engagement, and social media delivery.
- Increase the disaster preparedness, response, recovery, and mitigation capabilities of vulnerable and diverse individuals residing in the counties of Santa Clara, Monterey, Santa Cruz, and San Benito.
- Create an advisory board to offer guidance and oversight for the project, advise on how to carry out program activities so they are culturally inclusive and accessible, and help program staff overcome challenges in meeting deliverables.

The CORE Community Organized Relief Effort was granted Listos California Statewide Grant Program funding to:

- Participate in monthly coordination bodies and attend monthly meetings with the Los Angeles County Community Disaster Resiliency and County of San Bernardino's volunteer organizations.
- Conduct home visits in risk areas to teach individuals how to assess risks and plan mitigation activities like identification of home ignition zones, home hardening, defensible space, debris removal, and tree climbing.
- Create and disseminate Listos California visuals and education materials on seasonal natural hazards, mobile phone alerts, and websites, and amplify government warnings and evacuation orders.
- Host workshops that will empower and reinvigorate communities hit hard by the latest disasters to ensure resilience against future extreme events.

Community Resources for Independent Living

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Alameda. The Community Resources for Independent Living was granted Listos California Target Grant Program funding to:

- Implement a three-step program designed to service and deliver outreach, training, and community engagement throughout the county to identified vulnerable groups.
- Host a kick-off meeting with key county leaders, health centers, CBOs, and community leaders to raise awareness of the project and inform stakeholders of the proposed plan.
- Establish communication methods, set common goals, and discuss opportunities for collaboration using culturally and linguistically competent staff.

- Create a peer-to-peer approach to engage and educate the community, these outreach efforts will be used to provide quick education and resources on emergency preparedness and response topics, such as "how to build an emergency kit" or "where to go after a disaster."
- Distribute Listos California materials and provide information on where to go for additional training or community engagement opportunities.

County of San Diego

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of San Diego. The County of San Diego was granted Listos California CERT Support Grant Program funding to:

- Directly engage residents with emergency preparedness education, training, and activities during the grant performance period.
- Provide five cardiopulmonary resuscitation (CPR)/automated external defibrillator (AED) courses in English.
- Provide two CPR/AED courses in Spanish.
- Provide two fire extinguisher trainings.
- Provide three Wildfire Safety Fairs in partnership with San Diego Gas and Flectric.

A federally recognized tribe located in Oroville, California. The Listos California Tribal Grant Program will allow the tribe to provide emergency response, recovery, and mitigation resources/education to vulnerable tribal community members located in the County of Butte. Enterprise Rancheria of Maidu Indians of California was granted Listos California Tribal Grant Program funding to:

- Develop an outreach, training, and community engagements program to increase the disaster preparedness, response, recovery, and mitigation capabilities of their vulnerable communities.
- Provide outreach, education, and training to the community, tribal members, and governmental employees through house meetings, general membership meetings, and town hall meetings.

Equality California Institute

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Imperial, Los Angeles, Riverside, and San Diego. The Equality California Institute was granted Listos California Statewide Grant Program funding to:

- Work with Subgrantees in the counties to deliver on-the-ground training sessions for community members and the population in hard-to-reach areas.
- Serve LGBTQ+ Californians in high-risk regions for outreach including Spanish language messaging capabilities with a robust network of LGBTQ+ allied CBO partners.
- Leverage Cal OES existing outreach training and educational materials to ensure alignment with Listos California Program goals.
- Develop a bilingual, culturally inclusive, LGBTQ+ facing online training and interactive quiz addressing disaster preparedness response and recovery, relevant to immigrant and refugee, Spanish speaking, unhoused, and other LGBTQ+ communities.
- Target online public education campaigns including Instagram, Twitter, Facebook, and email blasts.
- Host online panel discussions, and Train-the-Trainer events, share best practices and culturally relevant memory tools for emergency response.
- Host two community and training sessions on disaster preparedness.
- Distribute bilingual outreach/education/training materials to promote events monthly.

ExtraFood.Org

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Marin, San Francisco, and Sonoma. ExtraFood.Org was granted Listos California Target Grant Program funding to:

- Aim to reach individuals and families in all vulnerable groups within these counties, such as low-income, people with disabilities, low-income seniors, people experiencing homelessness, individuals in isolated areas, and households with limited English proficiency.
- Collaborate with community-based and coalition-building organizations as well as community partners and non-profit organizations to distribute and disseminate Listos California information to these vulnerable populations.
- Focus on accessing and preserving food in the event of a disaster or emergency.
- Include direct in-person distribution of printed materials at all food distribution sites by trained staff and volunteers.
- Attend community events to provide Listos California materials and engage the general public to educate on emergency preparedness protocols.

Fort Independence Indian Community

The Fort Independence Indian Community was granted Listos California Tribal Grant Program funding to:

- Administer CERT training to tribal government staff and provide education materials that will cover disaster preparedness practices.
- Work to implement and engage tribal and public community input through outreach, community engagement, and training.
- Increase the community's overall preparedness, recovery, response, and disaster mitigation of vulnerable populations.
- Conduct three tribal and two public meetings to gather and collect data that will be used to improve emergency preparedness needs.
- Utilize strategic partners to reach the residents of the town of Independence to deliver quick information on emergency preparedness

and response topics such as "where to go during or after a disaster", "must-haves to be prepared for a disaster", and information on where to get additional training and community resources.

Friends of the Long Beach Firefighters

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The Friends of the Long Beach Firefighters was granted Listos California CERT Support Grant Program funding to:

- Conduct free 20-hour FEMA curriculum CERT training to the community.
- Provide "check-in" stations throughout Long Beach with various emergency preparedness activities and training.
- Provide a "Ready Long Beach" preparedness exposition that will include a venue, seating, tents, tables, Listos California marketing materials, and audiovisual support.

Healing Urban Barrios

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Placer, Sacramento, Solano, and Yolo. The Health Education Council was granted Listos California Target Grant Program funding to:

- Provide disaster preparedness, response, recovery, and mitigation resources to Spanish-speaking immigrants, older adults, and farmworkers living in Sacramento, Yolo, Solano, and Placer Counties and co-nationals receiving services from Sacramento's Mexican Consulate.
- Conduct daily disaster education presentations at the Mexican Consulate in Sacramento and provide written information to Spanish-speaking residents.
- Participate in community events to engage and provide written information to Spanish-speaking residents.
- Develop and lead a Listos Ambassador training for Spanish-speaking residents that will prepare them to educate their family, friends, and community members about disaster response, recovery, preparedness, and mitigation strategies.
- Conduct community conversations with Spanish-speaking residents from targeted neighborhoods to identify disaster preparedness, response, recovery, and mitigation needs in Sacramento, Yolo, Placer, and Solano Counties. The events will be hosted jointly with local leaders and the County Emergency Manager from each county.

Healthy Community Forum for the Greater Sacramento Region

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Sacramento. The Healthy Community Forum for the Greater Sacramento Region was granted Listos California Target Grant Program funding to:

 Launch a coordinated education campaign with a clear, consistent, and actionable message to increase emergency preparedness awareness in targeted populations throughout Sacramento County.

- Leverage social media presence to disseminate emergency preparedness materials and resources.
- Aim to reach individuals with characteristics including, but not limited to, diversity in race/ethnicity, language, age, gender, ability, sexual orientation, and socio-economic circumstances by amplifying the message via multiple communication outlets.
- Provide outreach services to persons experiencing homelessness and assist them with connecting to supportive services.

Hopland Band of Pomo Indians

A federally recognized tribe located in Hopland, California. The Listos California Tribal Grant Program will allow the tribe to provide emergency response, recovery, and mitigation resources/education to vulnerable tribal community members located in the County of Mendocino. The Hopland Band of Pomo Indians was granted Listos California Tribal Grant Program funding to:

- Engage in a four-part program of community education, training, engagement, and the provision of resources.
- Increase emergency preparedness, response, recovery, and mitigation in the tribal community, targeting the most vulnerable members.
- Receive training and support from an expert consultant to evaluate and update their Community Emergency Response Plan.
- Lead community engagement with updated educational and engagement materials (emergency preparedness checklists, handouts, toolkits, etc.).
- Collaborate with community partners to conduct peer-to-peer educational check-ins and share approved disaster preparedness materials.
- Conduct two membership meetings and five community events, providing presentations on the CERT and emergency planning resources for the community.

Inland Southern California 211+

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Riverside and San Bernardino. The Inland Southern California 211+ was granted Listos California Statewide Grant Program funding to:

- Perform in-field work to bring in-person/in-community cultural and linguistic tools and materials for outreach monthly.
- Serve immigrants, refugees, farmworkers, people with disabilities, seniors, individuals, and families experiencing homelessness, isolated individuals, and homes with limited English proficiency with a focus on providing disaster response and recovery materials, outreach, and training.
- Host outreach events with in-person delivery and peer-to-peer engagement on emergency preparedness emphasizing the importance of emergency preparedness, response, and/or recovery.
- Conduct phone engagements (inbound and outbound) reaching residents who are more remote and hard to reach and target questions to determine how they would benefit from disaster preparedness and education.

Kern County Fire Department CERT Program

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Kern. The Kern County Fire Department CERT Program was granted Listos California CERT Support Grant Program funding to:

- Provide Train-the-Trainer, Program Manager, and Teen CERT courses.
- Register seven CERT members to attend the National CERT Association
 Conference located in San Francisco, California, including travel expenses.
- Provide standard CERT kits to all new members residing in farming communities or low-income areas in Bakersfield, California, after successful completion of all required CERT classes. CERT kits include a backpack, light stick, flashlight, whistle, batteries, safety vest, hard hat, safety goggles, N95 particulate mask, work gloves, emergency survival blanket, pry bar, etc.

• Prepare and distribute Listos and FEMA emergency preparedness information.

La Habra Police Department

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County Orange. The La Habra Police Department was granted Listos California CERT Support Grant Program funding to:

- Continue to focus on creating a Spanish CERT basic training course.
- Create a strategic plan to improve emergency preparedness access to the vulnerable community.
- Recruit Spanish-speaking volunteers from the new Spanish CERT program
 graduates to aid in additional outreach at public events to better educate
 the underserved non-English speaking population in the city of La Habra.
- Schedule five Spanish-speaking personnel to attend FEMA CERT Train-the-Trainer courses, conduct two CERT basic training in Spanish, and recruit Spanish-speaking CERT volunteers. In addition, the Department will continue to offer regional English CERT training through the Los Angeles County Fire Department when those are available.
- Continue to participate in public events such as National Night Out by manning a CERT booth and providing emergency preparedness information.
- Provide CERT basic training to the Spanish-speaking community and help recruit a cadre of Spanish-speaking CERT volunteers to further educate the vulnerable non-English speaking population.
- Bridge the gap between the underserved Spanish community and emergency preparedness education.

La Honda Fire Brigade

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of San Mateo. The La Honda Fire Brigade was granted Listos California CERT Support Grant Program funding to:

- Provide a trained cadre of emergency preparedness volunteers, including Spanish speakers, who can assist their neighbors, staff the TEP, and help with evacuations in the Pescadero, California area.
- Conduct essential CERT and First Aid Training for the staff of the Pescadero La Honda School District.
- Provide emergency preparedness bags or CERT bags to all CERT committed members.
- Provide Certified Training Fire Pan and Stop the Bleed kits to all committed CFRT members.
- Work with farmworkers to educate and give smoke/carbon monoxide alarms to underserved areas of Pescadero, California.

Lake California Community Emergency Response Team

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Butte, Glenn, Shasta, and Tehama. The Lake California Community Emergency Response Team was granted Listos California Grant CERT Support Program funding to:

- Continue to fund free emergency preparedness, fire extinguisher, cardiopulmonary resuscitation/automated external defibrillator, and first aid classes to the community. These Emergency Preparedness classes are open to all but focus on low-income and seniors.
- Purchase radios, communication supplies, and generators. Cell coverage is spotty and often down during an emergency. Radio communications are vital when other methods have failed.
- Host the annual Emergency Preparedness Safety Fair and partner with county agencies to provide one-stop shopping for community members to learn all aspects of emergency preparedness.
- Teach Emergency Preparedness at a fair targeted for those with access and/or functional needs.

Leadership Excellence and Development Foundation

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Alameda, Kern, Los Angeles, Madera, Mariposa, Monterey, Placer, Riverside, San Bernardino, San Diego, San Luis Obispo, Stanislaus, and Tulare. The Leadership Excellence and Development Foundation was granted Listos California CERT Support Grant Program funding to:

- Offer Basic CERT, Teen CERT, and CERT Train-the-Trainer programs.
- Work with local school districts and community partners to increase recruitment of local volunteers to become CERT trainers.
- Offer Stop the Bleed Training Kits to CERT members Which is additional training to enhance awareness of bleeding control and life threats posed by uncontrolled bleeding.
- Increase the number of bilingual CERT trainers, acquire the instructional materials needed to support conducting training in languages other than English, and increase the number of individuals trained as CERT members.

Lily of the Valley Emmanuel Church of Jesus Christ

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the City of Coalinga in Fresno County, Kern County, Kings County, and Tulare County. The Lily of the Valley Emmanuel Church of Jesus Christ was granted Listos California Statewide Grant Program funding to:

- Engage key stakeholders in each county for needs and assessment stages.
- Conduct initial surveys to assess community knowledge of disaster preparedness.
- Conduct post-implementation surveys to assess increased knowledge of disaster preparedness to include those with lived experiences by deploying staff and volunteers throughout the communities to conduct preimplementation surveys to be used as part of the needs assessment.
- Attend local and community events, farmer's markets, county fairs, and local parks to engage community members monthly.

- Implement a peer-to-peer approach to engage and educate communities by using culturally and linguistically competent community advocates.
- Provide awareness and education in English and Spanish.

Nehemiah Charitable Fund

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Riverside and San Bernardino. The Nehemiah Charitable Fund was granted Listos California Target Grant Program funding to:

- Increase the awareness, education, and engagement of residents for their emergency disaster campaign which provides outreach education to hard-to-reach, vulnerable communities.
- Conduct outreach, CERT training, and educational presentations at community events/health fairs.
- Increase community outreach and education to at-risk, hard-to-reach populations.
- Increase collaboration and coordination among San Bernardino County Emergency Management Services, the County of Riverside Emergency Department, the American Red Cross, and other emergency services providers.

Nevada County United Way

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Nevada, Placer, Sierra, and Sutter. The Nevada County United Way was granted Listos California Target Grant Program funding to:

- Attend community events.
- Identify and visit the most geographically isolated populations by knocking on doors to provide a quick 3–5-minute discussion on disaster preparedness.

- Provide monthly online education and training sessions for those unable to leave their homes but have broadband.
- Assist residents in creating a personal evacuation plan.
- Utilize well-established contacts throughout the community to reach residents at work and in schools. Age-appropriate disaster preparedness presentations will be provided to students at local schools and Listos California materials will be handed out.
- Host a kick-off meeting with key county leaders, community leaders, and volunteers to raise awareness of the project and inform stakeholders of the proposed plan.

North Coast Opportunities, Inc.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Lake and Mendocino. The North Coast Opportunities, Inc. was granted Listos California CERT Support and Target Grant Program funding to:

- Conduct a range of outreach and demonstration activities to strengthen relationships with underserved communities while supporting them in developing stronger relationships within their neighborhoods that result in more prepared and resilient families and communities.
- Offer information and resources to assist with community organizing and teambuilding and support community leaders with planning and hosting a NeighborFest event, using peer-to-peer strategies to help their community and their neighbors prepare for future disasters.
- Share information on available resources through other programs (e.g., Gardens Project, MendoLake Food Hub, CERT, and Volunteer Network.
- Complete the certification of one new CERT Master Instructor and develop an administrative structure that coordinates CERT in both counties rather than operating as separate programs in each county.
- Provide outreach to existing/potential CERT members through radio, news articles, email, social media, and presentations to community groups and schools.

- Provide refresher training for existing CERT members, covering curriculumbased skills, CERT principles, cardiopulmonary resuscitation, and traffic control with up to 100 CERT members participating.
- Register two members to attend the National CERT Association
 Conference located in San Francisco, California, including travel expenses.
- Convene area-wide CERT disaster drills in each county for all CERT teams and members, with at least 100 CERT members participating. The CERT Coordinator will work with County Offices of Emergency to plan and conduct disaster drills, as well as for deployment of CERT members for disaster response.

North Valley Community Foundation

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Butte, Colusa, Glenn, Nevada, Placer, and Yuba. The North Valley Community Foundation was granted Listos California Target Grant Program funding to:

- Reach vulnerable populations through 2-1-1 call center services, as well as through other programs, including In-Home Support Services and the CalWORKs client management program.
- Create a dedicated webpage for emergency preparedness resources that can be accessed easily by the public.
- Augment and/or supplement the current Disaster Preparedness Training to focus on every vulnerable population that they serve, including those with access and functional needs.
- Provide training on Disaster Preparedness protocols.
- Increase fire emergency preparedness by collecting data and analyzing and creating a plan to implement with five trusted emergency allies.
- Incorporate concepts for disaster preparedness using Listos California materials.

Nuestra Comunidad

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Sonoma. Nuestra Comunidad was granted Listos California Target Grant Program funding to:

- Conduct outreach at food and diaper distribution events, tabling at community events, and canvasing vulnerable neighborhoods.
- Create and deliver outreach programs to targeted communities, consisting of monolingual Spanish speakers.
- Conduct half-day Listos California training and outreach events focused on delivering disaster preparedness education to vulnerable populations.
- Engage difficult-to-reach farmworkers and seniors/older adults.
- Provide outreach to age-restricted mobile home parks where many of the residents live below the poverty level.

Ohlone Tribe of Carmel First Settlers of Chino Valley

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of San Bernardino and Riverside. Ohlone Tribe of Carmel First Settlers of Chino Valley was granted Listos California Statewide Grant Program funding to:

- Tailor their educational content to align with Listos California resources.
- Provide public safety, fire prevention, and emergency preparedness forums and post ads in real estate and rental-related magazines, local newspapers, zip code-specific YouTube, Cable TV, or local radio stations to reach the agency's targeted population.
- Provide training on how to stay safe during disaster events, proper use of emergency kits, and cardiopulmonary resuscitation training.
- Conduct group workshops with "how to" activities on posting emergency contact numbers, gathering personal emergency information and medication supplies, smoke detectors, local cut-off valves, making escape routes, pet care plans, and alternative stay locations.

• Record training and make it available at no cost over social media.

Pala Band of Mission Indians

A federally recognized tribe located in Pala, California. The Listos California Tribal Grant Program will allow the tribe to provide emergency response, recovery, and mitigation resources/education to vulnerable tribal community members located in the County of San Diego. The Pala Band of Mission Indians was granted Listos California Tribal Grant Program funding to:

- Conduct a minimum of two community workshops and information fairs for families, elders, and Spanish-speaking residents.
- Conduct a minimum of four disaster preparedness trainings for current employees.
- Tailor disaster preparedness materials for each specific tribal audience.
- Track outreach programs and collect data to better bridge gaps in emergency preparedness procedures within the community.
- Conduct a tribal leader and agency partner presentation at the 2024 Rise and Shine Resilience Breakfast to highlight the key successes of the program and convene a stakeholder meeting (with neighboring tribes, first responders, CERTs, and emergency managers) to strategize about how to mitigate any gaps in resources or community outreach as well as share best practices.

Project Camp

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of El Dorado, Fresno, Imperial, Lassen, Plumas, Santa Barbara, Santa Bernardino, Siskiyou, and Ventura. Project Camp was granted Listos California Statewide Grant Program funding to:

- Create individualized, community-based disaster preparedness plans that focus on child and family wellbeing for nine California counties that stretch from Mexico to the Oregon border.
- Identify local partners in the targeted regions to expand and improve the planning process for a child-focused emergency disaster response plan.

- Provide training to local volunteers.
- Provide routine check-ins and updates to plans; and ensure implementation of plans during actual disasters.
- Recruit local partners to help secure sites for day camps and childcare during disasters, as well as help spread the word to families about available services, and groups who can help recruit local volunteers.
- Bring together a coalition to create a plan targeting child-and-familydisaster response needs.

San Jose Neighborhood Community Emergency Response Team

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Santa Clara. The San Jose Neighborhood Community Emergency Response Team was granted Listos California CERT Support Grant Program funding to:

- Provide liability insurance to their members.
- Enhance their SJNCERT.Org website.
- Procure three laptops for CERT members to use during CERT classes.
- Procure eighteen tablets for CERT members to use during events.
- Purchase CERT fanny packs for Teen CERT graduates.
- Motivate and educate residents on emergency preparedness at CERT trainings.
- Recruit volunteers through outreach efforts.
- Work with neighborhoods and affinity groups, like religious organizations, using the easy-to-remember expression of "Neighbors Helping Neighbors."
- Use CERT members to organize meetings and presentations to community groups, apartment associations, and religious and service organizations.

They are working closely with the City's Project Hope which provides an entrée to underserved neighborhoods difficult to obtain otherwise.

Santa Maria CERT

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Santa Barbara. The Santa Maria CERT was granted Listos California CERT Support Grant Program funding to:

- Train sixty teens through the establishment of a TEEN CERT Program which
 consists of an 8-week in-person training with weekly sessions during the
 summer, including CERT and Red Cross cardiopulmonary resuscitation and
 First Aid certification. The First Aid certification will include a Stop the Bleed
 component.
- Assist with monthly disaster/emergency response community outreach at community events and neighborhood outreach events, organizing response scenario exhibitions at schools and in public, and recruiting teens for free quarterly in-person CPR/Emergency Bleeding/First Aid training through the end of the school year.
- Assist teens as they will be responsible for training or recruiting their families
 to participate in variations of the training. They will also create disaster
 preparedness videos and post them on the City of Santa Maria's YouTube
 page with over 2,000 subscribers.
- Will support efforts to expand preparedness education for 2,000 at-risk and underserved community members through teen engagement.

Self-Help Enterprises

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Fresno, Kern, Kings, Madera, Mariposa, Merced, San Joaquin, Stanislaus, and Tulare. The Self-Help Enterprises was granted Listos California Statewide Grant Program funding to:

 Leverage its extensive network of program participants and partners as well as its reputation as a trusted messenger to increase emergency readiness among vulnerable populations across nine counties.

- Utilize Listos California training materials and resources to host emergency preparedness workshops in low-income housing development community centers. Workshops will train residents on what to do during disasters.
 Feedback from the community will be used to guide the next steps and to strengthen local hazard mitigation plans.
- Ensure disadvantaged communities have a comprehensive approach to emergency preparedness, at the community and individual levels.
- Hosts Gateway Counseling courses.
- Empower prospective homebuyers to select the right homebuying opportunity and develop a financial plan for homeownership. These classes will accommodate a session on emergency preparedness and planning to ensure new homeowners are prepared before a disaster hits.
- Offer assistance in the form of direct financial assistance, drought services, private well repair and replacement grants, and other safe drinking water programs. Each family receiving direct assistance presents an opportunity to engage on the topic of emergency preparedness and provide resources.

St. Barnabas Senior Center of Los Angeles

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The St. Barnabas Senior Center of Los Angeles was granted Listos California Statewide Grant Program funding to:

- Initiate a two-pronged approach to ensure outreach and engagement efforts around disaster preparedness, response, and recovery are both broad and deep within the target areas.
- Combine direct and peer-to-peer "in-language" outreach within lowincome communities with limited English proficiency, with broader, mass marketing efforts.
- Target older adults living in poverty in the State helping to prepare the community in case of disaster.

- Work with media outlets to share printed and online materials that drive older adults to call or enroll online for information regarding disaster preparedness items such as First Aid kits, Disaster Preparedness backpacks, fire extinguishers, COVID tests, etc.
- Educate older adults, their caregivers, and professionals working with older adults in disaster preparedness, response, and recovery.

SYV CERT

Provides emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Santa Barbara. The SYV CERT was granted Listos California CERT Support Grant Program funding to:

- Provide in-person basic and advanced CERT training and CERT drills to members.
- Distribute emergency preparedness information and activities through eblasts, newsletters, and social media posts.
- Create up-to-date materials and hire specialist trainers to deliver the FEMA curriculum.
- Will increase efforts to work with local Latino volunteer groups to recruit volunteers and conduct CERT training in Spanish.
- Provide gear, notification system, training aids, and instructional materials in both English and Spanish to all volunteers to reduce barriers to participation.
- Recruit and train in the Latinx community to increase community preparedness and continue supporting CERT training with our senior communities.

Thai Community Development Center

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Los Angeles. The Thai Community Development Center was granted Listos California Target Grant Program funding to:

- Engage the Thai, Bangladeshi, and other immigrant communities through shared databases.
- Conduct standing meetings to update one another, assess the progress of the program and its goals, and coordinate targeted efforts to increase engagement and outreach.
- Provide outreach and education on disaster preparedness, response, recovery, and mitigation.
- Provide in-person training on virtual education through social media outreach.

TODEC Legal Center Perris

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Riverside. The TODEC Legal Center Perris was granted Listos California Target Grant Program funding to:

- Share information and increase community disaster preparedness to indigenous farmworkers, Latino immigrants, and rural farmworkers within Riverside County.
- Provide equitable access to information, community education, advocacy, and civic engagement for limited and non-English speaking people including immigrants and migrant workers.
- Establish a comprehensive emergency management program that includes ongoing training and exercises for emergency responders and staff, as well as public education and outreach efforts to promote disaster preparedness among residents.

Trybe Inc.

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Alameda. Trybe Inc. was granted Listos California Target Grant Program funding to:

• Engage Oakland residents through a peer-to-peer engagement approach.

- Serve individuals from Oakland through direct services including multicultural family events, age 0-12 enrichment activities, food and basic need distributions, youth internships, sports teams, art and wellness programs, job readiness programs, and safety ambassadors.
- Connect with residents who attend Trybe programming to discuss disaster preparedness, response, recovery, and mitigation.
- Participate in street canvassing and door-to-door outreach to initiate engagements and discuss disaster preparedness while distributing Listos California-approved materials.
- Collect data from surveys and include the results in their multilingual informational updates.
- Direct community training sessions for Trybe's other programming areas.
 Training will include safety drills for youth interns, tabletop displays, and emergency kit-building activities.

Ukrainian American House

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of El Dorado, Placer, Sacramento, and Yolo. The Ukrainian American House was granted Listos California Target Grant Program funding to:

- Hold informational sessions about disaster preparedness specifically for Ukrainian and Slavic immigrants and refugees. These sessions will be held in Slavic languages and will include question-and-answer sessions and interactive activities.
- Conduct disaster preparedness meetings during the grant performance period.
- Create a social media campaign targeting Slavic and Ukrainian audiences already utilizing an existing refugee resettlement service, school districts, religion-based organizations, and local radio stations.
- Work together with stakeholders in Yolo and El Dorado Counties to recruit and train new CERT-certified personnel to better serve the Slavic and

Ukrainian refugees' community in their disaster preparedness, response, recovery, and mitigation.

United Way of Northern California

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Alameda, Alpine, Amador, Butte, Calaveras, Contra Costa, El Dorado, Glenn, Humboldt, Inyo, Lake, Madera, Marin, Mariposa, Mendocino, Mono, Monterey, Napa, Placer, Sacramento, San Benito, San Francisco, San Mateo, Santa Cruz, Shasta, Siskiyou, Solano, Sonoma, Stanislaus, Tehama, Trinity, and Yolo. The United Way of Northern California was granted Listos California Statewide Grant Program funding to:

- Promote readiness activities through outreach and education training events, peer-to-peer engagement with partner Subgrantees, and coordination within disaster-related collaboratives to increase early alert sign-ups for those with broadband limitations or access and functional needs.
- Work with existing or developing Voluntary Organizations Active in Disaster (VOADs) to reach vulnerable communities, regardless of language or accessibility needs, through volunteer networks who are trained in Listos disaster preparedness and available during disaster response efforts.

- Collect impact stories and recommendations to inform program implementation and share them with Listos for inclusion in statewide efforts and other appropriate areas.

Up Valley Family Centers of Napa County

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Napa. The Up Valley Family Centers of Napa County was granted Listos California Target Grant Program funding to:

- Provide Listos California services to populations with key social vulnerability factors: immigrants and refugees, mainly from Latin America; farmworkers, especially agricultural workers in the wine industry; seniors and older adults; individuals and households that are solely Spanish-speaking or with limited English Proficiency; people with disabilities; and geographically isolated and/or low broadband households.
- Distribute Listos California materials in various languages (i.e. booklets, door hangers, and readiness protection plans).
- Host interactive disaster training and resources to socially vulnerable populations across Napa County to improve disaster preparedness, response, recovery, and mitigation capabilities of residents at risk of severe impact from disasters such as wildfire.
- Collaborate with non-profits, faith groups, government agencies, and private sectors in Napa County to lead coordinated responses during disasters.

Valley Onward

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the County of Merced. Valley Onward was granted Listos California Target Grant Program funding to:

- Develop and implement outreach sessions targeted to immigrants, refugees, farmworkers, and older adults within the geographically isolated communities of the county.
- Work with a cohort of community members throughout Merced County.
- Host resiliency fairs that offer training, discuss local emergency response challenges, and improve emergency planning procedures.
- Enable and create a platform for community members to hold conversations with key county leaders, local County Emergency Managers, elected officials, as well as local CBOs regarding emergency response challenges within the communities.

- Host CERT training for staff, community organizers, and resident engagement coordinators, to practice evidence-based emergency preparedness plans, and identify gaps in the current emergency preparedness protocols.
- Share information on upcoming trainings or community events to their large target audience as well as conduct short quizzes/surveys with residents to help build a greater understanding of the gaps and needs for further outreach efforts.

The Vision y Compromiso

Serves organizations that provide emergency response, recovery, and mitigation resources/education to vulnerable communities located in the Counties of Santa Barbara and San Luis Obispo. The Vision y Compromiso was granted Listos California Target Grant Program funding to:

- Engage people in North Santa Barbara and South San Luis Obispo
 Counties with a primary focus on immigrants and refugees, farmworkers,
 seniors/older adults, geographically isolated individual families, low
 broadband subscribers, and households with limited English proficiency.
- Increase emergency preparedness, response, recovery, and mitigation capabilities in the Santa Maria region.
- Develop a peer-to-peer engagement approach in collaboration with local promotoras. Promotoras are primarily a women-led workforce.
- Work with existing and new partners (faith-based communities, schools, community centers, etc.) to host events and activities that will discuss disaster preparedness emergency planning, and mitigation needs.

Conclusion

Continuation of the Listos California Grant Program ensures that communities disproportionately impacted by disaster are included in the disaster preparedness conversation. To date, just over 2.8 million vulnerable Californians – older adults, people with disabilities, people living in poverty, and people with language barriers – have been reached and are better able to prepare for, withstand, and recover from disaster.

This successful program has improved collaboration amongst CBOs and volunteer and service teams in our most vulnerable communities. This network of support has resulted in building stronger relationships, better visibility, and knowledge sharing which will continue to benefit these communities, resulting in a more resilient California.
