The Advisory Board discussed what can be shared vs what should be shared. Mr. Currier stated the Board should come up with a standard on what is shared from 9-8-8 to 9-1-1.

Mr. Currier discussed the deployment plan for 2023 for CHS installations.

Mr. Currier discussed 9-1-1 to 9-8-8 Interface. Technology planning has begun and will be available Summer 2023. Further discussion and action items for working group. Mr. Currier gave an example of how Virginia handles policy from routine to emergent level as well as a workflow diagram.

Mr. Currier discussed the State Emergency Telephone Number Account (SETNA) surcharge for 9-8-8 is \$0.08 cents for 2023-2024.

Mr. Currier discussed 9-8-8 milestones: director has been appointed, interfaces between 9-1-1 and 9-8-8 have been validated, board has been established, budget change proposals have been submitted.
