The Statewide Interoperability Executive Committee liaison will copy and distribute the materials to the Statewide Interoperability Executive Committee members. If prior delivery is not possible, it is requested that a minimum fifteen (15) copies be submitted to the Statewide Interoperability Executive Committee liaison prior to the start of the scheduled meeting. The materials will be distributed to the Statewide Interoperability Executive Committee Members.
