California Radio Interoperable System (CRIS)

- Total of 56 sites installed, 54 in wide-area trunking
- Scheduled to have 59 sites online by end of this fiscal year
- Currently working on CRIS VHF expansion in Mono and Lassen Counties, and 700 MHz installations in various locations throughout the state
- Developing partnerships for CRIS expansion with an additional four rural counties
- Challenge: Acquiring leases and facility upgrades at radio sites owned by partnering state agencies



PSC CAPSNET

Status


- 73% Complete
- Of the 240 sites planned to receive MPLS infrastructure,
 175 have been installed
- Phase 4 installations completed
- Revisiting remaining Phase 3 sites and planning for their installations summer 2024

Deployment Progress

- Phase 1: 52/52 sites installed
- Phase 2: 49/49 sites installed
- Phase 3: 33/49 sites installed
- Phase 4: 41/41 sites installed
- Phase 5: 0/17 sites installed (229 submissions and staging underway)

Upcoming

 Phase 6, 32 sites in scope for installation, include some carryover from Phase 3

- We are currently updating and renegotiating the CALNET 9.1 FirstNet Broadband for Public Safety contract, as well as CALNET 19.2 First Responder Cellular Services for Broadband contract


