




Item 5-1: Outage Overview





Item 5-1: NG 9-1-1 - Call routing





 - Imperial County Sheriff live February 2023




Item 5-2: Legacy CPE Limitations

- Three distinct testing processes currently in motion:
 - Compliance with Interface Control Document (ICD) needed for the CPE to interface with NG 9-1-1 that includes the work arounds the NG 9-1-1 providers have put in place to overcome limitations of current CPE.
 - Contract requirements for legacy CPE i3 compliance installed at PSAPs under previous CPE contracts.
 - Contract requirements for cloud-based CPE on the current contract.




Item 5-2: PSAP Testing Preparing for NG 9-1-1 Go-Live
