

9-1-1 OPERATIONS MANUAL INTRODUCTION

The State of California (State), Governor's Office of Emergency Services, Public Safety Communications, California 9-1-1 Emergency Communications Branch (CA 9-1-1 Branch), in concert with all public safety agencies in the State, is dedicated to providing its citizens and visitors the best emergency services possible. To successfully achieve this commitment, the goal of the CA 9-1-1 Branch is to enable Public Safety Answering Points (PSAPs) to provide the fastest, most reliable, and cost-effective telephone access to emergency services for any 9-1-1 caller in California. That is, the accessibility of 9-1-1 services from every corner of the state, from any communications device, by anyone in California is essential.

Information provided in the State of California 9-1-1 Operations Manual (Manual) is intended to assist PSAPs, 9-1-1 County Coordinators, and other 9-1-1 stakeholders in the administration and funding related to the successful delivery of 9-1-1 calls in California. As telecommunications technologies evolve at a rapid pace, the CA 9-1-1 Branch will make every effort to update the information throughout this manual in a timely manner.

AUTHORITY:

Administration of funding by the CA 9-1-1 Branch for equipment and services related to the delivery of 9-1-1 calls is based upon laws passed by the California State Legislature as defined in CA Government Code, Sections 53100-53120 known as the Warren-911-Emergency Assistance Act; and, the CA Revenue and Taxation Code, Sections 41001 -41176 known as the Emergency Telephone Users Surcharge Act.
