*SUBMISSION OF WRITTEN MATERIALS:* All written materials used by a presenter or member of the public making public comment are requested to be delivered to the PSRSPC liaison a minimum five (5) days prior to the scheduled meeting. The mailing address and email of the PSRSPC liaison is identified below in General Information. The PSRSPC liaison will copy and distribute the materials to the PSRSPC members. If prior delivery is not possible, it is requested that a minimum fifteen (15) copies be submitted to the PSRSPC liaison prior to the start of the scheduled meeting. This material will be distributed to the PSRSPC members.
