V. CA 9-1-1 BRANCH REPORT

Mr. Troxel discussed the 9-1-1 Stats and predictive analysis thinking 2022 is a slower year

Mr. Troxel discussed CPE limitations and three distinct testing processes; compliance with ICD needed for the CPE to interface with NG, contract requirements for legacy CPE not meeting i3 compliance, contract requirement for cloud-based CPE

Mr. Troxel discussed Legacy CPE i3 limitations.

Mr. Troxel discussed preparing NG Go-Live & the ALI Emulation box that has been developed to convert NG 9-1-1 location to legacy location.

Mr. Troxel discussed NG 9-1-1 deployment in Tuolumne and South Lake Tahoe, the Cal OES team is in Imperial County today testing, could be live by the end of day.

Mr. Troxel discussed CPE installation, 8 successful installations in 2022, expected more deployment in 2023.

Mr. Troxel discussed, Lumen, Atos and NGA are all through lab, Intrado and Rapid Deploy could be through the lab early 2023. Motorola and Carbyne are still in discussion and not to phase 1 yet.

Mr. Troxel discussed Procurement updates: Recruiting & Retention RFP expected to be complete in early 2023, 9-8-8 CPE expected contract by December 2022. OES has two (2) pending procurements: Audio Logging Contract and statewide CAD Master Service Agreement

Mr. Troxel discussed SETNA Funding and the support the State provides to PSAPs. Surcharge fee for 2023 will remain at \$0.30.

VII. 9-8-8 UPDATE

Mr. Currier discussed the 9-8-8 signed into law on September 29,2022. The bill requires OES and Health and Human Services to develop a plan for integration.

The surcharge for 2023 and 2024 will be \$0.08. Still needs a System Director and a Technical Advisory Board. A drafted committee is listed but subject to change. First meeting will be December 8th, 2022.

Mr. Currier discussed the technical board tasks. Develop standards for 9-8-8 system, sustainable interoperability between 9-8-8 and 9-1-1, and protocols for transferring between 9-8-8 and 9-1-1 centers.

Mr. Currier discussed the next steps, procurement process in December 2022, installs from 2023-2025, develop procedures and best practices and 9-8-8 and 9-1-1 transfer. Continue collaboration with local, state, and federal stakeholders.
