### CDAA-2022-08: Heat Dome and Wildfires - California Disaster Assistance Act Funding

On August 31, 2022, a Governor's Proclamation was issued to secure funding to help El Dorado, Madera, Modoc, Placer, and Siskiyou counties respond to and recover from the Heat Dome and Wildfires. This fact sheet contains information regarding the available assistance and California Disaster Assistance Act (CDAA) application information.

### Important Disaster Information

The incident period is August 31, 2022, to October 23, 2022. The Heat Dome and Wildfires (CDAA-2022-08) makes available CDAA funding for eligible costs in the following counties for work performed in response to the corresponding fires:

<u>County</u>	<u>Authorized Fire</u>
El Dorado	Mosquito Fire
Madera	Fork Fire
Modoc	Barnes Fire
Placer	Mosquito Fire
Siskiyou	Mill and Mountain Fires

### Applicants Eligible for Assistance

The following local government entities are eligible for disaster assistance under CDAA:

- Cities
- Counties
- Special Districts
- School Districts
- Community College Districts
- Certain Private Non-profit Organizations

### Eligible Private Non-Profit Reimbursement

An eligible private non-profit (PNP) applicant may receive state financial assistance as reimbursement for the performance of essential community services, provided such expenditures meet all the eligibility requirements. PNP activities resulting from self-deployment will not be eligible for reimbursement.

### Available Assistance – Public Assistance Program

State cost shares 75 percent and local 25 percent of eligible costs. The types of work eligible are illustrated below:

#### EMERGENCY WORK

- Debris Removal **(Category A)**
- Emergency Response and Protective Measures **(Category B)**

#### PERMANENT WORK

- Roads and Bridges **(Category C)**
- Water Control Facilities **(Category D)**
- Buildings and Equipment **(Category E)**
- Utilities **(Category F)**
- Parks, Recreational Facilities, Other Items **(Category G)**

**Note: Force Account Labor**  
Emergency Work - Only overtime is eligible.

**Note: Force Account Labor**  
Permanent Work - Regular and overtime is eligible.
