### **CDA-2024-06 Smith River Complex Fire - California Disaster Assistance Act Funding**

## **CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES**

On August 29, 2023, a Governor's Proclamation was issued to secure funding to help the County of Del Norte respond to and recover from the Smith River Complex Fire. This fact sheet contains information regarding the available assistance and California Disaster Assistance Act (CDA) application information.

### **Important Disaster Information**

**Declaration Name:** Smith River Complex Fire

**Incident Period:** August 15, 2023, through September 11, 2023.

The Smith River Complex Fire (CDA-2024-06) makes available CDA funding for eligible costs for the County of Del Norte.



### **Applicants Eligible for Assistance**

The following local government entities are eligible for disaster assistance under CDA:

- Cities
- Counties
- Special Districts
- School Districts
- Community College Districts
- Certain Private Non-Profit Organizations

### **Eligible Private Non-Profit Reimbursement**

An eligible private non-profit (PNP) applicant may receive state financial assistance as reimbursement for the performance of essential community services, provided such expenditures meet all the eligibility requirements. PNP activities resulting from self-deployment will not be eligible for reimbursement.

**Available Assistance - Public Assistance Program**  
State cost shares 75 percent and local 25 percent of eligible costs. The types of work eligible are illustrated below.
