FEMA Grants Update

Budget & Scope of Work (SOW) Updates

Background:

- Current estimate is \$40,000 per home
- Cost estimates were based on data from over 3 years ago
- Costs have risen due to inflation and supply/demand
- Each Subrecipient will need to request a scope of work change

Planned FEMA subaward SOW changes

- Average cost of bids will help determine the average cost per home
 - The target # of homes proposed in the original SOW will need to be reduced as the average cost per home increases
 - o Total Project Cost will not increase




CWMP Portal Administration Tool






Management of Homeowner Application








EHP Stages & Steps



Conducted a CWMP DSI/HIZ Training for Shasta and Lake County pilot communities on March 14-15. Field days are set for Shasta on March 20 and Lake County on March 21,2024.

Recently sent out our CWMP Retrofit List and Minimum Quality Standards Version 2 document to stakeholders for review.

Next steps for Demonstration Project

Assembly Budget Subcommittee No. 6 on Public Safety, Budget Hearing

- FY 2021-22 Extension of the California Wildfire Mitigation Program Liquidation Period. Requesting the liquidation of \$15,986,000 General Fund for the California Wildfire Mitigation Program be extended from June 30, 2025 to June 30, 2029 to complete wildfire home hardening activities.
- Wildfire Home Hardening FY 2023-24 (SB 101) \$12 million General Fund reversion.
- Wildfire Home Hardening FY 2022-23 (AB 179) \$13 million Siskiyou & Riverside Counties. Not discussed.
- Prior to Hearing: Responded to Several Inquiries by the Department of Finance and the Legislative Analyst's Office

CWMP Update: Legislative Report

Assembly Bill No. 38 Report Requirements

- An evaluation of the cost-effectiveness of the wildfire mitigation program compared to other structure hardening, defensible space, vegetation management, and fuel reduction incentive programs.
- An evaluation of the overall wildfire risk reduction achieved statewide through awards of financial assistance under the wildfire mitigation program.
- Detailed information about the quantity, monetary value, geographic distribution, and categories of awards of financial assistance made under the wildfire mitigation program.
- Detailed information about the sources and amounts of funds appropriated or granted to the wildfire mitigation program.
- Detailed information about barriers encountered to completing work awarded financial assistance under the wildfire mitigation program, including state, regional, or local permitting requirements.
- Any other information the office determines is necessary or convenient to evaluate the financial assistance awarded under the program.




