[HUD FY2024 Healthy Homes and Weatherization Cooperation Demonstration](#)

- Application deadline August 13, 2024
- Provides funding to housing interventions in lower-income households that are served by both HUD's Healthy Homes Production (HHP) program and DOE's Weatherization Assistance Program (WAP).

[Tribal Wetland Program Development Grants](#)

- Application deadline October 1, 2024
- Assists tribal governments and intertribal consortia to develop or refine tribal programs which protect, manage, and restore wetlands.

[NAWCA 2025 US Small Grants](#)

- Application deadline October 10, 2024
- A matching grants program that supports public-private partnerships carrying out projects in the United States that further the goals of the North American Wetlands Conservation Act.
- Projects must involve only long-term protection, restoration, enhancement and/or establishment of wetland and associated upland habitats to benefit migratory birds.

[Local Housing Trust Fund \(LHTF\) Program | California Department of Housing and Community Development](#)

- Application due September 17th, 2024
- Portal Open August 20th, 2024 – September 17th, 2024.
- The LHTF program provides matching funds to local and regional housing trust funds dedicated to the creation, rehabilitation, or preservation of affordable housing, transitional housing and emergency shelters.

[Rebuilding American Infrastructure with Sustainability and Equity \(RAISE\) Grant Program](#)

- FY 2025 Deadline: January 13, 2025, at 11:59 pm Eastern
- FY 2026 Deadline: January 13, 2026, at 11:59 pm Eastern
- RAISE grants will be awarded on a competitive basis, per statute, for planning or constructing surface transportation infrastructure projects that will improve safety; environmental sustainability; quality of life; mobility and community connectivity; economic competitiveness

[Single Family Housing Repair Loans & Grants in Presidentially Declared Disasters Pilot | Rural Development \(\[usda.gov\]\(https://usda.gov\)\)](#)

- Due to Lack of Funding, USDA Pauses Pilot Program to Repair Homes Damaged by Presidentially Declared Disasters.
- This is effective as of June 7, USDA intends to renew the pilot if funding becomes available again.
- This pause for the pilot program will not affect applications from those who are 62 and older who remain eligible for regularly appropriated funding under USDA's Single Family Housing Repair Loans and Grants Program.
- Community Facilities Program Disaster Repair Grants
- Open until July 18, 2025, which is the conclusion of the pilot program
- Grants will be provided to eligible applicants to repair eligible essential community facilities damaged by Presidentially Declared Disasters that occurred on or after July 18, 2022

[Behavioral Health Bridge Housing \(BHBH\) Program](#)

- Application deadline June 30, 2027
- Providing over a billion dollars in funding to county behavioral health agencies and Tribal entities to operate bridge housing settings to address the immediate housing needs of people experiencing homelessness who have serious behavioral health conditions, including serious mental illness (SMI) and/or substance use disorder (SUD).



[Manufactured Housing Opportunity and Revitalization Program \(MORE\)](#)

- The MORE program helps fund a variety of activities intended to keep Mobile home Parks a safe and affordable homeownership option.
- MORE funds can be used for the acquisition, conversion to resident organization ownership, rehabilitation, reconstruction, and replacement of mobile home parks, as well the remediation of health and safety items of both parks and individual mobile homes.
