- Purchase and installation of efficiency upgrades and capacity additions to existing bulk grid power generators in California that will serve as emergency supply for the state's electrical grid during extreme events (as defined in Public Resources Code [PRC] section 25790.5[b]).

#### [Earthquake Brace + Bolt \(EBB\): Grants for Earthquake Retrofitting in California](#)

- Helps homeowners lessen the potential for damage during an earthquake.
- Grants of up to \$3,000 toward a seismic retrofit for qualifying older houses

- At least 5 percent of funds for planning, preparation or design of eligible projects
- 50 percent of funds can be spent on projects located in a rural area with a population equal to or less than 200,000.
- Not more than 50 percent of funds can be spent on projects located in an urbanized area with a population of more than 200,000.
