- Application deadline February 21, 2024
- Helps homeowners lessen the potential for damage during an earthquake.
- Grants of up to \$3,000 toward a seismic retrofit for qualifying older houses

- Application deadline February 28, 2024
- At least 5 percent of funds for planning, preparation or design of eligible projects
- 50 percent of funds can be spent on projects located in a rural area with a population equal to or less than 200,000.



- Not more than 50 percent of funds can be spent on projects located in an urbanized area with a population of more than 200,000.
