<u>California Urban and Community Forestry Inflation Reduction Act - California</u> Grants Portal

- Application Deadline: May 30, 2024. Time 5:00 pm
- Increased and equitable access to urban tree canopy and associated human health, environmental, and economic benefits in disadvantaged communities.
- Broadened community engagement in local urban forest planning, tree planting, and management activities.
- Improved community and urban forest resilience to climate change, extreme heat, forest pests and diseases, and storm events through best management and maintenance practices.

<u>Urban and Community Forestry Grants | CAL FIRE</u>

- Application Deadline: May 30, 2024, Time: 5:00 pm
- Increase the long-term benefits trees provide, improve the public's understanding and appreciation of urban trees, and advance urban forest management and tree care. Special consideration is given to projects serving disadvantaged and/or low-income communities.

<u>Defense Community Infrastructure Program | Office of Local Defense</u> <u>Community Cooperation (oldcc.gov)</u>

- Application Deadline: June 17, 2024
- Section 2391(d) of Title 10, United States Code (10 U.S.C. § 2391(d)), authorizes the Secretary of Defense to "make grants, conclude cooperative agreements, and supplement funds available under Federal programs administered by agencies other than the Department of Defense to assist



State and local governments to address deficiencies in community infrastructure supportive of a military installation.

• Community infrastructure projects are transportation projects, community support facilities and utility infrastructure projects that are located off of a military installation or on property under the jurisdiction of a Secretary of a military department that is subject to a real estate agreement (including a lease or easement), and are owned by a state or local government or a not-for-profit, member-owned utility service.

ENVIRONMENTAL ENHANCEMENT AND MITIGATION PROGRAM 2024 Grant Cycle (ca.gov)

- Application Deadline: June 25, 2024, Time: 1700 PST
- Environmental enhancement and mitigation projects that are directly or indirectly related to the environmental impact of modifying existing transportation facilities or for the design, construction, or expansion of new transportation facilities.

- Providing funding for the rehabilitation and/or replacement of individual Mobile homes
- The creation of Affordability Restrictions for assisted Mobile home Parks.
