- Community infrastructure projects are transportation projects, community support facilities and utility infrastructure projects that are located off of a military installation or on property under the jurisdiction of a Secretary of a military department that is subject to a real estate agreement (including a lease or easement), and are owned by a state or local government or a not-for-profit, member-owned utility service.
