In some cases, a community may choose to utilize a FEMA-approved hazard mitigation plan or Tribal hazard mitigation plan with a wildfire component that meets the same objectives of a CWPP.
- For project implementation: The project must be described in a Community Wildfire Protection Plan that is not more than 10-years old.
