## Recovery Highlights

### Safety Assessment Program (SAP) County

### 2025 Field Exercise - El Dorado

The Safety Assessment Program (SAP) conducted the first ever 2-day in office and field exercise on November 18th -19th, 2025. This exercise took place in El Dorado County with county planning staff working alongside Inland Region OES and various partners and began the process of incorporating Disaster Service Workers – Volunteers (DSW-V) for the first time. Participating organizations included: DGS/DSA, CalTrans, CGS, HCIA, CalBO, and SEAOC. Internal OES partners included: IMAT, Watershed, SOC Mission Tasking, Field IT, the IT GIS team, Recovery Analytics, Disaster Logs, and Tech Comms. One of the greatest benefits was bringing all partners together in the same room and learning from one another. This significantly strengthened partnerships, cohesiveness, and teamwork. Participants were enthusiastic, happy to be involved, and eager to join future exercises. Many plan to share their positive experience with coworkers to encourage broader participation in future exercise and real-world events.

## Recovery Support Functions (RSFs)



### Economic RSF:

#### **Analysis Spotlights Economic Toll of the January 2025 Los Angeles Wildfires; Outlines Early Recovery Trends**

The Los Angeles County Department of Economic Opportunity (LA DEO), the Los Angeles Economic Development Corporation (LA EDC) and its Institute for Applied Economics, in partnership with Economic RSF state partner GO-Biz, released the first installment of a year-long economic impact study examining the effects of the January 2025 wildfires. The study projects **\$5.2 to \$10.1 billion in lost economic output** and provides early insights into how businesses, workers, and communities across both burn areas and Secondary Fire Areas are beginning to recover. It's a data-rich look at disruptions caused by the Eaton and Palisades fires, including prolonged closures, evacuation impacts, and workforce displacement. Future quarterly analyses will inform recovery decisions and capture lessons for future disaster response.

#### **Palisades Recovery Pop-Up Delivers Nearly \$500K in Aid to Fire**

Global Empowerment Mission (GEM), Rotary District 5280, in partnership with Palisades LTRG, hosted the Palisades Recovery Pop-Up on November 22 at American Legion Palisades—a site recommended by the Economic RSF to help address limited, affordable recovery event space (and one day liability insurance) in the area. The day centered on healing, connection, and support for fire survivors. The event brought together local resources, service providers, health and wellness workshops, and kids' activities. In total, 277 fire-impacted families and 695 survivors received assistance; Southern Baptist volunteers served over 400 free hot meals and partners distributed food, clothing, home goods, pet supplies, and toys. Nearly \$500,000 in aid and services were delivered in a single day, underscoring the power of the community coming together in recovery.

#### **Stronger Together: 1st Business Recovery Expo Brings Critical Support to LA Wildfire Survivors**

The City of Los Angeles and Operation HOPE hosted the first **Stronger Together Business Recovery Expo** in September at the American Legion Palisades, providing much-needed support to small businesses impacted by the LA Wildfires. The Economic RSF was invited to serve on the event planning committee and helped to bring key Economic RSF agency partners into the event

program. The event drew more than 50 business owners and community members from Palisades, Malibu, and Los Angeles County. Through workshops on capital access, insurance and legal guidance, workforce recovery, and rebuilding revenue, participants gained practical tools and direct insight from experts. Economic RSF partners—California

Office of the Small Business Advocate (CalOSBA) and Small Business Administration (SBA) - served as featured speakers and exhibitors.

### **Health and Social Services RSF:**

#### **Los Angeles County Increases its Disaster Behavioral Health Capacity**

Following the four delivered Train the Trainer sessions of Psychological First Aid in July and August, Los Angeles County's Department of Mental Health (LADMH) has successfully expanded its disaster behavioral health resources. 91 paraprofessionals are now trained and operational in the Los Angeles area. LADMH is currently working with local jurisdictions, long term recovery groups, and special districts to deploy these new resources and meet growing mental-health needs across fire-survivor communities.

### **Individual Assistance (IA)**

#### **Mono County Pack Fire**

The Mono County Office of Emergency Services, in close coordination with the Mono County Administrators Office, the Board of Supervisors' Office, and the local Fire Department, demonstrated exceptional dedication and leadership throughout Local Assistance Center (LAC) operations and the Preliminary Damage Assessment process following the November 2025 Pack Fire. Their teams worked tirelessly to engage directly with impacted residents, gather critical household and business information, and accurately document damages. This effort required long hours, close coordination, and a steadfast commitment to ensuring no affected household or business was overlooked. The LAC itself served 22 households with a total of 138 services to impacted residents. The accuracy and completeness of the data collected at the LAC and in the days that followed were instrumental in clearly demonstrating the scope and severity of impacts across the community.

Equally important was the County's collaborative and proactive partnership with the Cal OES Individual Assistance team. Mono County's willingness to work together with state and federal partners, adapt processes in real time, and prioritize data integrity directly contributed to the successful SBA declaration and, ultimately, the issuance of a State of Emergency by the Governor's Office. Their collective efforts ensured the community received the assistance it urgently needed and deserved. This outcome reflects not only strong interagency coordination, but also Mono County's unwavering commitment to advocating for its residents throughout the recovery process.



### Environmental and Historic Preservation Emergency Regulatory and Permitting Guidance

## Environmental and Historic Preservation (EHP)

EHP continues to work with Local, State, and Federal partners to steer the process to address disaster recovery activities associated with the late 2024 and early 2025 wildfires including, Park, Borel, and the Los Angeles events. EHP compliance requirements were summarized in the 2025 Statewide Wildfire Environmental Protection Plan (EPP) which was completed with state and federal partners in July.

The Cal OES EHP team is available to provide support to our local and state partners with expertise

in how to handle recovery projects with complex or sensitive environmental and historic preservation issues whether or not there is a state or federally declared disaster. ## Recovery Resources

### CalAssist Mortgage Fund

California expanded the CalAssist Mortgage Fund Disaster Relief so more California families can qualify for mortgage grants. Income limits were increased expanding eligibility for families rebuilding after disasters. Homeowners whose primary residence was destroyed or severely damaged as the result of a qualified disaster that occurred between Jan. 1, 2023, and Jan. 8, 2025, may qualify if other parameters are met. ## The Safety Assessment Program (SAP) CalSAFE

Cal OES SAP is proud to introduce CalSAFE (Safety Assessment for Field Evaluations), on the Veoci platform. The CalSAFE system continues to grow with new dashboards for liaisons and incorporating FIRIS flyover data. Cal OES SAP continues to work with the GIS team and Veoci to add in any geospatial data that can be utilized in future SAP deployments.

**Future CalSAFE Functions:** Cal OES SAP is building a public dashboard to look up the status of SAP Evaluators SAP ID. This dashboard will improve the availability of information that our evaluators and their organizational liaisons can access. SAP also wants to be able to assist

local jurisdictions by giving them the ability to use the state's rapid assessment forms, dashboards, and notifications in disaster response situations.



## Quality Control and Monitoring (QCM)




QCM has completed 29 Recovery Compliance Reviews this year, 26 with findings and has 17 more underway. These reviews cover over \$38 million in FEMA obligated projects across 13 different disaster funds, completed even with the unit operating at minimum staffing for seven months due to LA Wildfires JFO activations and deployments. Beyond formal reviews, QCM also provided technical assistance to Recovery Programs and

subrecipients to promote compliance proactively. This support has safeguarded more than \$15 million in funding by ensuring subaward activities remain allowable and compliant.

The Top findings for all 2025 projects are missing Suspension and Debarment contract provisions along with inadequate vendor/contractor verification.

FEMA provides a number of [guidance documents](#) to assist in meeting requirements. Specifically, the FEMA Contract Provisions Guide identifies the mandatory contract language, as well as samples of recommended language with links to the relevant CFR citation. Reviewing the relevant program guidance, as well as information provided during applicant briefings and application preparation workshops are the keys to avoid findings, corrective action, and the potential recapture of funds.


