Overview

The California Governor's Office of Emergency Services (Cal OES), Interagency Recovery Coordination is comprised of six Recovery Support Functions (RSF) teams. The teams are Community Planning & Capacity Building (CPCB), Natural & Cultural Resources (NCR), Health & Social Services (HSS), Economic (ECON), Housing (HSG), and Infrastructure Systems (INF). The role of the RSF teams is to help communities with long-term recovery after disasters strike. This includes help to find additional funding opportunities that fall outside of Federal Emergency Management Agency (FEMA) and State Public/Individual Assistance.

California is home to several federally recognized tribes. There are nearly 100 separate reservations or Rancherias throughout the state.¹ Many of these reservations and Rancherias are in remote/woody areas of California and at risk for wildfire damages.

The California Governor's Office of Emergency Service's Natural & Cultural Resources RSF has developed the Tribal Recovery Resource Guide for Federally Recognized Tribes to provide an overview of resources to assist affected Tribes with recovery efforts from the 2021 wildfires, as well as future wildfires. This includes resources that will support local community planning and capacity building, housing, economic, infrastructure, and natural and cultural resources recovery, as well as opportunities for increasing local resilience to future disasters.

Program Description	<p>AmeriCorps is committed to working on a Nation-to-Nation basis with Native Nations and upholding the federal government's Tribal trust responsibility.</p> <p>AmeriCorps planning grants provide support to a grant recipient to develop an AmeriCorps program that will engage AmeriCorps members in implementing evidence-based interventions to solve community problems. Grant recipients are awarded up to \$240,000 for a 12-month planning period and are encouraged to compete for an AmeriCorps program grant in the following grant cycle if they deem the fit with AmeriCorps to be of use to their community. A planning grant may not be used to support AmeriCorps members. Applicants will apply for a Cost Reimbursement grant. The project period is no more than a year, with a start date proposed by the applicant. The project start date may not occur prior to the date AmeriCorps awards the grant.</p>

Program Description	<p>The Small Community Drought Relief Program (Program) was authorized by the Legislature pursuant to the Budget Act of 2021 (Stats. 2021, ch. 240, § 80) and its Trailer Bill, (Wat. Code, § 13198 et seq.). The Trailer Bill authorized specified state agencies, defined as implementing agencies, subject to an appropriation for these purposes, to make grants and direct expenditures for interim or immediate relief in response to conditions arising from a drought scenario to address immediate impacts on human health and safety and on fish and wildlife resources and to provide water to persons or communities that lose or are threatened with the loss or contamination of water supplies.</p> <p>The small communities are those that are not supplied by an urban water supplier as defined in California Water Code (Sec 10617). Urban water suppliers are those that provide drinking water with more than 3,000 connections or more than 3,000 acre-feet per year.</p>
