## Overview

The California Governor's Office of Emergency Services (Cal OES), Recovery Support Functions (RSF) Unit is comprised of six RSFs—Community Planning & Capacity Building (CPCB), Economic (ECON), Health & Social Services (HSS), Housing (HSG) Infrastructure Systems (INF), and Natural & Cultural Resources (NCR).

The mission of the RSFs is to assist communities with long-term recovery efforts following an incident or disaster through the coordination of resources (e.g., funding opportunities, guidance, and technical assistance). These resources are intended to supplement traditional State and federal recovery programs including the Federal Emergency Management Agency (FEMA) Individual Assistance, Hazard Mitigation, and Public Assistance programs.

The California Governor's Office of Emergency Service's NCR RSF developed the Vegetation Management Resource Guide to provide funding and technical assistance for vegetation management and hazardous fuel reduction activities following a wildfire incident. This grant funding, technical assistance, and support resources included in this resource guide are intended to assist communities affected by wildfires with current recovery activities and to increase resilience to future wildfire events.

## Active California State Grant & Loan Resources

Wildlife Conservation Board (WCB) Habitat Enhancement and Restoration Program (HERP)	
<b>Application Deadline</b>	Ongoing
<b>Program Description</b>	<p>When WCB was created by the Wildlife Conservation Law of 1947, it was authorized to acquire and restore California lands to protect wildlife values and provide wildlife-oriented public access. HERP supports a wide variety of restoration projects that fall outside WCB's other mandated programs. HERP projects are distributed throughout California and all habitat types. Broad categories of HERP projects include, but are not limited to:</p> <ul style="list-style-type: none"> <li>• Habitat restoration (e.g., coast, forest, desert, wetland, grassland)</li> <li>• Wildlife corridors</li> <li>• Fisheries enhancements (e.g., fish ladders, barrier removal)</li> </ul> <p>Most HERP funding is provided by the Habitat Conservation Fund and various voter-approved bonds. HERP projects must receive a recommendation from the California Department of Fish and Wildlife and provide for long-term maintenance following project completion.</p>

<b>Program Description</b>	<p>The goal of CRHCP is to protect, preserve, and restore riparian habitats throughout California. Typical riparian projects include, but are not limited to:</p> <ul style="list-style-type: none"> <li>• Restoration of riparian vegetation and re-establishing floodplain connectivity.</li> <li>• Active or passive restoration that may include an element of invasive plant removal and control.</li> </ul>

<b>Program Description</b>	<p>The purpose of the CFIP is to encourage private and public investment in, and improved management of, California forest lands and resources. The CFIP can provide eligible landowners with technical and financial assistance for planning, reforestation and resource management investments that improve the quality and value of forestland. The program scope includes the improvement of all forest resources including fish and wildlife habitat, and soil and water quality.</p>

	<p><b>Project Types and Activities:</b></p> <ul style="list-style-type: none"> <li>• Preparation of a Forest Management Plan by a Registered Professional Forester (RPF)</li> <li>• RPF Supervision of the following: <ul style="list-style-type: none"> <li>○ Reforestation <ul style="list-style-type: none"> <li>▪ Site Preparation</li> <li>▪ Trees and Planting</li> <li>▪ Tree Shelters</li> </ul> </li> <li>○ Stand Improvement <ul style="list-style-type: none"> <li>▪ Pre-commercial Thinning or Release</li> <li>▪ Pruning</li> <li>▪ Follow-up (includes mechanical, herbicide and/or slash disposal follow-up)</li> </ul> </li> <li>○ Forestland conservation practices / fish and wildlife habitat improvement</li> </ul> </li> </ul> <p>Cost-share assistance is provided to private and public ownerships containing 20 to 5,000 acres of forest land. CFIP is a reimbursement program and to receive reimbursement from CFIP, you must first provide documents to the CAL FIRE FAS to demonstrate that the expenses to be reimbursed have been paid out. CFIP typically provides reimbursement for up to 75% of the cost of a project.</p>
<p><b>Eligibility</b></p>	<p>To be eligible for CFIP, landowners must own at least 20 acres of forestland but not more than 5,000 acres of forestland in California. The 20-acre minimum does not apply to forestland zoned timber production zone. As per California Public Resource Code §4793(e), forestland means land at least 10% occupied by trees of any size that are native to California, including native oaks, or formerly having had that tree cover and not currently zoned for uses incompatible with forest resource management. To determine that at least 10% of the property is occupied by trees, average canopy cover of native species across the property shall be used to determine whether the property meets the definition. Developed areas such as structures, landscaping, and gardens shall not be excluded from the 20-acre minimum property size and shall be included in the calculation of average canopy cover.</p> <p>Eligible landowners include private owners, government agencies, businesses, corporations, and non-federally owned Native American lands.</p>

<b>California Conservation Corps (CCC)  Greenhouse Gas Reduction Fund Forest Health</b>

<b>Program Description</b>	<p>In 2017, the Legislature appointed the CCC as the Job Training and Workforce Development program within the California Climate Investments (CCI) initiative. Greenhouse Gas Reduction Fund (GGRF) monies were appropriated to the CCC to provide formal and on-the-job training and work experience to complete projects that aid in reducing Greenhouse Gas (GHG) emissions.</p> <p>Examples of projects that incorporate formal and on-the-job training and support GHG reduction include, but are not limited to:</p> <ul style="list-style-type: none"> <li>• Fuel Load Reduction: removing dead and dying trees, brush and vegetation to reduce wildfire intensity and rate of spread</li> </ul>

<b>Application Deadline</b>	Application closed on 3/4/2022; Check back for future funding opportunities
<b>Program Description</b>	<p>Funding from Prop 1 is intended to fund projects that provide more reliable water supplies, restore important species and habitat, and develop a more resilient and sustainably managed water system (water supply, water quality, flood protection, and environment) that can better withstand environmental pressures in the coming decades.</p> <p>Chapter 6 of Proposition 1 requires the services of the CCC or a local conservation corps certified by the CCC be used, whenever feasible, for restoration and ecosystem protection projects. Corps</p>

	<p>programs increase the public benefit of these projects by creating workforce development opportunities for young adults.</p> <p>Organizations seeking funds for a Proposition 1 Chapter 6 project should carefully read the administering agency's guidelines and then consult with representatives of the CCC or the California Association of Local Conservation Corps (CALCC) to determine the feasibility of a corps' participation.</p> <p>CALCC: <a href="https://mylocalcorps.org/">https://mylocalcorps.org/</a></p> <p>The CCC provides supervised crews of 10-15 young adults trained and equipped to work safely on a wide variety of environmental projects related to the priorities of Prop 1.</p> <p>Examples of projects include:</p> <ul style="list-style-type: none"> <li>• Fisheries restoration</li> <li>• Build or repair livestock exclusion fences</li> <li>• Fish stocking and hatchery work; fish surveys and tagging for study</li> <li>• Wetland restoration</li> <li>• Stream bank stabilization through bioengineering and installation of gabions and log/boulder structures</li> <li>• Erosion control</li> <li>• Monitoring: fish populations, stream flow, water quality</li> <li>• Native species reintroduction</li> <li>• Non-native plant removal</li> <li>• Nursery work for native planting and restoration projects</li> <li>• Tree planting and establishment watering</li> <li>• Scrub Oak restoration</li> <li>• Forest health</li> <li>• Dune and desert restoration</li> <li>• Meadow restoration</li> <li>• Water conservation</li> <li>• Assist with grassroots outreach about water conservation</li> </ul>

	<p>For projects included in chapters other than Chapter 6 of Proposition 1, consultation with the CCC or a certified local conservation corps is encouraged.</p> <p>Grant applications for planning or acquisition projects with no field work or hand labor do not need to consult with the CCC or local corps.</p>

<b>Program Description</b>	<p>The EFRP helps the owners of non-industrial private forests restore forest health damaged by natural disasters by authorizing payments to owners of private forests to restore disaster damaged forests.</p> <p>The local Farm Service Agency (FSA) County Committee implements EFRP for all disasters with the exceptions of drought and insect infestations. In the case of drought or an insect infestation, the national FSA office authorizes EFRP implementation.</p>
<b>Eligibility</b>	<p>The FSA County Committee inspects the damage to determine if forest land is eligible for EFRP. For land to qualify for EFRP funds, the damage from the natural disaster must create new conservation problems that if not dealt with would:</p> <ul style="list-style-type: none"> <li>• Harm the natural resources on the land</li> <li>• Significantly affect future land use</li> </ul> <p>Only owners of nonindustrial private forests with tree cover existing before the natural disaster occurred are eligible to apply. The land must be owned by a private individual, group, association, corporation, or other private legal entity that has decision making authority on the land and does not use the land for business purposes.</p>
<b>Maximum Award</b>	<p>Up to 75% of the cost to implement emergency conservation practices can be provided, however the final amount is determined by the committee reviewing the application. The FSA County Committee can approve applications up to \$50,000, while \$50,000 to \$100,000 requires State committee approval. Amounts over \$100,000 require the approval of the national FSA office. Additionally, a limit on payments of \$500,000 per person or entity per disaster applies.</p>
<b>Application Process</b>	<p>EFRP enrollment is administered by FSA State and county committees and county offices. Owners should inquire with their</p>
